- A complete set of Bidding Documents may be purchased from the office of Road Improvement and Development Project, Rammandir Marg, Battisputali, Kathmandu Nepal by Pre-Qualified Bidders on the submission of a written application, along with the copy of evidence that the firm (Single or JV) is prequalified/conditionally prequalified by the Employer through pre-qualification process, and upon payment of a non-refundable fee of NRs. 20000.00 or 200 US\$ till 2018/08/29 (21<sup>st</sup> day from the date of Publication of this notice). If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost of NRs. 5000 or 50 US\$. However, the Employer will not be responsible for delay or non-delivery of the documents so sent.

- Sealed bids in original plus 2 copies or electronic bids must be submitted to the office Road Improvement and Development Project, Rammandir Marg, Battisputali, Kathmandu Nepal by hand/courier or through PPMO website [www.bolpatra.gov.np](http://www.bolpatra.gov.np) on or before 12:00 hours 2018/08/30(22<sup>nd</sup> day from the date of Publication of this notice). Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hours on 2018/08/30(22<sup>nd</sup> day from the date of Publication of this notice) at the office of Road Improvement and Development Project, Rammandir Marg, Battisputali, Kathmandu Nepal. Bids must be valid for a period of 120 days after bid opening date and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of USD mentioned in above table, which shall be valid for 30 days beyond the validity period of the bid.
- If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- Late Bids, portion of Bids, Bids not received, and the Bids not opened at the Bid opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
