



Invitation for Expression of Interest (EOI) for the selection of Consultants (Firms) for Building Carriage Construction Workshop at Saidpur with Feasibility Study under Line of Credit (GoI).

1. Bangladesh Railway with permission of Government of People's Republic of Bangladesh (GoB) has applied for a loan from Exim Bank of India for the implementation of Building a Railway Carriage Construction Workshop at Saidpur and it intends to apply part of the proceeds of this Loan for payments under the contract for the provision of consultancy services which this EOI is invited.
2. Bangladesh Railway (Executing Agency) will implement the project.
3. The Consultancy services include-
 - a) Techno-Economic feasibility Study and design to construct a railway carriage manufacturing shop in Saidpur Workshop of Bangladesh Railway.
 - b) To assess the number of Board gauge and Meter gauge Carriages required per year for Bangladesh Railway.
 - c) To prepare a layout plan for the proposed carriage manufacturing shop
 - d) To assess necessary machinery, plants, jigs, fixtures and preparation of specifications of these items.
 - e) To assess necessary Manpower and human resource development for the proposed carriage construction workshop.
 - f) To assess approximate cost for proposed carriage construction workshop and to analyze financial feasibility, technical feasibility and environmental feasibility of such workshop in the context of Bangladesh Railway.
4. The Consultants (firm) will be selected under Quality and Cost Based Selection (QCBS) Method in accordance with the procedures set out in the Guidelines on the Use of Consultant.
5. In order to be eligible to submit EOI proposals the Experience, Resources and Delivery Capacity of the consultancy firm required are:-
 - a) Technical Competency : Details of past experience working with similar project authorities;
 - b) Management Competency : Should be in active consultancy business for at least last 8(eight) years; and
 - c) Others : Information including summary of permanent professional employees with key qualifications; experience of detailed design and design review of building a railway carriage construction workshop & electrical substation; experience in developing business models and operational plan of workshop research and training center and Railway operation
6. Submission of EOI is allowed on or before 11.30 hrs (Bangladesh Standard Time) on 03.09.2019 in sealed envelopes marked with Building Carriage Construction Workshop to the address of the undersigned.
7. Interested applicants may obtain further information from the undersigned by direct communications or by e-mail.
8. Bangladesh Railway will conduct the short-listing of the interested consulting firms.
9. Only shortlisted firms will be issued RFP documents. The shortlisted firms/companies will be requested to carry out a multimedia presentation.
10. The Client will not be responsible for any costs or expenses incurred by the firm(s) in connection with the preparation or delivery of the EOI. The Executing Agency reserves the right to accept or reject any proposal without assigning any reason.

The share of each JV partner has to be clearly specified in application. Such JVCA agreement has to be formed prior to submission of application for this EoI. The shortlisted JV will be sustained for the entire bidding process. Once the list of shortlisted JV entities is finalized, no change in JV partners/entity including the percentage of shareholding in JV is permissible.</p> <p>(ii) In case of JVCA, all firms/entities shall be jointly liable for the assignment.</p> <p>(iii) The joint venture agreement shall in all respect be governed by and interpreted in accordance with Indian laws.</p> <p>(iv) Joint venture firm shall be required to submit the bid security and all other guarantees like performance guarantee, advance payment guarantee etc. only in the name of JV firm and not in the name of constituent member(s). Splitting of guarantees amongst the members of the JVCA shall not be permitted.</p> <p>(v) The JVCA shall nominate a lead partner who shall have the authority to conduct all business for and on behalf of any and all the partners of the JVCA during the pre-qualification process tendering process and, in the event the JVCA is awarded the contract, during contract execution.</p> <p>(vi) All the payments to the JVCA shall be made to the account of the JVCA and not to the account of individual member(s).</p>
