The Export-Import Bank of India [hereafter Exim Bank, or the Bank], on behalf of the Government of India (GOI), extends from time-to-time, concessional credit facilities under the Indian Development and Economic Assistance Scheme (IDEAS) to overseas governments/ their nominated agencies in developing countries for financing projects involving procurement of goods, civil works, consultancy and non-consultancy services to be contracted to Indian entities.

These Lines of Credit (LOCs) are governed by the Guidelines issued by the GOI from time-to-time. As per the extant guidelines issued vide letter No. 21/3/2015-IDEAS dated December 7, 2015, the Bank is required to carry out a prequalification exercise and provide a list of prequalified bidders to the Borrower for invitation of bids for specific contract packages under the project(s) financed by the LOCs.

In pursuance to the above, the Bank invites Applications from eligible Indian consultants for prequalification for preparation of the Detailed Project Report (DPR) for road projects (I) Kimbe to Hoskins and (II) Madang to Baiyer in Papua New Guinea under a Line of credit extended to the Government of the Papua New Guinea.

An upfront and non-refundable Processing Fee of INR 25,000 plus applicable GST (presently 18%) is payable through NEFT transfer as per details given below:

Part I: Scope of Consultancy Services

The Export-Import Bank of India (Exim Bank or the Bank), on behalf of the Government of India (GOI), has approved financing of road projects out of a Line of Credit (LOC) extended to the Government of the Papua New Guinea (PNG) for connecting (a) 'Kimbe' to 'Hoskins' in the West New Britain province of PNG and (b) 'Madang' to 'Baiyer', connecting the Western Highlands province to the Madang Province in PNG. A part of the LOC shall be utilized for the preparation of Detailed Project Report (DPR) for which Exim Bank now seeks applications for prequalification of eligible Indian Consultants. Refer ITA-4 of Part-II for eligibility criteria.

A. Background and Major Components of the Project

The Department of Works (DOW), Government of Papua New Guinea (PNG) (the "**Project Authority**") is implementing a number of highway projects that will help meet the infrastructure development objectives of the Government of PNG. The major works involves design, rehabilitation and construction of the highways. The roads from (a) 'Kimbe' to 'Hoskins' in the West New Britain province of PNG (approximate length 43 kms) and (b) from 'Baiyer' to 'Madang' connecting the Western Highlands province to the Madang Province in PNG (approximate length - 240 kms), are critical links in PNG's road network. The Government of PNG is desirous of constructing these roads to provide an efficient transport mode for faster movement of people and goods. The above road projects will provide immense benefits to the local communities and provide an impetus to the economic development in the region through significant reduction in travel time leading to faster movement of goods, commodities etc.; connecting various parts of the country; significant reduction in vehicle operating cost; improved trade and commerce; greater access to healthcare and education, etc.

B. Location of the Project

(a) **'Kimbe' to 'Hoskins' Road Project (approximate length - 43 kms)** : This section covers a total of 42km of road that links the Kimbe Town with the Hoskins Airport. This section of the road is currently a two lane sealed road. **Kimbe** is the capital of the province of West New Britain Province, which is a travel destination in Papua New Guinea and is well known for its world-class scuba-diving and game fishing. Kimbe is a port town located on the Kimbe Bay and is the third largest port in Papua New Guinea. Kimbe is served by **Hoskins** Airport located about 42km from the Town. This route services two key intersections viz, Mosa and Mai Junction.

(b) **'Baiyer' to 'Madang' Road Project (approximate length - 240 km.)**: The 'Baiyer' to 'Madang' road is an alternate highway to the existing Highlands Highway, and when fully developed will be the shortest possible route to reach Madang Province in comparison to the existing Highlands Highway to Madang. When fully developed, the road will link the highlands provinces to the coastal township of Madang, via the Ruti Valley, Simbai Area and the Middle Ramu River Basin.

C. Scope of Work

The tasks to be undertaken by the Consultant are divided into two (2) phases :

Phase-1.

Carry out feasibility study: The Consultant shall carry out the required survey and investigation, safeguards (environmental and resettlement) assessments, and feasibility study of various options for the road construction. The feasibility study shall include technical analysis, scope of the project, concept designs, cost estimates, risk and situation assessment, environmental and social impact assessments. The main purpose of this exercise is to come out with various options for construction of roads to provide a link between 'Kimbe' to 'Hoskins' and 'Baiyer' and 'Madang', to make the road passable and for movement of traffic. The various options will take into account : (i) type of road to be constructed i.e., whether paved or unpaved road (dirt road/track road) ; (ii) types of bridges and culverts to be constructed; (iii) geometrics/gradient of the road and (iv) specifications/standards for construction of road within the available funding.

Phase-2.

Preparation and submission of Detailed Project Report: After a particular option has been selected by the Project Authority as may be suggested by the consultant during Phase-1, the Consultant shall prepare the following:

- (a) **Detailed Engineering Designs (DED):** Based on its survey and investigation reports/data, the Consultant shall prepare the DED, complete in all respect including all drawings, technical specifications, BOQ, and method of measurement, etc. in accordance with the relevant road design standards of DOW.
- (b) **Safeguard Documents (Environmental and Land Acquisition and Resettlement):** The Consultant shall prepare the environmental and land acquisition and resettlement safeguard documents in accordance with applicable laws of PNG;

D. Other Deliverables

As part of the assignment, the Consultant shall assess the following which shall be included in the final Detailed Project Report (DPR) of the Consultant based on the alternative selected by the project authority:

- (a) Assessment about the availability and type of land (rocky/marshy/water-logged), details of access/right of way to the site, in consultation with the local government officials;
- (b) Requirement and availability of suitable construction materials in the vicinity of project site, including availability of quarry, raw materials and intermediate inputs as well as utilities like water, electricity, gas, etc. as may be required by the contractor during construction of the roads;

- (c) Requirement and availability of skilled and unskilled human resources in the region, as may be required during construction of the roads;
- (d) Applicable provisions of various departments of the Government of PNG for implementation of the project, such as tax exoneration, allotment of land, environmental clearances, security to the Indian personnel, clearance of goods from the port authorities and its transportation to the site, etc., as an information to the prospective bidders.
- (e) Attainability of the minimum Indian content of 75% value of the contract. If not, how much relaxation will be required and the cost of the project with minimum Indian content (75%) and with suggested relaxation.
- (f) The DPR consultant, while arriving at cost estimates, should also mention about feasible transport routes for material from India and associated costs.
- (g) Current set-up of roads and highways, traffic load, etc.,
- (h) Requirements in connection with EIA (Environment Impact Analysis) studies and applicable regulations.

E. Contract execution period

The duration of the contract shall be six (6) calendar months from the date of commencement of the services. The Consultant shall submit all outputs specified in this document within the aforesaid period.

F. Client's Inputs : The Client shall provide the following:

- (a) All available documents, reports, data and all other information related to the proposed assignment.
- (b) Counterpart staff to work with the consultant (this will be identified at the time of contract negotiations or contract implementation).
- (c) Provide any letters or assistance required by the consultant in obtaining all necessary permits and authorizations for carrying out the services.
- (d) Provide assistance for the international personnel in obtaining necessary visa, for their stay in PNG.

G. GOI Guidelines

As per the GOI guidelines, goods, works and services for minimum 75% value of the contracts covered under these Lines of Credit, must be sourced from India. A. General

| 1. Background | 1.1 The Export-Import Bank of India (hereinafter called “the Bank”), on behalf of the Government of India (GOI), extends from time-to-time, concessional credit facilities (hereinafter called “Lines of Credit”) under the Indian Development and Economic Assistance Scheme (IDEAS) to overseas governments or their nominated agencies (hereinafter called “Borrower or Employer”), for financing projects to be executed by Indian entities. Payment by the Bank to the Indian exporters will be made only at the request of the Borrower and upon approval by the Bank, and will be subject, in all respects, to the terms and conditions of the credit (or financing) agreement. |
| 2. Scope of Prequalification | 2.1 With reference to the Invitation for Prequalification (IFP) indicated in Part III, Data Sheet (DS), this Application Document (“Application Document”) is being issued by the Bank to prospective applicants (“Applicants”) interested in submitting applications (“Applications”) for prequalification as per the scope described in Part I, Scope of Consultancy Services and subject to the provisions of this Application Document. |
| 3. Ethics and Integrity | <p>3.1 The Bank requires Applicants to participate in this prequalification process with the highest standards of ethics and integrity. It is strictly forbidden to the parties involved in the prequalification process, by themselves or by a third party, to offer, ask or accept for itself or for a third party, financial or non-financial advantage or even direct or indirect promise or any other acts¹, as offsets for prequalification or bidding or contract award and execution as applicable, if susceptible of being qualified as criminal unlawful acts in accordance with national laws of any party involved.</p> <p>3.2 In pursuance of ITA 3.1 above, Applicants shall permit the Bank to inspect all accounts, records and other documents relating to the submission of the Application, bid submission (in case prequalified), and contract performance (in the case of award), and to have them audited by auditors appointed by the Bank.</p> <p>3.3 If, in accordance with the administrative procedures of the Bank, it is demonstrated that an Applicant in this prequalification process,</p> |

or during the subsequent bidding for the contract(s) has violated the provisions stated in ITA 3.1 above, the Bank, inter alia,

- a. shall reject any Application for prequalification or proposal to award a contract in connection with the subsequent procurement process, as applicable; and/or
- b. may declare an Applicant, temporarily or permanently, ineligible to be awarded future contracts under Bank funding.

4. Eligibility of Applicants

- 4.1 This prequalification exercise is open to only Indian Applicants in accordance with the provisions of ITA 4.4. Any form of association by the Applicant with ineligible entities either during this prequalification process or subsequent bidding process may be liable for rejection.
- 4.2 For the purpose of applying the eligibility criteria listed in this article 4, "Applicant" would include the single entity or in case of a joint venture ("JV"), each member of the JV, involved or intended to be involved with this prequalification process (as mentioned in Form A.1.2 Applicant's/ JV Member's Information Form), for any part of the prospective contract(s) including related services.
- 4.3 An Applicant may be a single entity or a combination of entities in the form of a JV either existing or with the intent to enter into a JV supported by a letter of intent or JV Agreement listing out the names of all the JV members. In the case of a JV, all members shall be jointly and severally liable for the execution of the subsequent contract(s) in accordance with the respective contract terms. The JV shall be represented by an authorized representative who shall have the authority from all members of the JV so as to conduct all business for and on behalf of the JV during the prequalification process. The limit on the number of members in a JV would be as specified in the **DS**.
- 4.4 This prequalification exercise is open to only Indian Applicants. An Applicant shall be deemed to be Indian if the Applicant is constituted, incorporated or registered in, and operates in accordance with the provisions of the laws of India, as evidenced by its articles of incorporation and its registration documents, as the case may be.
- 4.5 An Applicant that has been blacklisted/debarred/ sanctioned by any Multilateral Development Agencies (MDA) or any authority in India or the borrowing country in accordance with extant rules and procedures, shall be ineligible to participate in the prequalification/bidding process as applicable, during such period

of time as the sanctioning authority shall have determined. In case the Applicant is blacklisted/ debarred/sanctioned post the prequalification process (i.e. including during bidding process and Project implementation phase), the Applicant shall immediately inform Exim Bank of such blacklisting/ debarment/sanction and reasons thereof. This may lead to cancellation of prequalification / contract.

- 4.6 The list of debarred firms and individuals by certain leading MDAs is available as specified in the **DS**. This may not be an exhaustive list of debarred entities but those which are made available centrally on the respective MDA's website. Additionally, there could be lists of debarred entities issued by various government departments/ procuring entities/ corporations and maintained offline.
- 4.7 An Applicant shall be ineligible to be prequalified if it is currently under default on any loan to any Bank/ Financial Institution (FI) as per Central Repository of Information on Large Credits (CRILC) database and its account has been classified as Non-Performing Asset (NPA) with any Bank/FI or their companies/ promoters/ directors appear in Reserve Bank of India (RBI) Caution List, RBI Wilful Defaulter List (Suit filed as well as non-suit filed), Credit Information Bureau India Ltd. (CIBIL) Defaulter List and any other negative list of central and state government agencies, updated from time to time. On being included in any of the above lists post the prequalification process (i.e. including during bidding process and Project implementation phase), the Applicant shall immediately inform Exim Bank on the inclusion and reasons for inclusion thereof. This may lead to cancellation of prequalification / contract.
- 4.8 An Applicant shall furnish such evidence of eligibility satisfactory to the Bank, as the Bank shall reasonably request.

B. Composition of the Application Document

- 5.2 Unless obtained directly from the Bank, the Bank shall not be responsible for the completeness of the document, responses to requests for clarification, or Addenda to the Application Document in accordance with ITA 7. In case of any discrepancies, documents issued directly by the Bank shall prevail.
- 5.3 An Applicant is expected to study all instructions, and forms in the Application Document and to furnish with its Application all information or documentation as is required by the Application Document.

6. Clarifications

- 6.1 A prospective Applicant requiring any clarification of the Application Document shall contact the Bank in writing at the Bank's address indicated in the **DS**. The Bank will respond in writing to any request for clarification provided that such request is received no later than fourteen (14) days prior to the deadline for submission of the applications. The Bank's response, at its discretion, may be put up on its website and shall include a description of the inquiry (without identifying its source) and corresponding clarification. As a result of a clarification the Bank may, if necessary, amend the Application Document in accordance with the provisions of ITA 7.
- 6.2 Any modification to the Application Document that may become necessary as a result of the clarifications to the queries shall be made by the Bank exclusively through the use of a Corrigendum pursuant to ITA 7.

7. Corrigendum of Application Document

- 7.1 At any time prior to the deadline for submission of Applications, the Bank may amend the Application Document by issuing a Corrigendum.
- 7.2 Any Corrigendum or Addenda issued shall be deemed to be part of the Application Document and shall be published on the Bank's website.
- 7.3 Post Corrigendum, in order to allow sufficient time to the prospective Applicants in preparing their Applications, or for other good reason, the Bank may, at its discretion, extend the deadline for the submission of Applications in accordance with ITA 16.2.

C. Preparation, Submission and Opening of Applications

8. Cost towards Application

- 8.1 The Applicant shall bear all costs associated with the preparation and submission of its Application. The Bank will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the prequalification process.

- 9. Language**
- 9.1 The Application documentation and printed literature that are part of the Application, if in another language, shall be accompanied by an accurate translation of the relevant passages in English language, which shall be the governing language.
- 10. Documents constituting the Application**
- 10.1 The Application shall comprise the following:
- (a) Application Submission Form, in accordance with ITA 11.1;
 - (b) documentary evidence establishing the Applicant's eligibility, in accordance with ITA 12.1;
 - (c) documentary evidence establishing the Applicant's qualifications, in accordance with ITA 13; and
 - (d) any other document required as specified in the **DS**.
- 11. Application Submission Form**
- 11.1 The Applicant shall complete an Application Submission Form as provided in Part V (Forms). This Form must be completed without any alteration to its format.
- 12. Documents Evidencing the Applicant's Eligibility**
- 12.1 To establish its eligibility in accordance with ITA 4, the Applicant shall complete the eligibility declarations in the Application Submission Form and Forms A.1.1 and A.1.2, included in Part V (Forms).
- 13. Documents Evidencing the Applicant's Qualifications**
- 13.1 To establish its qualifications in accordance with Part IV, Prequalification Criteria and Requirements, the Applicant shall provide the information requested in the corresponding Forms included in Part V without any alteration to the format. Applicant shall also complete the Questionnaire included in Part VI without any alteration to the questions. Each Form included in Part V and the Questionnaire in Part VI shall be duly signed by the authorized representative of the Applicant. In case of JV, authorized representative of the respective member shall sign. Non-compliance with this clause may result in summary rejection of the Application.
- 13.2 Wherever a monetary amount is to be stated, Applicant should indicate the USD equivalent using the rate of exchange determined as follows:
- (a) Exchange rates shall be taken from the publicly available source identified in the **DS**. Any error in determining the exchange rates in the Application may be corrected by the Bank during evaluation;
 - (b) For data related to financial statements, the amounts shall be mentioned in Indian Rupees (INR). Equivalent amount in USD shall be arrived at using the exchange rate as on 31st March of respective financial year as specified in the **DS**;
 - (c) for data related to contracts signed in the current financial year, unless otherwise specified in the **DS**, the exchange rate prevalent as on the working day preceding the date of Invitation

for Prequalification (IFP) shall be used to arrive at the USD equivalent; and

- (d) for contracts signed prior to the current financial year, the exchange rate as on 31st March of the respective financial year in which the contract was signed shall be used to arrive at the USD equivalent as specified in the **DS**.

14. Authorized Signatory and Number of Copies

- 14.1 The Applicant shall prepare one original of the documents comprising the Application as described in ITA 10 and clearly mark it "ORIGINAL". The original of the Application shall be typed or written in indelible ink and shall be signed by a person duly authorized to sign on behalf of the Applicant. In case the Applicant is a JV, the Application shall be signed by all members of the JV.

15. Preparing the Application Envelope

- 15.1 The Applicant shall enclose the original Application in a sealed envelope that shall:
- (a) be addressed to the Bank, as per ITA 16.1;
 - (b) mention the name and address of the Applicant; and
 - (c) mention the specific identification of this prequalification process indicated in the **DS** ITA 2.1.
- 15.2 The Bank will accept no responsibility for not processing any envelope that was not prepared as required in ITA 15.1 above.

16. Application Submission Deadline

- 16.1 Applicants must submit their Applications in dual mode (on-line as well as off-line). Applications shall be received by the Bank at the address and no later than the deadline indicated in the **DS**.
- 16.2 The Bank may, at its discretion, extend the deadline for the submission of Applications by amending the Application Document in accordance with ITA 7.

17. Late Applications

- 17.1 Applications received after the deadline for submission of applications shall not be admissible, and if received, shall be returned unopened to the Applicant.

18. Opening of Applications

- 18.1 The Bank shall open all Applications at the date, time and place specified in the **DS**. Applicants' representatives may be present during opening.

D. Procedures for Evaluation of Applications

19. Evaluation to be Confidential

- 19.1 Information relating to the Applications, their evaluation and result shall be confidential and will not be disclosed to Applicants or any other person(s) not officially concerned with the prequalification process until the official notification of prequalification results is made in accordance with ITA 25.

19.2 From the deadline for submission of Applications to the time of notification of the results of the prequalification in accordance with ITA 25, any Applicant who wishes to contact the Bank on any matter related to the prequalification process (except as specified in ITA 20.1 below), may do so only in writing. Canvassing in any form will be grounds for disqualification.

20. Clarifications during Evaluation

20.1 During the evaluation of Applications, in case of ambiguity, the Bank may, at its discretion, ask an Applicant for a clarification of its Application, to be submitted within a stated reasonable period of time. Any request for clarification from the Bank and all clarifications from the Applicant shall be in writing. Any clarification submitted by an Applicant that is not in response to a request by the Bank may not be considered.

20.2 If an Applicant does not provide (within the time allowed) clarifications and/or documents requested as per the Bank's request for clarification, its Application shall be evaluated based on the information and documents available at the time of evaluation of the Application.

21. Determination of Responsiveness of Applications

21.1 The Bank may reject any Application which is not responsive to the requirements of the Application Document and may not subsequently be made responsive by correction of the causes of non-responsiveness or by substitution or resubmission of the Application or part thereof.

E. Evaluation of Applications and Prequalification of Applicants

22. Evaluation of Applications
