The Export-Import Bank of India [hereafter Exim Bank, or the Bank], on behalf of the Government of India (GOI), extends from time-to-time, concessional credit facilities under the Indian Development and Economic Assistance Scheme (IDEAS) to overseas governments/ their nominated agencies in developing countries for financing projects involving procurement of goods, civil works, consultancy and non-consultancy services to be contracted to Indian entities.

These Lines of Credit (LOCs) are governed by the Guidelines issued by the GOI from time-totime. As per the extant guidelines issued vide letter No. 21/3/2015-IDEAS dated December 7, 2015, the Bank is required to carry out a prequalification exercise and provide a list of prequalified bidders to the Borrower for invitation of bids for specific contract packages under the project(s) financed by the LOCs.

In pursuance to the above, the Bank invites Applications from eligible Indian consultants for prequalification for preparation of the Detailed Project Report (DPR) for road projects (I) Kimbe to Hoskins and (II) Madang to Baiyer in Papua New Guinea under a Line of credit extended to the Government of the Papua New Guinea.

Part I: Scope of Consultancy Services

The Export-Import Bank of India (Exim Bank or the Bank), on behalf of the Government of India (GOI), has approved financing of road projects out of a Line of Credit (LOC) extended to the Government of the Papua New Guinea (PNG) for connecting (a) 'Kimbe' to 'Hoskins' in the West New Britain province of PNG and (b) 'Madang' to 'Baiyer', connecting the Western Highlands province to the Madang Province in PNG. A part of the LOC shall be utilized for the preparation of Detailed Project Report (DPR) for which Exim Bank now seeks applications for prequalification of eligible Indian Consultants. Refer ITA-4 of Part-II for eligibility criteria.

A. Background and Major Components of the Project

The Department of Works (DOW), Government of Papua New Guinea (PNG) (the "**Project Authority**") is implementing a number of highway projects that will help meet the infrastructure development objectives of the Government of PNG. The major works involves design, rehabilitation and construction of the highways. The roads from (a) 'Kimbe' to 'Hoskins' in the West New Britain province of PNG (approximate length 43 kms) and (b) from 'Baiyer' to 'Madang' connecting the Western Highlands province to the Madang Province in PNG (approximate length - 240 kms), are critical links in PNG's road network. The Government of PNG is desirous of constructing these roads to provide an efficient transport mode for faster movement of people and goods. The above road projects will provide immense benefits to the local communities and provide an impetus to the economic development in the region through significant reduction in travel time leading to faster movement of goods, commodities etc.; connecting various parts of the country; significant reduction in vehicle operating cost; improved trade and commerce; greater access to healthcare and education, etc.

B. Location of the Project

- (a) 'Kimbe' to 'Hoskins' Road Project (approximate length 43 kms): This section covers a total of 42km of road that links the Kimbe Town with the Hoskins Airport. This section of the road is currently a two lane sealed road. Kimbe is the capital of the province of West New Britain Province, which is a travel destination in Papua New Guinea and is well known for its world-class scuba-diving and game fishing. Kimbe is a port town located on the Kimbe Bay and is the third largest port in Papua New Guinea. Kimbe is served by **Hoskins** Airport located about 42km from the Town. This route services two key intersections viz, Mosa and Mai Junction.
- (b) 'Baiyer' to 'Madang' Road Project (approximate length 240 km.): The 'Baiyer' to 'Madang' road is an alternate highway to the existing Highlands Highway, and when fully developed will be the shortest possible route to reach Madang Province in comparison to the existing Highlands Highway to Madang. When fully developed, the road will link the highlands provinces to the coastal township of Madang, via the Ruti Valley, Simbai Area and the Middle Ramu River Basin.

C. Scope of Work

The tasks to be undertaken by the Consultant are divided into two (2) phases :

Phase-1.

Carry out feasibility study: The Consultant shall carry out the required survey and investigation, safeguards (environmental and resettlement) assessments, and feasibility study of various options for the road construction. The feasibility study shall include technical analysis, scope of the project, concept designs, cost estimates, risk and situation assessment, environmental and social impact assessments. The main purpose of this exercise is to come out with various options for construction of roads to provide a link between 'Kimbe' to 'Hoskins' and 'Baiyer' and 'Madang', to make the road passable and for movement of traffic. The various options will take into account : (i) type of road to be constructed i.e., whether paved or unpaved road (dirt road/track road) ; (ii) types of bridges and culverts to be constructed; (iii) geometrics/gradient of the road and (iv) specifications/standards for construction of road within the available funding.

Phase-2.

Preparation and submission of Detailed Project Report: After a particular option has been selected by the Project Authority as may be suggested by the consultant during Phase-1, the Consultant shall prepare the following:

- (a) **Detailed Engineering Designs (DED)**: Based on its survey and investigation reports/data, the Consultant shall prepare the DED, complete in all respect including all drawings, technical specifications, BOQ, and method of measurement, etc. in accordance with the relevant road design standards of DOW.
- (b) **Safeguard Documents (Environmental and Land Acquisition and Resettlement)**: The Consultant shall prepare the environmental and land acquisition and resettlement safeguard documents in accordance with applicable laws of PNG;

D. Other Deliverables

As part of the assignment, the Consultant shall assess the following which shall be included in the final Detailed Project Report (DPR) of the Consultant based on the alternative selected by the project authority:

- (a) Assessment about the availability and type of land (rocky/marshy/water-logged), details of access/right of way to the site, in consultation with the local government officials;
- (b) Requirement and availability of suitable construction materials in the vicinity of project site, including availability of quarry, raw materials and intermediate inputs as well as utilities like water, electricity, gas, etc. as may be required by the contractor during construction of the roads;

- (c) Requirement and availability of skilled and unskilled human resources in the region, as may be required during construction of the roads;
- (d) Applicable provisions of various departments of the Government of PNG for implementation of the project, such as tax exoneration, allotment of land, environmental clearances, security to the Indian personnel, clearance of goods from the port authorities and its transportation to the site, etc., as an information to the prospective bidders.
- (e) Attainability of the minimum Indian content of 75% value of the contract. If not, how much relaxation will be required and the cost of the project with minimum Indian content (75%) and with suggested relaxation.
- (f) The DPR consultant, while arriving at cost estimates, should also mention about feasible transport routes for material from India and associated costs.
- (g) Current set-up of roads and highways, traffic load, etc.,
- (h) Requirements in connection with EIA (Environment Impact Analysis) studies and applicable regulations.

E. <u>Contract execution period</u>

The duration of the contract shall be six (6) calendar months from the date of commencement of the services. The Consultant shall submit all outputs specified in this document within the aforesaid period.

- F. <u>Client's Inputs</u> : The Client shall provide the following:
 - (a) All available documents, reports, data and all other information related to the proposed assignment.
 - (b) Counterpart staff to work with the consultant (this will be identified at the time of contract negotiations or contract implementation).
 - (c) Provide any letters or assistance required by the consultant in obtaining all necessary permits and authorizations for carrying out the services.
 - (d) Provide assistance for the international personnel in obtaining necessary visa, for their stay in PNG.

G. GOI Guidelines

As per the GOI guidelines, goods, works and services for minimum 75% value of the contracts covered under these Lines of Credit, must be sourced from India. A. General

| 1. | Background | 1.1 | The Export-Import Bank of India (hereinafter called "the Bank"), on behalf of the Government of India (GOI), extends from time-to-time, concessional credit facilities (hereinafter called "Lines of Credit") under the Indian Development and Economic Assistance Scheme (IDEAS) to overseas governments or their nominated agencies (hereinafter called "Borrower or Employer"), for financing projects to be executed by Indian entities. Payment by the Bank to the Indian exporters will be made only at the request of the Borrower and upon approval by the Bank, and will be subject, in all respects, to the terms and conditions of the credit (or financing) agreement. |

| 2. | Scope of Prequalification | 2.1 | With reference to the Invitation for Prequalification (IFP) indicated in Part III, Data Sheet (DS), this Application Document ("Application Document") is being issued by the Bank to prospective applicants ("Applicants") interested in submitting applications ("Applications") for prequalification as per the scope described in Part I, Scope of Consultancy Services and subject to the provisions of this Application Document. |
| 3. | Ethics and Integrity | 3.1 | The Bank requires Applicants to participate in this prequalification process with the highest standards of ethics and integrity. It is strictly forbidden to the parties involved in the prequalification process, by themselves or by a third party, to offer, ask or accept for itself or for a third party, financial or non-financial advantage or even direct or indirect promise or any other acts ¹ , as offsets for prequalification or bidding or contract award and execution as applicable, if susceptible of being qualified as criminal unlawful acts in accordance with national laws of any party involved. |
| | | 3.2 | In pursuance of ITA 3.1 above, Applicants shall permit the Bank to inspect all accounts, records and other documents relating to the submission of the Application, bid submission (in case prequalified), and contract performance (in the case of award), and to have them audited by auditors appointed by the Bank. |

3.3 If, in accordance with the administrative procedures of the Bank, it is demonstrated that an Applicant in this prequalification process,

or during the subsequent bidding for the contract(s) has violated the provisions stated in ITA 3.1 above, the Bank, inter alia,

- a. shall reject any Application for pregualification or proposal to award a contract in connection with the subsequent procurement process, as applicable; and/or
- b. may declare an Applicant, temporarily or permanently, ineligible to be awarded future contracts under Bank funding.
- 4. Eligibility of This pregualification exercise is open to only Indian Applicants in 4.1 accordance with the provisions of ITA 4.4. Any form of association by the Applicant with ineligible entities either during this pregualification process or subsequent bidding process may be liable for rejection.
 - 4.2 For the purpose of applying the eligibility criteria listed in this article 4, "Applicant" would include the single entity or in case of a joint venture ("JV"), each member of the JV, involved or intended to be involved with this pregualification process (as mentioned in Form A.1.2 Applicant's/ JV Member's Information Form), for any part of the prospective contract(s) including related services.
 - 4.3 An Applicant may be a single entity or a combination of entities in the form of a JV either existing or with the intent to enter into a JV supported by a letter of intent or JV Agreement listing out the names of all the JV members. In the case of a JV, all members shall be jointly and severally liable for the execution of the subsequent contract(s) in accordance with the respective contract terms. The JV shall be represented by an authorized representative who shall have the authority from all members of the JV so as to conduct all business for and on behalf of the JV during the pregualification process. The limit on the number of members in a JV would be as specified in the **DS**.
 - 4.4 This prequalification exercise is open to only Indian Applicants. An Applicant shall be deemed to be Indian if the Applicant is constituted, incorporated or registered in, and operates in accordance with the provisions of the laws of India, as evidenced by its articles of incorporation and its registration documents, as the case may be.
 - 4.5 An Applicant that has been blacklisted/debarred/ sanctioned by any Multilateral Development Agencies (MDA) or any authority in India or the borrowing country in accordance with extant rules and participate procedures, shall be ineligible to in the pregualification/bidding process as applicable, during such period

of time as the sanctioning authority shall have determined. In case the Applicant is blacklisted/ debarred/sanctioned post the prequalification process (i.e. including during bidding process and Project implementation phase), the Applicant shall immediately inform Exim Bank of such blacklisting/ debarment/sanction and reasons thereof. This may lead to cancellation of prequalification / contract.

- 4.6 The list of debarred firms and individuals by certain leading MDAs is available as specified in the **DS**. This may not be an exhaustive list of debarred entities but those which are made available centrally on the respective MDA's website. Additionally, there could be lists of debarred entities issued by various government departments/ procuring entities/ corporations and maintained offline.
- 4.7 An Applicant shall be ineligible to be prequalified if it is currently under default on any loan to any Bank/ Financial Institution (FI) as per Central Repository of Information on Large Credits (CRILC) database and its account has been classified as Non-Performing Asset (NPA) with any Bank/FI or their companies/ promoters/ directors appear in Reserve Bank of India (RBI) Caution List, RBI Wilful Defaulter List (Suit filed as well as non-suit filed), Credit Information Bureau India Ltd. (CIBIL) Defaulter List and any other negative list of central and state government agencies, updated from time to time. On being included in any of the above lists post the prequalification process (i.e. including during bidding process and Project implementation phase), the Applicant shall immediately inform Exim Bank on the inclusion and reasons for inclusion thereof. This may lead to cancellation of prequalification / contract.
- 4.8 An Applicant shall furnish such evidence of eligibility satisfactory to the Bank, as the Bank shall reasonably request.

- 5.2 Unless obtained directly from the Bank, the Bank shall not be responsible for the completeness of the document, responses to requests for clarification, or Addenda to the Application Document in accordance with ITA 7. In case of any discrepancies, documents issued directly by the Bank shall prevail.
- 5.3 An Applicant is expected to study all instructions, and forms in the Application Document and to furnish with its Application all information or documentation as is required by the Application Document.

 6.1 A prospective Applicant requiring any clarification of the Application Document shall contact the Bank in writing at the Bank's address indicated in the DS. The Bank's response, at its discretion, may be put up on its website and shall include a description of the inquiry (without identifying its source) and corresponding clarification. As a result of a clarification the Bank may, if necessary, amend the Application Document in accordance with the provisions of ITA 7.
 - 6.2 Any modification to the Application Document that may become necessary as a result of the clarifications to the queries shall be made by the Bank exclusively through the use of a Corrigendum pursuant to ITA 7.
