INVITATION TO SUBMIT PROPOSALS

1. The Government of the Republic of Mauritius has received a Line of Credit from the Export-Import Bank of India (Exim Bank) and intends to apply part of the proceeds of this Credit to cover eligible payments under the contract for the appointment of a Project Management Consultant (PMC) for the design and construction supervision of Administrative Building(s) of total gross floor area of approximately 30,000 m² to 40,000 m² at Cote d'Or City.
2. **Cote d'Or City Ltd.**, on behalf of the **Government of the Republic of Mauritius** now invites Indian Consulting firms to submit their Proposals to act as Project Management Consultant (PMC) for the project. The broad scope of services shall include but not be limited to the following:
 - (a) Design the Administrative Building(s) and associated site works
 - (b) Design all the onsite and offsite infrastructure works (access roads, water reticulation, sewerage network, electricity connection works, surface water drainage, telecommunication network, etc.) to service the project site
 - (c) Manage the procurement processes for the appointment of contractor/s.
 - (d) Management and supervision of the Construction activities
