As per the extant guidelines issued vide letter No. 21/3/2015-IDEAS dated December 7, 2015, the Bank is required to carry out a prequalification exercise and provide a list of prequalified bidders to the Borrower for invitation of bids for specific contract packages under the project(s) financed by the LOCs.

Part I: Scope of EPC

The Export-Import Bank of India (hereafter Exim Bank or the Bank), on behalf of the Government of India (GOI) has approved financing of a project out of a Line of Credit extended to the Ecowas Bank for Investment and Development (EBID), Togo for supply of equipment and rehabilitation of health centres / hospitals in Cote D'Ivoire under a Line of Credit, for which Exim Bank now seeks applications for prequalification from eligible Indian entities. Refer Part II ITA 4 for eligibility provisions.

A] Background and Major Components of the Project

Site and other Data

With a population of around 24.3 million in 2017, Cote d'Ivoire has about sixty ethnic groups and nearly seventy languages. Located in West Africa Cote d'Ivoire is bordered by Ghana to the east, Guinea and Liberia to the west, Burkina Faso and Mali to the north and the Atlantic Ocean to the south. Cote d'Ivoire) is a relatively decentralized state. The country divided into 14 administrative districts, of which two are cities organized as autonomous districts (Abidjan and Yamoussoukro). The 12 non-autonomous districts are subdivided into 31 second-level "regions". The autonomous districts and the regions are divided into 108 third-level "departments". The departments are divided into 510 fourth-level "sub-prefectures". Sub-prefectures contain "villages" and, in some instances, several villages are combined into fifth-level communes. There are 197 communes.

Côte d'Ivoire (CIV) is a lower-middle income country (LMIC) with a Gross National Income (GNI) per capita of US\$1,520 in 2016 and is the second largest economy in West Africa. After 10 years of economic stagnation accompanying civil unrest, economic growth picked up and GDP has increased at more than 7% annually.Since 2012, the country ranks among the top ten countries with the highest growth rate in the world (averaging 9.4% over the period 2012-2015). At 1%, inflation has been lower than the regional average and a series of structural reforms aimed at supporting business activity, accompanied by infrastructure investments to redress the impact of civil conflict, have helped to stimulate economic growth. The macroeconomic outlook remains positive, with IMF predicting growth at similar rates until 2020, with continued low inflation.

The health system in Côte d'Ivoire is organized according to the administrative divide. At village level, there are primary care service (Centre de santé rural/CSR), it's the first population health contact managed by the nurses or wise women. Most of these centers are difficult to access due to bad roads. At the Sub-prefectures and communes, there are secondary primary care service (Centre de santé urbain/CSU) with a medical doctor. At the department level, there are reference hospitals (Hopital Général/HG) with urgent, medical consultation, obstetrical, operation, basic radio diagnostic services. The regional level is linked with the Regional Hospital (Centre Hospitalier Régional/CHR). At the top, there are tertiary level with the Universities and Reseach Hospitals called Centre Hospitalier Universitaire /CHU). The current public health system in Côte d'Ivoire contains around 2000 primary health care centres; 112 general hospitals; 23 Regional Hospitals and 5 University Hospitals.

Weak infrastructure and unavailability of drugs and medical equipment are important challenges, especially for maternal and child health. 45% of primary and secondary health facilities are without electricity; 35% without water; and 32% without both water and electricity.

Project background

The objective of the Project is to rehabilitate and equip 117 health facilities in Côte d'Ivoire. It is intended to equip 80 health centres and 8 general hospitals, and to rehabilitate and equip 29 health centres. It is also planned to build the capacity of maintenance services in health facilities. The overall objective of the project is to improve the use and quality of health services with an emphasis on maternal, new-born and child health.

The expected results from the project are:

- equipping 80 health facilities and 8 general hospitals;
- rehabilitating and fully equipping 29 health centres;
- equipping the maintenance services of the Department of Equipment and Maintenance Infrastructure (DIEM);
- training engineers and technicians on how to maintain equipment;
- ensuring the mobility of DIEM staff through the acquisition of vehicles.

Scope of EPC

The scope of EPC includes supply installation and commissioning of medical equipments and rehabilitation of healthcare facilities. Details as under:

Major Components of the Project

The project of Equipment and Rehabilitation of the Health facility in Côte d'Ivoire aims to equip with biomedical material for one hundred and seventeen (117) health facilities in Côte d'Ivoire. The broad category of supplies / rehabilitation is bifurcated in 4 batches as under:

1. Count of X-ray Remote-controlled digitized, Digitized Radiography and Echography (scanning) equipment, Operating room, Anaesthesia, Intensive Care, Hygiene equipment and sterilization;

2. Laboratory equipment, medical furniture (dispensary equipment and Maternity), small medical equipment, maintenance tools;

- 3. Rehabilitation of health infrastructures
- 4. Furniture, general and logistic equipment

Batch I : Count of X-ray Remote-controlled digitized, Digitized Radiography and Echography (scanning) equipment, Operating room, Anaesthesia, Intensive Care, Hygiene equipment and sterilization:

a) Count of X-ray Remote-controlled digitized: The equipment will have to ensure examination of pulmonary, skeleton, traumatology; and routine and emergency examinations, orthopaedic applications, special application (contrast products, fluoroscopic, whole-body PET screening) with option to treat images on laptop.

b) X-ray Digitized Radiography and Echography equipment: The equipment is used for following examinations: examination of pulmonary, skeleton, traumatology; and routine et emergency examinations

c) Color Echographe doppler for general and obstetric examination. Mutidisciplinary use for the following applications: Abdomen, Cardiology, Gynécology, Obstétric, Urology, soft tissue, Pédiatrics, foetal ultrasound, skeletal Musculos, Orthopedic, Vascular.

d) Hygiene and sterilization equipment: It includes isolated maternity home, hygiene and sterilization equipment (Autoclave of straw mattress, autoclaves horizontal and vertical autoclave sterilizer), Thermo plastic welding machine of sachet, Apparatus of disinfection to ultrasounds.

Batch II: Laboratory equipment, medical furniture (dispensary equipment and Maternity), small medical equipment, maintenance tools

a) Laboratory equipment: Vertical autoclave, blood bank centrifuges, Automat of biochemistry, Automat of hematology, binocular microscopes, Agitator Vortex, electrophoresis channels, Marie bath thermostated, spectrophotometers and Elisa chains,

Refrigerator/medical freezer, Hemoglobin meter, Automatic set of pipettes, Water 4-6l/h distiller.

b) Surgery and Intensive Care Unit equipment: Anesthesia tables, surgical aspirator, mucositis aspirator, Defibrillators, Intensive care respirators, patient monitors, syringe, Intensive care manuals and laryngoscope, General-purpose operating table, electrosurgical unit, scialytic, oxygen concentrator, Carriage of oxygen treatment, baby resuscitation table, incubator, phototherapy lamp, heat lamp, Saw with plaster, Aseptic wash-hand basin 1 and 2 stations, Négatoscope 1-2-3 beaches

c) Maternity home equipment: Foetal pulse detectors, examination lamps, adult weighs, baby weighs and examination table, cardiotocograph, Weigh anybody with measuring apparatus.

d) Medical furniture: Reads reanimation, reads mobile hospitalization, Instrument carriage, Carriage with clean linen, Carriage with dirty linen, Carriage of care, Count with instrument, Count with bandage, Count with plaster, Count of childbirth, Bedside table, Dumb assistant, Cradle with hull, Stool 2 steps stainless, Metal rack, Armchair of taking away, Wheel chair, Folding screen 3 panels, Carry-cup doubles stainless, Bracket, Stool with adjustable height, Stool with mobile adjustable height with splash plate Stool anesthetist, Stool anesthetist, Stool surgeon, Instrument window

e) Boxes and small materials: Limp with amputation, Limp with appendicitis/hernia, Bandage box, Limp with joining, Limp digestive surgery, Limp digestive and biliary surgery, Limp of childbirth, Box of childbirth great composition, Limp of amygdalectomy, Limp of Cesarean, Box of general surgery, Limp of pediatric surgery, Limp of curetting, Limp of Goiter and Thyroïde, Box of cyst, Limp of laparotomy, Limp of laparotomy child, Limp of small surgery, Limp of gynaecological examination, Limp of hysterectomy, Limp of intruments with plaster, Limp evisceration, Limp male nurse, Limp for circumcision, Limp for abdominal surgery, Limp for digestive surgery, Limp for episiotomy, Limp for vegetation, Otoscope, Weigh anybody with measuring apparatus, Bathroom scales

f) Maintenance tools for the CRIEM (Regional Center of Infrastructure, Equipment and maintenance) and the District Maintenance Workshop (AMD). The maintenance tools will consist in three Equipments: Toolbox, Set of tools for equipment quality control and Full electronics suitcase

The contract will also include (i) maintenance of equipment for one year and (ii) training of users of DIEM, CRIEM and AMD. The CRIEM are located in five (07) Districts: Abidjan, Abengourou, Bondoukou, Yamoussoukro, Daloa, San Pedro, Man. The AMD are located in 04 Districts: Danané, Toumodi, Dimbokro and Guiglo.

Batch III: Rehabilitation of health infrastructure

The rehabilitation will include Partial Rehabilitation of 10 secondary hospitals and complete Rehabilitation of 26 primary health care. The rehabilitation of primary health care will include rehabilitation of the dispensary, the maternity and latrine, including ancillary annex such as laboratory, vaccination course etc.

For the General and Regional Hospital Centers, the rehabilitation works will include rehabilitation of the radiology, operating room, laboratory, pediatric and maternity services to allow installation of the equipments.

The rehabilitation works will aim at restoring the main part of the infrastructure, such as:

- Health building super-structure (foundation, building enhancement)
- Technical installations (plumbing, electricity, sanitization)
- secondary state corps (carpentry, tiles, false ceiling, roof, painting)
- Connections in water and electricity of sanitary structures.

Batch IV: Furniture, general equipment and logistics

The Batch IV will include the following:

- a) Vehicles: Provision of 4x4 and Pick-Up vehicles for the project.
- b) Motorbike: Acquisition of motorbikes for the equipment's maintenance specialist.
- c) Informatics and office furniture's: Laptop computers; High volume copier; Video projector with screen wall; Multifunction printer.

The above description are general and the details will be described in the schedule of requirements and the tender documents that will be issued at the tendering stage.

B] Contract execution period

The overall duration of the contract is expected to be: Eight (8) months

D] GOI Guidelines

As per the GOI guidelines, goods and services for minimum 75% value of the contracts covered under the Lines of Credit, must be sourced from India. Part II. Instructions to Applicants

A. General

- 1. Background

 The Export-Import Bank of India (hereinafter called "the Bank"), on behalf of the Government of India (GOI), extends from time-to-time, concessional credit facilities (hereinafter called "Lines of Credit") under the Indian Development and Economic Assistance Scheme (IDEAS) to overseas governments or their nominated agencies (hereinafter called "Borrower or Employer"), for financing projects to be executed by Indian entities. Payment by the Bank to the Indian exporters will be made only at the request of the Borrower and upon approval by the Bank, and will be subject, in all respects, to the terms and conditions of the credit (or financing) agreement.
- 2. Scope of Prequalification
 2.1 With reference to the Invitation for Prequalification (IFP) indicated in Part III, Data Sheet (DS), this Application Document ("Application Document") is being issued by the Bank to prospective applicants ("Applicants") interested in submitting applications ("Applications") for prequalification as per the scope described in Part I, Scope of EPC and subject to the provisions of this Application Document.
- 3. Ethics and Integrity
 3.1 The Bank requires Applicants to participate in this prequalification process with the highest standards of ethics and integrity. It is strictly forbidden to the parties involved in the prequalification process, by themselves or by a third party, to offer, ask or accept for itself or for a third party, financial or non-financial advantage or even direct or indirect promise or any other acts¹, as offsets for prequalification or bidding or contract award and execution as applicable, if susceptible of being qualified as criminal unlawful acts in accordance with national laws of any party involved.
 - 3.2 In pursuance of ITA 3.1 above, Applicants shall permit the Bank to inspect all accounts, records and other documents relating to the submission of the Application, bid submission (in case prequalified), and contract performance (in the case of award), and to have them audited by auditors appointed by the Bank.
 - 3.3 If, in accordance with the administrative procedures of the Bank, it is demonstrated that an Applicant in this prequalification process, or during the subsequent bidding for the contract(s) has violated the provisions stated in ITA 3.1 above, the Bank, inter alia,
 - a. shall reject any Application for prequalification or proposal to award a contract in connection with the subsequent procurement process, as applicable; and/or
 - b. may declare an Applicant, temporarily or permanently, ineligible to be awarded future contracts under Bank funding.

- 4. Eligibility of Applicants
- 4.1 This prequalification exercise is open to only Indian Applicants in accordance with the provisions of ITA 4.4. Any form of association

by the Applicant with ineligible entities either during this prequalification process or subsequent bidding process may be liable for rejection.

- 4.2 For the purpose of applying the eligibility criteria listed in this article 4, "Applicant" would include the single entity or in case of a joint venture ("JV"), each member of the JV, involved or intended to be involved with this prequalification process (as mentioned in Form A.1.2 Applicant's JV Member's Information Form), for any part of the prospective contract(s) including related services.
- 4.3 An Applicant may be a single entity or a combination of entities in the form of a JV either existing or with the intent to enter into a JV supported by a letter of intent or JV Agreement listing out the names of all the JV members. In the case of a JV, all members shall be jointly and severally liable for the execution of the contract(s) in accordance with the respective contract terms. The JV shall be represented by an authorized representative who shall have the authority from all members of the JV to conduct all business for and on behalf of the JV during the prequalification process. The limit on the number of members in a JV would be as specified in the **DS**.
- 4.4 This prequalification exercise is open to only Indian Applicants. An Applicant shall be deemed to be Indian if the Applicant is constituted, incorporated or registered, and operates in accordance with the provisions of the laws of India, as evidenced by its articles of incorporation and its registration documents, as the case may be.
- 4.5 An Applicant that has been blacklisted/ debarred/ sanctioned by any Multilateral Development Agency (MDA) or any authority in India or the borrowing country in accordance with extant rules and ineligible procedures, shall be to participate in the pregualification/ bidding process as applicable, during such period of time as the sanctioning authority shall have determined. In case the Applicant is blacklisted/ debarred/sanctioned, the Applicant shall immediately inform Exim Bank of such blacklisting/ debarment/sanction and reasons thereof. This may lead to cancellation of pregualification / contract.
- 4.6 The list of debarred firms and individuals by certain leading MDAs is available as specified in the **DS**. This may not be an exhaustive list of debarred entities but those which are made available centrally on the respective MDA's website. Additionally, there could be lists of debarred entities issued by various government departments/ procuring entities/ corporations and maintained offline.
- 4.7 An Applicant shall be ineligible to be prequalified if (a) it is currently under default on any loan to any Bank/Financial Institution (FI) and its account has been classified as Non-Performing Asset (NPA) as per Central Repository of Information Large Credits (CRILC) database: and/or (b) on its promoters/directors appear in Negative List, RBI Wilful Defaulter List (Suit filed as well as non-suit filed), Credit Information Bureau India Ltd. (CIBIL) Defaulter List and/or any other negative list of

central and/or state government agencies, updated from timeto-time. On being included in any of the above lists post the prequalification process (i.e. including during bidding process and/or Project implementation phase), the Applicant shall immediately inform Exim Bank on the inclusion and reasons thereof. This may lead to cancellation of prequalification / contract.

- 4.8 An Applicant shall furnish such evidence of eligibility satisfactory to the Bank, as the Bank shall reasonably request.

 - 5.2 Unless obtained directly from the Bank, the Bank shall not be responsible for the completeness of the document, responses to requests for clarification, or Addenda to the Application Document in accordance with ITA 7. In case of any discrepancies, documents issued directly by the Bank shall prevail.
 - 5.3 An Applicant is expected to study all instructions, and forms in the Application Document and to furnish with its Application all information or documentation as is required by the Application Document.
- 6. Clarifications
 6.1 A prospective Applicant requiring any clarification of the Application Document shall contact the Bank in writing at the Bank's address indicated in the DS. The Bank will respond in writing to any request for clarification provided that such request is received no later than fourteen (14) days prior to the deadline for submission of the applications. The Bank's response, at its discretion, may be put up on its website and shall include a description of the inquiry (without identifying its source) and corresponding clarification. As a result of a clarification the Bank may, if necessary, amend the Application Document in accordance with the provisions of ITA 7.
 - 6.2 Any modification to the Application Document that may become necessary as a result of the clarifications to the queries shall be made by the Bank exclusively through the use of a Corrigendum pursuant to ITA 7.
 - Ium of7.1At any time prior to the deadline for submission of Applications,
the Bank may amend the Application Document by issuing a
Corrigendum.
 - 7.2 Any Corrigendum or Addenda issued shall be deemed to be part of the Application Document and shall be published on the Bank's website.
