Profit (i.e. Profit Before Tax) for at least two (2) out of last five (5) financial years defined above; and c. Annual EPC Revenue³ in any one (1) of the last five (5) financial years as defined above be not less than;

(ii) The Applicant shall demonstrate that it has access to, or has available, liquid assets, lines of credit, and other financial means (independent of any contractual advance payment) sufficient to meet the project cash flow requirements of ongoing contracts including the present contract net of the Applicants other commitments. - a) reflect the financial situation of the Applicant or in case of JV for each member, and not an affiliated entity (such as parent company or group member).
- b) be independently audited and certified by the Statutory Auditors / Chartered Accountants in accordance with applicable legislation.
- c) be complete, including all notes to the financial statements.
- d) correspond to accounting periods already completed and audited.

Supporting documents issued by the Banks for additional financial means for likely future commitments to be attested by the respective banks. These documents shall be of latest available date and shall be valid beyond the last date of submission of the PQ Application.

- An applicant is allowed to be pre-qualified for multiple packages in the order of priority as specified by the applicant in its Application
- For pre-qualification under multiple packages, the specific experience/financial status etc. requirements shall <u>not</u> be aggregated.
- Pre-Qualification under multiple packages is allowed as per the priority list as per Form F submitted by the applicant.
- Govt. of Maldives has indicated that, at the time of bidding stage, a restriction would be placed on the number of packages a company can be awarded. Accordingly, the maximum number of packages that can be awarded to a company shall be based on the aggregation of the Financial/Specific Experience requirements at the time of award of tender.
- The priority list as per Form F may be utilized by Govt. of Maldives at the time of award of Tender.

- **2** Additionally, out of the experience mentioned under point no. 1 above, or separately, the applicant shall demonstrate experience of the following for each package. If an applicant applies for multiple packages, the minimum requirement as **under shall not be aggregated** for the number of packages applied for:
- a) Survey, geo-technical investigation, detail design, supply, installation, testing and commissioning of atleast 50 kms of underground water supply network having diameter not less than 100 mm and associated civil works.
- b) Survey, geo-technical investigation, detail design, supply, installation, testing and commissioning of atleast 15 kms of underground sewage network with diameter not less than 160 mm and associated manholes and other civil works.
- c) Design, Supply installation, testing and commissioning of at least one RO / Desalination Plant of capacity not less than 0.20 MLD or the applicant shall provide manufacturer authorization clearly mentioning that the manufacturer shall provide support for design, delivery, installation as well as also service support during the defect liability period/warranty period for the RO/Desalination Plant.
- d) Supply installation, testing and commissioning of Packaged Sewage Treatment Plant of capacity not less than 0.30 MLD, based on Sequencing Batch Reactor technology/Membrane Bio-Reactor/Moving Bed Bio-Film Reactor.

The Applicant shall submit the completion certificate as document of proof for completion of the similar nature of work and mention the date and cost of completion of the work listed in (a) to (d) above.

- 3. In case of JVCA, the requirement shall be met as below:
 - i) Eligibility in terms of the number of contracts under each option can be aggregated across the JVCA members
- ii) The contracts considered for meeting the criterion at (1) above shall each be of the min. value as mentioned under each option.
- iii) In addition to the above, each member of the JVCA shall have executed atleast one contract of min. value of 50% under Option I.
- iv) In respect of the past experience of JVCA Applicant for meeting the experience required at (2) above, each member shall meet atleast 1 (one) conditions out of the four(4) conditions, and all members shall meet 4 conditions together
- Subcontractors' experience and resumes, if any, submitted with the application will not be taken into account in determining the Applicant's compliance.
