## INVITATION FOR BIDS

- The People's Republic of Bangladesh has received for financing from the EXIM BANK of India toward the cost of Indian Line of Credit (LOC-2). Part of this financing will be used for payments under the contract named above. Bidding is open to Bidders from India only.
- The Power Grid Company of Bangladesh Limited (PGCB), ("the Employer") invites sealed bids from eligible bidders for the "Design, Supply, Installation, Testing & Commissioning of Jamuna River Crossing Portion of Bogura-Kaliakoir 400kV Double Circuit Transmission Line on Turnkey Basis (Package-01, Lot-03)." (herein after referred to as "the Works"). The Works under this turnkey contract shall have to be completed within 720 (Seven Hundred Twenty) days from the effective date.
- International Competitive Bidding (ICB)** will be conducted in accordance with Single-Stage: Two-Envelope bidding procedure and is open to all bidders from India.
- Bidders shall meet the following minimum requirements along with other requirements as mentioned in the bidding documents:
  - Experience under contracts in the role of prime contractor or management contractor in power sector for at least 10(ten) years prior to the bid submission deadline.
  - Participation as a contractor in at least three contracts with minimum contract value 32.0 million USD in each contract completed between 1<sup>st</sup> January 2010 and the Bid submission deadline and those are similar to the proposed contract. The scope of each contract must include supply, installation, testing & commissioning of single and/or double circuit 380kV or above voltage overhead transmission line on lattice steel towers.

For the above-mentioned or other similar contracts executed during the period mentioned above:

    - at least one (1) of the above contracts shall be of 380kV or higher voltage rating transmission line construction having at least 60km route length of single/double circuit line including Design, Supply, Installation, Testing & Commissioning.
    - at least one (1) contract shall be of 380kV or above voltage transmission line and being in successful operation for a minimum of three (03) years prior to the date of bid submission.
    - at least one (1) contract shall be of 380kV or above voltage transmission line construction and completed outside the Bidder's own country.
    - Completion of one contract (any nature) as contractor which includes stringing, erection and foundation of at least 5km 380kV or higher voltage transmission line including river crossing towers with span at least 800 meter in the last 10(ten) years prior to the Bid submission deadline. The height of each river crossing tower shall be 90m or more.
    - Experience in Key Activities: River Crossing Foundation  
Completion of at least two pile foundations with steel tube pile in the river bed having minimum pile length of 50 meter and minimum diameter of 1.5 meter. This experience may be complied by Specialist Subcontractor not limited to the transmission line towers only.

The Bidding Document may be sent through a courier for an additional fee of BDT 10,000.00 (local delivery) or USD 120.00 (International delivery) in the form of Pay Order/ Demand Draft in favor of Power Grid Company of Bangladesh Limited. No liability will be accepted for loss or late delivery of the Bidding Document.

- Technical bids will be opened at **11:05 Hours Local Time on June 24, 2021** at the head office of the Power Grid Company of Bangladesh Limited (PGCB), Avenue-03, Jahurul Islam City, Aftabnagar, Badda, Dhaka-1212, Bangladesh in the presence of Bidders' representatives who choose to attend, whereas the Financial Bids shall remain sealed and unopened and shall be placed locked. The Financial Bids of only Technically Responsive and Qualified Bidders shall be opened after Technical Bid Evaluation, whereas, the Financial Bids of those Bidders whose Technical Bids are not responsive and qualified shall be returned unopened after the contract is awarded.
- PGCB will not be responsible for any costs or expenses incurred by bidders in connection with the preparation or delivery of bids including costs and expenses related to participation in pre-bid meeting and site visit/s.
