These Lines of Credit (LOCs) are governed by the Guidelines issued by the GOI from time-to-time. Part I: Scope of EPC

The Export-Import Bank of India (Exim Bank or the Bank), on behalf of the Government of India (GOI) has approved financing of a project out of a Line of Credit extended to the Government of Myanmar for Yenwe and Kunn Chaung Irrigation Scheme ("the Project") for which Exim Bank now seeks applications for prequalification from eligible Indian entities. Refer Part II of ITA 4 for eligibility provisions.

A] Background and Major Components of the Project

The Government of the Republic of Myanmar intends to implement various potential irrigation projects in the country in a phased and time bound manner with the objective to improve the food productivity as well as greening the environment. The Ministry of Agriculture and Irrigation, Government of Myanmar, has initiated two projects viz. Kunn Chaung Irrigation System Project [LOT-I] and Yenwe Irrigation System Project [LOT –II] in the Republic of Myanmar. The Project includes all civil, structural, mechanical, electrical/electro-mechanical works complete as per the specifications and other terms and conditions of the PQ Document.

1. Scope of Work

The Scope of Work of the Contractor is to construct access road, Road Bridge, gated weir, head regulator and irrigation network of canals. Brief details of Lot 1 and Lot II are mentioned below:

LOT I:

The construction of ongoing Kunn Chaung Weir and Irrigation System is reckoned to be one of the potential irrigation projects, which is expected to increase agricultural crops production including food crops substantially.

Kunn Chaung Irrigation System is an on-going project of Government of Myanmar. Kunn Chaung Weir and Irrigation System is located in Phyu Township, Toungoo District, Bago Region. The project started in year 2011-12 and it is now proposed to take up the balance works for development of irrigable area of 35000 acre (14170 ha) below Kunn Chaung weir upto Sittaung River.

The main objectives of the Project are:

- To provide irrigation water for double cropping of rice and other upland crops during the dry season
- To mitigate flooding of Sittaung Plain
- To mitigate poverty of local people.

The Kunn Chaung Weir and Irrigation System comprises of the following components;

- Gated Weir
- Head Regulator for Main Canal
- Irrigation Networks of Canals

Status of Project Works

- 1. **Preparatory work** The work involves construction of access road, Road Bridge and other investigations. Access road has been completed to the extent of 74 % and bridge 100%.
- 2. Construction of gated Weir: 50 %
- 3. Construction of Head Regulator: 80 %
- 4. **Construction of Irrigation Network of Canals** The work is in initial stages only. The construction of the main canal has been taken up. Earth work of the main canal has been completed to the extent of 20%. The main canal along with left and right main canals is proposed to be lined with cast-in-situ cement concrete lining. At present, the concrete lining work in main canal has been completed in less than 1 km length only in the initial portion with pre cast cement block lining out of total 40.33 km length. Besides, two canal structures out of total 1750 no. have also been completed.

LOT II:

The construction of Yenwe Irrigation System which is one of the components of Yenwe Multipurpose Dam Project, is reckoned to be one of the potential irrigation projects which is expected to increase agricultural crops production including food crops substantially. Yenwe Multipurpose Dam Project is located in Kyauktagar Township, Bago District, Bago Region.

The main objectives of the Yenwe Multipurpose Dam Project are:

- i. To provide irrigation water for double cropping of rice and other upland crops during the dry season
- ii. To mitigate flooding of Yenwe creek
- iii. To generate hydropower for annual output of 125 million kilowatt Hours.

The construction of Yenwe Multipurpose Dam Project commenced in the Year 2000 -2001. The construction of dam, hydropower plant and spillway completed in 2006. The diversion tunnel had been completed even earlier i.e. in 2004. Though the construction of weirs of the dam was also completed in 2009, the irrigation network in the command area below the weir upto Sittaung River remained incomplete. Thus the major task for the development of irrigation in the Bago region needed immediate attention.

Yenwe Multipurpose Dam Project comprises of the following components:

Dam: The dam is located on Yenwe Creek which is one of the tributaries of Sittaung River. The project comprises of a water impounding earthen dam of 1050ft (320m) length and 251ft (76.5m) height across the Yenwe Creek and has a catchment area of 306 sq miles (793 sq km). It has a gross and live storage capacity of 931800 Acft (1150 Mcum) and 896900 Acft (1107 Mcum) respectively with dead storage capacity being 34900 Acft (43 Mcum). The storage capacity of Yenwe dam is adequate to supply irrigation water to 62000 acres (25090 ha) of cultivable land for double cropping of rice and other crops in Yenwe command area.

Spillway: The type of spillway provided is RCC ogee shaped spillways. Two spillways of 416 ft (126.8m) and 485ft (147.8m) lengths are provided to cater to a design discharge of 8000 cusec (226 Cumec).

Hydropower: Other than irrigation, there is also hydropower plant with installed capacity of 2x12.5 MW and annual power output of 125 MKWH. Length of diversion tunnel for hydropower is 1634 ft (498m).

Weir: RCC weir of ogee type of 99ft length (30.2m) and 17.5 ft (5.3m) height having 5 nos. of radial gates of size 10' x 15' (3mx4.6m). The weir is located 10 Mile (16 Km) below the dam.

Canal Irrigation Network: Two Main Canals, one on left bank of length 2.58 mile (4.23 km) and the other on right bank of length 5.36 mile (8.78 km) are off-taking from weir. The Irrigation network on both the banks comprises of 3 branch canals of length 19.89 mile (32.61 km) all on LMC, 9 Nos. of distributaries of length 70.79 mile (116.05 km) and 152 number of minors of length 193.11 miles (316.58 km) off-taking from the distributaries.

Part II. Instructions to Applicants

A. General

1. Background

1.1 The Export-Import Bank of India (hereinafter called "the Bank"), on behalf of the Government of India (GOI), extends from time-to-time, concessional credit facilities (hereinafter called "Lines of Credit") under the Indian Development and Economic Assistance Scheme (IDEAS) to overseas governments or their nominated agencies (hereinafter called "Borrower or Employer"), for financing projects to be executed by Indian entities. Payment by the Bank to the Indian exporters will be made only at the request of the Borrower and upon approval by the Bank, and will be subject, in all respects, to the terms and conditions of the credit (or financing) agreement.

2. Scope of Prequalification

2.1 With reference to the Invitation for Prequalification (IFP) indicated in Part III, Data Sheet (**DS**), this Application Document ("Application Document") is being issued by the Bank to prospective applicants ("Applicants") interested in submitting applications ("Applications") for prequalification as per the scope described in Part I, Scope of EPC and subject to the provisions of this Application Document.

3. Ethics and Integrity

- 3.1 The Bank requires Applicants to participate in this prequalification process with the highest standards of ethics and integrity. It is strictly forbidden to the parties involved in the prequalification process, by themselves or by a third party, to offer, ask or accept for itself or for a third party, financial or non-financial advantage or even direct or indirect promise or any other acts¹, as offsets for prequalification or bidding or contract award and execution as applicable, if susceptible of being qualified as criminal unlawful acts in accordance with national laws of any party involved.
- 3.2 In pursuance of ITA 3.1 above, Applicants shall permit the Bank to inspect all accounts, records and other documents relating to the submission of the Application, bid submission (in case prequalified), and contract performance (in the case of award), and to have them audited by auditors appointed by the Bank.
- 3.3 If, in accordance with the administrative procedures of the Bank, it is demonstrated that an Applicant in this prequalification process, or during the subsequent bidding for the contract(s) has violated the provisions stated in ITA 3.1 above, the Bank, inter alia,
 - a. shall reject any Application for prequalification or proposal to award a contract in connection with the subsequent procurement process, as applicable; and/or
 - may declare an Applicant, temporarily or permanently, ineligible to be awarded future contracts under Bank funding.

¹ These acts shall include, but not limited to, corrupt practice, fraudulent practice, collusive practice, coercive practice, obstructive practice, and conflict of interest.

4. Eligibility of Applicants

- 4.1 This prequalification exercise is open to only Indian Applicants in accordance with the provisions of ITA 4.4. Any form of association by the Applicant with ineligible entities either during this prequalification process or subsequent bidding process may be liable for rejection.
- 4.2 For the purpose of applying the eligibility criteria listed in this article 4, "Applicant" would include the single entity or in case of a joint venture ("JV"), each member of the JV, involved or intended to be involved with this prequalification process (as mentioned in Form A.1.2 Applicant's JV Member's Information Form), for any part of the prospective contract(s) including related services.
- 4.3 An Applicant may be a single entity or a combination of entities in the form of a JV either existing or with the intent to enter into a JV supported by a letter of intent or JV Agreement listing out the names of all the JV members. In the case of a JV, all members shall be jointly and severally liable for the execution of the contract(s) in accordance with the respective contract terms. The JV shall be represented by an authorized representative who shall have the authority from all members of the JV to conduct all business for and on behalf of the JV during the prequalification process. The limit on the number of members in a JV would be as specified in the **DS**.
- 4.4 This prequalification exercise is open to only Indian Applicants. An Applicant shall be deemed to be Indian if the Applicant is constituted, incorporated or registered, and operates in accordance with the provisions of the laws of India, as evidenced by its articles of incorporation and its registration documents, as the case may be.
- 4.5 An Applicant that has been blacklisted/ debarred/ suspended/ sanctioned by any Multilateral Development Agency (MDA) or any authority in India or the borrowing country in accordance with extant rules and procedures, shall be ineligible to participate in the prequalification/ bidding process as applicable, during such period of time as the sanctioning authority shall have determined. In case the Applicant is blacklisted/ debarred/suspended/ sanctioned post the prequalification process (i.e. including during bidding process and Project implementation phase), the Applicant shall immediately inform Exim Bank of such blacklisting/ debarment/ suspension/ sanction and/or reasons thereof. This may lead to cancellation of prequalification / contract.
- 4.6 The list of debarred firms and individuals by certain leading MDAs is available as specified in the **DS**. This may not be an exhaustive list of debarred entities but those which are made available centrally on the respective MDA's website. Additionally, there could be lists of debarred entities issued by various government departments/ procuring entities/ corporations and maintained offline.
- 4.7 An Applicant shall be ineligible to be prequalified if (a) it is currently under default on any loan to any Bank/ Financial Institution (FI) and its

account has been classified as Non-Performing Asset (NPA) as per Central Repository of Information on Large Credits (CRILC) database; and/or (b) its promoters/ directors appear in Negative List, RBI Wilful Defaulter List (Suit filed as well as non-suit filed), Credit Information Bureau India Ltd. (CIBIL) Defaulter List and/or any other negative list of central and/or state government agencies, updated from time-to-time. On being included in any of the above lists post the prequalification process (i.e. including during bidding process and/or Project implementation phase), the Applicant shall immediately inform Exim Bank on the inclusion and reasons thereof. This may lead to cancellation of prequalification / contract.

4.8 An Applicant shall furnish such evidence of eligibility satisfactory to the Bank, as the Bank shall reasonably request.

5. Contents of this Document

5.1 This Application Document consists of the Parts indicated below, and which should be read in conjunction with any Corrigendum issued in accordance with ITA 7.

- 5.2 Unless obtained directly from the Bank, the Bank shall not be responsible for the completeness of the document, responses to requests for clarification, or Addenda to the Application Document in accordance with ITA 7. In case of any discrepancies, documents issued directly by the Bank shall prevail.
- 5.3 An Applicant is expected to study all instructions, and forms in the Application Document and to furnish with its Application all information or documentation as is required by the Application Document.

6. Clarifications

- 6.1 A prospective Applicant requiring any clarification of the Application Document shall contact the Bank in writing at the Bank's address indicated in the **DS**. The Bank will respond in writing to any request for clarification provided that such request is received no later than fourteen (14) days prior to the deadline, or any extension thereof for submission of the applications. The Bank's response, at its discretion, may be put up on its website and shall include a description of the inquiry (without identifying its source) and corresponding clarification. As a result of a clarification the Bank may, if necessary, amend the Application Document in accordance with the provisions of ITA 7.
- 6.2 Any modification to the Application Document that may become necessary as a result of the clarifications to the queries shall be made by the Bank exclusively through the use of a Corrigendum pursuant to ITA 7

7. Corrigendum of Application Document

- 7.1 At any time prior to the deadline for submission of Applications, the Bank may amend the Application Document by issuing a Corrigendum.
- 7.2 Any Corrigendum or Addenda issued shall be deemed to be part of the Application Document and shall be published on the Bank's website.
- 7.3 Post Corrigendum, in order to allow sufficient time to the prospective Applicants in preparing their Applications, or for other good reason, the Bank may, at its discretion, extend the deadline for the submission of Applications in accordance with ITA 16.2.

C. Preparation, Submission and Opening of Applications

8. Cost towards Application

8.1 The Applicant shall bear all costs associated with the preparation and submission of its Application. The Bank will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the pregualification process.

9. Language

9.1 The Application documentation and printed literature that are part of the Application, if in another language, shall be accompanied by an accurate translation of the relevant passages in English language, which shall be the governing language.

10. Documents constituting the Application

- 10.1 The Application shall comprise the following:
 - (a) Application Submission Form, in accordance with ITA 11.1;
 - (b) documentary evidence establishing the Applicant's eligibility, in accordance with ITA 12.1;
 - (c) documentary evidence establishing the Applicant's qualifications, in accordance with ITA 13; and
 - (d) any other document required as specified in the **DS**.

11. Application Submission Form

- 11.1 The Applicant shall complete an Application Submission Form as provided in Part V (Forms). This Form must be completed without any alteration to its format.
