A part of the LOC shall be utilised for Construction of Forensic Science Laboratory in Mauritius for which Exim Bank now seeks applications for prequalification from eligible Indian entities. Refer Part II ITA 4 for eligibility provisions.

Introduction:

The Government of the Republic of Mauritius has appointed an Indian Project Management Consulting firm NBCC (India) Ltd. for the construction of FORENSIC SCIENCE LABORATORY.

The Consultant has worked in close collaboration with PMT (project monitoring team) and thereby advise the FSL (Forensic Science Laboratory) on each and every aspect of the project in accordance with an agreement that is signed by both parties. Certifications made on documents and drawings by the Consultant will be endorsed by the Employer's Engineer.

Forensic Science laboratory has been proposed by the Government of Mauritius in order to cater to the growing demand for the facilities & workspace within the existing facility of the Forensic Science Laboratory. So as not to restrict the development of the Laboratory, the Government of Mauritius intends to construct a Modern State of the Art - Forensic Science Laboratory that meets building codes and International accreditation.

Major Components of the project: The project shall comprise of the following:

- An Administration Section
- Forensic Science Laboratories (Biology, Chemistry, Toxicology, Human and Non-Human, Physical and Ballistics, Document, DNA)
- Procurement Section
- Police Post
- Shooting Range
- > Vehicle examination section
- > All other ancillary services
- > Parking facilities with secured parking for staff and senior personnel.
- Training and Crime Scene House

The building is designed with flexibility to support adaptability and change. The area of the proposed Scientific Laboratories and administrative section will be approximately 6000 m2.

Site & Proposed Design:

The proposed Forensic Science Laboratory Site is conveniently accessed from the main road and visible from the main Highway. It is currently devoid of any large trees and is slightly contoured. The building will be built on a plot of 10,921 m2 that has been earmarked for the project at La Vigie, Curepipe, and Republic of Mauritius.

The land is completely covered with bushes and vegetation. The site carries a downwards slope towards the South East. There are trees and a natural drain running along one edge on the South East side. The Entry to the site is an unpaved road, which will be upgraded during construction.

All the major components of the project have been placed in such a way that they are complementing each other and at the same time are segregated to symbolize the different nature & typology of the functions. All the facilities are proposed to be equipped with all the modern & latest equipment /technology so that the complex can be developed as a world class facility. An integrated & seamless vehicular circulation plan has been proposed to efficiently cater to the users within the complex. Traffic plan has been emphasized on providing a conflict free movement of private, VIP, services, security, fire and ambulance vehicles. The entire complex has been designed to provide a barrier free movement to its users.

Provision of parking at Surface level parking has been considered to meet the project requirement. 90 car parks along with 2 emergency vehicles have been considered in the parking design.

Location Description:

Mauritius officially the Republic of Mauritius is an island nation in the Indian Ocean. The main Island of Mauritius is located about 2,000 kilometers (1,200 mi) off the southeast coast of the African continent. The Republic of Mauritius also includes

the islands of Rodrigues, Agalega and St. Brandon. The capital and largest city Port Louis is located on the main island of Mauritius.

Mauritius is known for its beaches, lagoons and reefs. The mountainous interior includes Black River Gorges National Park, with rainforests, waterfalls, hiking trails and wildlife like the flying fox. Capital Port Louis has sites such as the Champs de Mars horse track, Eureka plantation house and 18th-century Sir Seewoosagur Ramgoolam Botanical Gardens.

Plaines Wilhems - Site Location

The site is conveniently located on the edge of 2 districts, Plaines Wilhems and Moka. Plaines Wilhems is the most populous district, with its population estimated at 368,621 as of 31 December 2015. The district is mainly urban; it consists of four towns, the village of Midlands and part of two other villages. The Plaines Wilhems district does not have a District Council; it has four Municipal Town Councils.

The people of Mauritius are multiethnic, multicultural and multilingual. Mauritius is highly ranked for democracy and for economic and political freedom. The Human Development Index of Mauritius is one of the highest in Africa. Mauritius is ranked as the most competitive and one of the most developed economies in the African region.

Mauritius is a welfare state; the government provides free universal health care, free education up to tertiary level and free public transport for students, senior citizens, and the disabled.

Being one of the most proficient institutions under an astute and dynamic leadership, it has gained recognition not just in the country but in the African subcontinent as well.

Project Vision And Objective:

Established in the 1950's, the Forensic Science Laboratory is an autonomous body under the aegis of the Prime Minister's Office, Home Affairs Division.

The Forensic Science Laboratory is the sole provider of forensic and advisory service to law enforcement agencies in Mauritius and is fast becoming an increasingly prominent forensic service player provider in the region.

The Forensic Science Laboratory is committed to providing a quality forensic and advisory service that meets the challenges presented by changing customer needs and emerging technologies.

The Forensic Science Laboratory which is accredited by The Mauritius Accreditation Service (MAURITAS) and meets all requirements of ISO/IEC 17025:2005 demonstrating technical competence and operation of a laboratory Quality Management System (QMS).

Scope of Contractor:

- Construction of a Modern State of the Art Forensic Science Laboratory that meets building codes and International accreditation. State land of a size of 10,921 Sq. mtr. at La Vigie, Curepipe, has been made available to the FSL for the construction of a new building cum laboratories with the required Furniture. The FSL building, having Lower Ground Floor + Ground Floor + 4 floors, is designed with flexibility to support adaptability and change. The total built-up area of the Scientific Laboratories and administrative section will be approximately 10,309 Sqm including required MEP works for the building as per BOQ, Drawings, technical specification and others specified in the tender documents.
- The scope of work covered in this tender shall be as per the Bill of Quantities, specifications, drawings, instructions, orders issued to the contractor from time to time during the pendency of work. The drawings for this work, which may be referred for tendering, provide general idea only about the work to be performed under the scope of this contract. These may not be the final drawings and may not indicate the full range of the work under the scope of this contract. The work will be executed according to the drawings to be released as "GOOD FOR CONSTRUCTION" from time to time by the Engineer-in-charge of NBCC (India) Limited and according to any additions/ modifications/ alterations/ deletions made from time to time, as required by any other drawings that would be issued to the contractor progressively during execution of work. It shall be the responsibility of the contractor to incorporate the changes that may be in this scope of work, envisaged at the time of tendering and as actually required to be executed.


B] Contract execution period

Part II. Instructions to Applicants

A. General

1. Background

1.1 The Export-Import Bank of India (hereinafter called "the Bank"), on behalf of the Government of India (GOI), extends from time-to-time, concessional credit facilities (hereinafter called "Lines of Credit") under the Indian Development and Economic Assistance Scheme (IDEAS) to overseas governments or their nominated agencies (hereinafter called "Borrower or Employer"), for financing projects to be executed by Indian entities. Payment by the Bank to the Indian exporters will be made only at the request of the Borrower and upon approval by the Bank, and will be subject, in all respects, to the terms and conditions of the credit (or financing) agreement.

2. Scope of Prequalification

2.1 With reference to the Invitation for Prequalification (IFP) indicated in Part III, Data Sheet (**DS**), this Application Document ("Application Document") is being issued by the Bank to prospective applicants ("Applicants") interested in submitting applications ("Applications") for prequalification as per the scope described in Part I, Scope of Construction Contract and subject to the provisions of this Application Document.

3. Ethics and Integrity

3.1 The Bank requires Applicants to participate in this prequalification process with the highest standards of ethics and integrity. It is strictly forbidden to the parties involved in the prequalification process, by themselves or by a third party, to offer, ask or accept for itself or for a third party, financial or non-financial advantage or even direct or indirect promise or any other acts¹, as offsets for prequalification or bidding or contract award and execution as applicable, if susceptible of being qualified as criminal unlawful acts in accordance with national laws of any party involved.

- 3.2 In pursuance of ITA 3.1 above, Applicants shall permit the Bank to inspect all accounts, records and other documents relating to the submission of the Application, bid submission (in case prequalified), and contract performance (in the case of award), and to have them audited by auditors appointed by the Bank.
- 3.3 If, in accordance with the administrative procedures of the Bank, it is demonstrated that an Applicant in this prequalification process, or during the subsequent bidding for the contract(s) has violated the provisions stated in ITA 3.1 above, the Bank, inter alia,
 - a. shall reject any Application for prequalification or

- proposal to award a contract in connection with the subsequent procurement process, as applicable; and/or
- b. may declare an Applicant, temporarily or permanently, ineligible to be awarded future contracts under Bank funding.

4. Eligibility of Applicants

- 4.1 This prequalification exercise is open to only Indian Applicants in accordance with the provisions of ITA 4.4. Any form of association by the Applicant with ineligible entities either during this prequalification process or subsequent bidding process may be liable for rejection.
- 4.2 For the purpose of applying the eligibility criteria listed in this article 4, "Applicant" would include the single entity or in case of a joint venture ("JV"), each member of the JV, involved or intended to be involved with this prequalification process (as mentioned in Form A.1.2 Applicant's JV Member's Information Form), for any part of the prospective contract(s) including related services.
- 4.3 An Applicant may be a single entity or a combination of entities in the form of a JV either existing or with the intent to enter into a JV supported by a letter of intent or JV Agreement listing out the names of all the JV members. In the case of a JV, all members shall be jointly and severally liable for the execution of the subsequent contract(s) in accordance with the respective contract terms. The JV shall be represented by an authorized representative who shall have the authority from all members of the JV so as to conduct all business for and on behalf of the JV during the prequalification process. The limit on the number of members in a JV would be as specified in the **DS**.
- 4.4 This prequalification exercise is open to only Indian Applicants. An Applicant shall be deemed to be Indian if the Applicant is constituted, incorporated or registered in, and operates in accordance with the provisions of the laws of India, as evidenced by its articles of incorporation and its registration documents, as the case may be.
- 4.5 An Applicant that has been blacklisted/ debarred/ sanctioned by any Multilateral Development Agency (MDA) or any authority in India or the borrowing country in accordance with extant rules and procedures, shall be ineligible to participate in the prequalification/ bidding process as applicable, during such period of time as the sanctioning authority shall have determined. In case the Applicant is blacklisted/ debarred/sanctioned, post the prequalification process (i.e. including during bidding process and/or contract implementation phase), the Applicant shall immediately inform Exim Bank of such blacklisting/ debarment/sanction and reasons thereof. This

may lead to cancellation of Applicant's prequalification / contract.

- 4.6 The list of debarred firms and individuals by certain leading MDAs is available as specified in the **DS**. This may not be an exhaustive list of debarred entities but those which are made available centrally on the respective MDA's website. Additionally, there could be lists of debarred entities issued by various government departments/ procuring entities/ corporations and maintained offline.
- An Applicant shall be ineligible to be pregualified if (a) it is currently under default on any loan to any Bank/ Financial Institution (FI) and its account has been classified as Non-Performing Asset (NPA) as per Central Repository of Information on Large Credits (CRILC) database; and/or (b) its promoters/ directors appear in Negative List, RBI Wilful Defaulter List (Suit filed as well as non-suit filed), Credit Information Bureau India Ltd. (CIBIL) Defaulter List and/or any other negative list of central and/or state government agencies, updated from time-to-time. On being included in any of the above lists post the prequalification process (i.e. including during bidding process and/or contract implementation phase), the Applicant shall immediately inform Exim Bank on the inclusion and reasons for inclusion thereof. This may lead to cancellation of Applicant's pregualification / contract.
- 4.8 An Applicant shall (i) be eligible with respect to the provisions of Public Procurement Orders No. 1 & 2 dated July 23, 2020 and Public Procurement Order No. 3 dated July 24, 2020 issued by Department of Expenditure, Ministry of Finance, Government of India; and (ii) furnish such evidence of eligibility satisfactory to the Bank, as the Bank shall reasonably request.
- B. Composition of the Application Document
- 5. Contents of this Document
- 5.1 This Application Document consists of the Parts indicated below, and which should be read in conjunction with any Corrigendum issued in accordance with ITA 7.
 - Part I. Scope of Construction Contract
 - Part II. Instructions to Applicants (ITA)
 - Part III. Data Sheet (DS) to ITA
 - Part IV. Pregualification Criteria and Requirements
 - Part V. Forms
 - Part VI. Questionnaire for Applicants
- 5.2 Unless obtained directly from the Bank, the Bank shall not be responsible for the completeness of the document,

responses to requests for clarification, or Addenda to the Application Document in accordance with ITA 7. In case of any discrepancies, documents issued directly by the Bank shall prevail.

5.3 An Applicant is expected to study all instructions, and forms in the Application Document and to furnish with its Application all information or documentation as is required by the Application Document.

6. Clarifications

- 6.1 A prospective Applicant requiring any clarification of the Application Document shall contact the Bank in writing at the Bank's address indicated in the **DS**. The Bank will respond in writing to any request for clarification provided that such request is received no later than fourteen (14) days prior to the deadline, or any extension thereof, for submission of the applications. The Bank's response, at its discretion, may be put up on its website and shall include a description of the inquiry (without identifying its source) and corresponding clarification. As a result of a clarification the Bank may, if necessary, amend the Application Document in accordance with the provisions of ITA 7.
- 6.2 Any modification to the Application Document that may become necessary as a result of the clarifications to the queries shall be made by the Bank exclusively through the use of a Corrigendum pursuant to ITA 7.

7. Corrigendum of Application Document

- 7.1 At any time prior to the deadline for submission of Applications, the Bank may amend the Application Document by issuing a Corrigendum.
- 7.2 Any Corrigendum or Addenda issued shall be deemed to be part of the Application Document and shall be published on the Bank's website.
- 7.3 Post Corrigendum, in order to allow sufficient time to the prospective Applicants in preparing their Applications, or for other good reason, the Bank may, at its discretion, extend the deadline for the submission of Applications in accordance with ITA 16.2.

C. Preparation, Submission and Opening of Applications

8. Cost towards Application

8.1 The Applicant shall bear all costs associated with the preparation and submission of its Application. The Bank will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the pregualification process.

9. Language

9.1 The Application documentation and printed literature that are part of the Application, if in another language, shall be accompanied by an accurate translation of the relevant passages in English language, which shall be the governing

language.

10. Documents constituting the Application

- 10.1 The Application shall comprise the following:
 - (a) Application Submission Form, in accordance with ITA 11.1;
 - (b) documentary evidence establishing the Applicant's eligibility, in accordance with ITA 12.1;
 - (c) documentary evidence establishing the Applicant's qualifications, in accordance with ITA 13; and
 - (d) any other document required as specified in the **DS**.

11. Application Submission Form

- 11.1 The Applicant shall complete an Application Submission Form as provided in Part V (Forms). This Form must be completed without any alteration to its format.
- 12. Documents

- 12.1 To establish its eligibility in accordance with ITA 4, the Applicant shall complete the eligibility declarations in the Application Submission Form and Forms A.1.1 and A.1.2, included in Part V (Forms).

13. Documents Evidencing the Applicant's Oualifications

- 13.1 To establish its qualifications in accordance with Part IV, Pregualification Criteria and Requirements, the Applicant shall provide the information requested in corresponding Forms included in Part V without any alteration to the format. Applicant shall also complete the Questionnaire included in Part VI without any alteration to the questions. Each Form included in Part V and the Questionnaire in Part VI shall be duly signed by the authorized representative of the Applicant. In case of JV, authorized representative of the respective member shall sign. Non- compliance with this clause may result in summary rejection of the Application.
- 13.2 If an Applicant does not manufacture or produce the goods it offers to supply, it shall submit documentation related to Manufacturer's Authorisation as specified in the **DS**.
- 13.3 Wherever a monetary amount is to be stated, Applicant should indicate the USD equivalent using the rate of exchange determined as follows:
 - (a) Exchange rates shall be taken from the publicly available source identified in the **DS**. Any error in determining the exchange rates in the Application may be corrected by the Bank during evaluation;
 - (b) For data related to financial statements, the amounts shall be mentioned in Indian Rupees (INR). Equivalent amount in USD shall be arrived at using the exchange rate as on 31st March of respective financial year as specified in the **DS**;

- (c) for data related to Liquidity, Annual Residual Contract Value and contracts signed in the current financial year, unless otherwise specified in the **DS**, the exchange rate prevalent as on the working day preceding the date of Invitation for Prequalification (IFP) shall be used to arrive at the USD equivalent as specified in the **DS**; and
- (d) for contracts signed prior to the current financial year, the exchange rate as on 31st March of the respective financial year in which the contract was signed shall be used to arrive at the USD equivalent as specified in the DS.
- 14. Authorized
 Signatory and
 Number of

- 14.1 The Applicant shall prepare one original of the documents comprising the Application as described in ITA 10 and clearly mark it "ORIGINAL". The original of the Application shall be typed or written in indelible ink and shall be signed by a person duly authorized to sign on behalf of the Applicant. In case the Applicant is a JV, the Application shall be signed by all members of the JV.
- 15. Preparing the Application Envelope
- 15.1 The Applicant shall enclose the original Application in a sealed envelope that shall:
