A] Background and Major Components of the Project:

Introduction:

The Government of the Republic of Mauritius has appointed an Indian Project Management Consulting firm NBCC (India) Ltd for the construction of National Archives & National Library Building.

The Consultant has worked in close collaboration with the PMT (Project Management Team) appointed by the Ministry of Arts and Cultural Heritage (MACH) and thereby advise MACH on each and every aspect of the project in accordance with an agreement that is signed by both parties. Certifications made on documents and drawings by the Consultant shall be endorsed by the PMT's Engineer.

The construction of the National Archives & National Library Building is a Government Project implemented by MACH.

The main objectives of the National Archives Department include the preservation of the collective memory of the nation and promotion of its awareness for the purpose of research; the production and publication of documentary materials for educational purposes and for the public at large; control of public archives lying in other repositories and tender advice on the ways they should be preserved; and the release, after a given period, official records for public research.

The National Library acts as the National Bibliographic Centre of the Republic. Its main role is to build a comprehensive collection of the national heritage by collecting, receiving and preserving all library materials, publications and productions printed and produced in Mauritius, required to be deposited in the library, and offers library and information services to the nation, and make these library materials available to the public for reference.

MACH has as mission to foster a balanced and harmonious Mauritian Society through consolidation of existing pluralism, cultural heritage and cultural values while promoting the creative industry.

The project comprises the construction of a new state of art building of international standard to house two key institutions of the Republic of Mauritius, namely the National Archives Department and the National Library, which operate under the aegis of the Ministry of Arts and Cultural Heritage. The proposed National Archives & National Library Building is being constructed on a plot of land of about 3.12 acres (approx.) at the Réduit Triangle, Moka, Mauritius. The building will be in accordance with international Archival and Library standards and will be of a total built-up area of around to 8,108 m². The building will comprise Ground plus 3 floors including associated infrastructure work like Roads, Water Supply, Sewerage, Drains, and other public utilities with required MEP works etc. for the building as per BOQ, Drawings, technical specification and others specified in the tender documents.

Site & Proposed Design:

Site for the Construction of National Archives & National Library Building is conveniently accessed from the main road and it is nearby Wellkin Hospital (formerly known as Apollo Bramwell Hospital) at Reduit Triangle, Moka which is visible from the main Highway. It is currently devoid of any large trees and is slightly contoured. The land is completely covered with bushes and vegetation. The proposed National Archives & National Library Building will be built on a plot of land of 3.12 acres (approx.) that has been earmarked for the project.

All the major components of the project have been placed in such a way that they are complementing each other and at the same time are segregated to symbolize the different nature & typology of the functions. All the facilities are proposed to be equipped with all the modern & latest equipment /technology so that the complex can be developed as a world class facility. An integrated & seamless vehicular circulation plan has been proposed to efficiently cater to the users within the complex. Traffic plan has been emphasized on providing a conflict free movement of private, VIP, services, security, fire and ambulance vehicles. The entire complex has been designed to provide a barrier free movement to its users.

Surface level parking has been considered to meet the project requirement. 36 car parks have been considered in the parking design.

Location Description: The Republic of Mauritius is an island in the Indian Ocean and is located about 2,000 kilometers (1,200 mi) off the southeast coast of the African continent. The Republic of Mauritius also includes the islands of Rodrigues, Agalega and St. Brandon. The capital is Port Louis.

Mauritius is known for its beaches, lagoons and reefs. The mountainous interior includes Black River Gorges National Park, with rainforests, waterfalls, hiking trails and wildlife.

Moka – The Site Location: The site is located in the Moka district. Moka is situated in the central plateau of the island. The district has an area of 234.4 km2 and the population estimate was at 83,672 as of 01 July 2019.

It is administered by the Moka District Council. The elevation is around 203 meters and can be up to 425 meters (apprx.) in some places. Moka is directly on the other side of the Moka Mountain Range from Port Louis. The village is close to the mountain Le Pouce and the town of Beau-Bassin and Rose-Hill.

The people of Mauritius are multiethnic, multicultural and multilingual. Mauritius is highly ranked for democracy and for economic and political freedom. The Human Development Index of Mauritius is one of the highest in Africa. Mauritius is ranked as the most competitive and one of the most developed economies in the African region.

The main pillars of the Mauritian economy are manufacturing, financial services, tourism, and information and communications technology. Mauritius is a welfare state; the government provides free universal health care, free education up to tertiary level and free public transport for students, senior citizens, and the disabled.

Project Vision and Objective:

The project comprises the construction of a purpose-built complex of international standard to house the National Archives Department and the National Library. The objective of this project described above, is as follows:-

- I. To ensure the safeguard and preservation of archival records;
- II. To enable the National Archives Department and the National Library to fulfill their historical and cultural roles, that is, to collect, preserve, make accessible the collective memory of the country, for the benefit of the present and future generations, and for research purposes; and
- III. To ensure effective coordination and efficient use of resources by accommodating the two institutions in a single building with common facilities.

Scope of Work:

- Construction of a new complex of international standard to house two key institutions of the Republic of Mauritius, namely the National Archives Department and the National Library. The complex should be in accordance with international Archival and Library standards. The building will be of a plinth area of around to 8,108 m² and will comprise ground plus 3 floors including required MEP works for the building as per BOQ, Drawings, technical specification and others specified in the tender documents.
- The scope of works covered in this tender shall be as per the Bill of Quantities, specifications, drawings, instructions, orders issued to the contractor from time to time during the pendency of work. The drawings for this work, which may be referred for tendering, provide general idea only about the work to be performed

under the scope of this contract. These may not be the final drawings and may not indicate the full range of the work under the scope of this contract. The work will be executed according to the drawings to be released as **"GOOD FOR CONSTRUCTION"** from time to time by the Engineer-in-charge of NBCC (India) Limited and according to any additions/ modifications/ alterations/ deletions made from time to time, as required by any other drawings that would be issued to the contractor progressively during execution of work. It shall be the responsibility of the contractor to incorporate the changes that may be in this scope of works, envisaged at the time of tendering and as actually required to be executed.


The quantities of various items as entered in the "BILL OF QUANTITIES" are indicative only and may vary depending upon the actual requirements. The contractor shall be bound to carry out and complete the stipulated works irrespective of the variation in individual items specified in the bill of quantities. The variation of quantities will be governed as per relevant clause of contract.

B] Contract execution period

The duration of the contract is expected to be **24 (Twenty Four)** months and the maintenance period shall be 12 (twelve) months after completion of works.

Part II. Instructions to Applicants

A. General

- 1. Background 1.1 The Export-Import Bank of India (hereinafter called "the Bank"), on behalf of the Government of India (GOI), extends from time-to-time, concessional credit facilities (hereinafter called "Lines of Credit") under the Indian Development and Economic Assistance Scheme (IDEAS) to overseas governments or their nominated agencies (hereinafter called "Borrower or Employer"), for financing projects to be executed by Indian entities. Payment by the Bank to the Indian exporters will be made only at the request of the Borrower and upon approval by the Bank, and will be subject, in all respects, to the terms and conditions of the credit (or financing) agreement.
- 2. Scope of Prequalification
 2.1 With reference to the Invitation for Prequalification (IFP) indicated in Part III, Data Sheet (DS), this Application Document ("Application Document") is being issued by the Bank to prospective applicants ("Applicants") interested in submitting applications ("Applications") for prequalification as per the scope described in Part I, Scope of the Construction Contract and subject to the provisions of this Application Document.
- 3. Ethics and Integrity
 3.1 The Bank requires Applicants to participate in this prequalification process with the highest standards of ethics and integrity. It is strictly forbidden to the parties involved in the prequalification process, by themselves or by a third party, to offer, ask or accept for itself or for a third party, financial or non-financial advantage or even direct or indirect promise or any other acts¹, as offsets for prequalification or bidding or contract award and execution as applicable, if susceptible of being qualified as criminal unlawful acts in accordance with national laws of any party involved.
 - 3.2 In pursuance of ITA 3.1 above, Applicants shall permit the Bank to inspect all accounts, records and other documents relating to the submission of the Application, bid submission (in case prequalified), and contract performance (in the case of award), and to have them audited by auditors appointed by the Bank.
 - 3.3 If, in accordance with the administrative procedures of the Bank, it is demonstrated that an Applicant in this prequalification process, or during the subsequent bidding

for the contract(s) has violated the provisions stated in ITA 3.1 above, the Bank, inter alia,

- a. shall reject any Application for prequalification or proposal to award a contract in connection with the subsequent procurement process, as applicable; and/or
- b. may declare an Applicant, temporarily or permanently, ineligible to be awarded future contracts under Bank funding.
- 4.1 This prequalification exercise is open to only Indian Applicants in accordance with the provisions of ITA 4.4. Any form of association by the Applicant with ineligible entities either during this prequalification process or subsequent bidding process may be liable for rejection.
 - 4.2 For the purpose of applying the eligibility criteria listed in this article 4, "Applicant" would include the single entity or in case of a joint venture ("JV"), each member of the JV, involved or intended to be involved with this prequalification process (as mentioned in Form A.1.2 Applicant's JV Member's Information Form), for any part of the prospective contract(s) including related services.
 - 4.3 An Applicant may be a single entity or a combination of entities in the form of a JV either existing or with the intent to enter into a JV supported by a letter of intent or JV Agreement listing out the names of all the JV members. In the case of a JV, all members shall be jointly and severally liable for the execution of the subsequent contract(s) in accordance with the respective contract terms. The JV shall be represented by an authorized representative who shall have the authority from all members of the JV so as to conduct all business for and on behalf of the JV during the prequalification process. The limit on the number of members in a JV would be as specified in the DS.
 - 4.4 This prequalification exercise is open to only Indian Applicants. An Applicant shall be deemed to be Indian if the Applicant is constituted, incorporated or registered in, and operates in accordance with the provisions of the laws of India, as evidenced by its articles of incorporation and its registration documents, as the case may be.
 - 4.5 An Applicant that has been blacklisted/ debarred/ sanctioned/ suspended by any Multilateral Development Agency (MDA) or any authority in India or the borrowing country in accordance with extant rules and procedures, shall be ineligible to participate in the prequalification/ bidding process as applicable, during such period of time as the sanctioning authority shall have determined. In case the Applicant is blacklisted/ debarred/sanctioned post the prequalification process (i.e. including during bidding

4. Eligibility of Applicants process and/or contract implementation phase), the Applicant shall immediately inform Exim Bank of such blacklisting/ debarment/sanction and reasons thereof. This may lead to cancellation of Applicant's prequalification / contract.

- 4.6 The list of debarred firms and individuals by certain leading MDAs is available as specified in the **DS**. This may not be an exhaustive list of debarred entities but those which are made available centrally on the respective MDA's website. Additionally, there could be lists of debarred entities issued by various government departments/ procuring entities/ corporations and maintained offline.
- 4.7 An Applicant shall be ineligible to be pregualified if (a) it is currently under default on any loan to any Bank/ Financial Institution (FI) and its account has been classified as Non-Performing Asset (NPA) as per Central Repository of Information on Large Credits (CRILC) database; and/or (b) its promoters/ directors appear in Negative List, RBI Willful Defaulter List (Suit filed as well as non-suit filed). Credit Information Bureau India Ltd. (CIBIL) Defaulter List and any other negative list of central and state government agencies, updated from time-to-time. On being included in any of the above lists post the pregualification process (i.e. including during bidding process and/or contract implementation phase), the Applicant shall immediately inform Exim Bank on the inclusion and reasons for inclusion thereof. This may lead to cancellation of Applicant's pregualification / contract.
- 4.8 An Applicant shall (i) be eligible with respect to the provisions of Public Procurement Orders No. 1 & 2 dated July 23, 2020 and Public Procurement Order No. 3 dated July 24, 2020 issued by Department of Expenditure, Ministry of Finance, Government of India; and (ii) furnish such evidence of eligibility satisfactory to the Bank, as the Bank shall reasonably request.
- B. Composition of the Application Document
- **5. Contents of this Document 5.1** This Application Document consists of the Parts indicated below, and which should be read in conjunction with any Corrigendum issued in accordance with ITA 7.

 - 5.2 Unless obtained directly from the Bank, the Bank shall not be responsible for the completeness of the document, responses to requests for clarification, or Addenda to the

Application Document in accordance with ITA 7. In case of any discrepancies, documents issued directly by the Bank shall prevail.

- 5.3 An Applicant is expected to study all instructions, and forms in the Application Document and to furnish with its Application all information or documentation as is required by the Application Document.
- 6. Clarifications 6.1 A prospective Applicant requiring any clarification of the Application Document shall contact the Bank in writing at the Bank's address indicated in the **DS**. The Bank will respond in writing to any request for clarification provided that such request is received no later than fourteen (14) days prior to the deadline, or any extension thereof, for submission of the applications. The Bank's response, at its discretion, may be put up on its

website and shall include a description of the inquiry (without identifying its source) and corresponding clarification. As a result of a clarification the Bank may, if necessary, amend the Application Document in accordance with the provisions of ITA 7.

- 6.2 Any modification to the Application Document that may become necessary as a result of the clarifications to the queries shall be made by the Bank exclusively through the use of a Corrigendum pursuant to ITA 7.
- **n of** 7.1 At any time prior to the deadline for submission of Applications, the Bank may amend the Application Document by issuing a Corrigendum.
 - 7.2 Any Corrigendum or Addenda issued shall be deemed to be part of the Application Document and shall be published on the Bank's website.
 - 7.3 Post Corrigendum, in order to allow sufficient time to the prospective Applicants in preparing their Applications, or for other good reason, the Bank may, at its discretion, extend the deadline for the submission of Applications in accordance with ITA 16.2.
