The Export-Import Bank of India [hereafter Exim Bank, or the Bank], on behalf of the Government of India (GOI), extends from time-to-time, concessional credit facilities under the Indian Development and Economic Assistance Scheme (IDEAS) to overseas governments / their nominated agencies in developing countries for financing projects involving procurement of goods, civil works, consultancy and non-consultancy services to be contracted to Indian entities.

These Lines of Credit (LOCs) are governed by the Guidelines issued by the GOI from time-to-time. As per the extant guidelines issued vide letter F. No. 5/7/2019-IDEAS dated March 31, 2022, the Bank is required to carry out a prequalification exercise and provide a list of prequalified bidders to the Borrower for invitation of bids for specific contract packages under the project(s) financed by the LOCs.

#### Part I: Scope of Construction Contract (CC)

The Export-Import Bank of India (hereafter Exim Bank or the Bank), on behalf of the Government of India (GOI) has approved financing of a project out of a Line of Credit extended to the SBM (Mauritius) Infrastructure Development Company Ltd., Mauritius. A part of the LOC shall be utilised for Construction of Mauritius Disciplined Forces Academy Building at Cote D'Or, Mauritius for which Exim Bank now seeks applications for prequalification from eligible Indian entities. Refer Part II ITA 4 for eligibility provisions.

#### Introduction:

The Discipline Force Services include the Mauritius Police Force, Mauritius Prison Services and the Mauritius Fire and Rescue Services. These three services run three schools separately to cater for the training of their personnel.

Mauritius Police Academy has been proposed by Mauritius Police Force (MPF) with an aim to regroup the police training institutions segregated across the island into one single consolidated campus, so that training and development of Police officers at all levels can be provided a quality service with pride and care and meet the organizational vision "With you, making Mauritius safer".

Police Officers are increasingly being confronted with new types of sophisticated crimes whilst being pressed by the growing demands for service excellence. Hence, there is a need for a modern, professional and flexible Police capable of addressing contemporary issues and proactively targeting emerging challenges. With a view to transform the organization and empower Officers to become effective leaders of Community Policing, the proposed project would cater for state-of-the-art infrastructure in line with modern standards for a training institution. The project also aims at setting up such facilities which could be used for police/official functions other than training, making the Academy a "one-stop shop" for social, cultural and educational events of the MPF.

The Government of the Republic of Mauritius has appointed an Indian Project Management Consulting firm NBCC (India) Ltd. for the construction of Mauritius Disciplined Forces Academy Building. The Consultant has worked in close collaboration with the PMT (Project Management Team) appointed by the Ministry of Defence & Rodrigues for C/o Mauritius

Disciplined Forces Academy. Certifications made on documents and drawings by the Consultant shall be endorsed by the PMC's Engineer.

**Major Components:** "The project will include the setting up of main administrative block, training buildings, residential buildings and outdoor facilities equipped with modern and state of the art training establishment. In view to harmonize the buildings with the surrounding environment, it is proposed that the built-in surface area should not exceed 20% of the total surface area of the land available.".

All the major components of the project have been placed in such a way that they are complementing each other and at the same time are segregated to symbolize the different nature & typology of the functions. All the facilities are proposed to be equipped with all the modern & latest equipment /technology so that the complex can be developed as a world class facility. An integrated & seamless vehicular circulation plan has been proposed to efficiently cater to the users within the complex. Traffic plan has been emphasized on providing a conflict free movement of private, VIP, services, security, fire and ambulance vehicles. The entire complex has been designed to provide a barrier free movement to its users.

#### Site & Proposed Design:

Site for the Construction of Mauritius Disciplined Forces Academy Building is conveniently accessed from the main road and it is nearby National Sports Complex at Cote D'Or. It is currently devoid of any large trees and is slightly contoured. The land is completely covered with bushes and vegetation. Mauritius Disciplined Forces Academy Building will be built on a plot of land of 30 acres (approx.) that has been earmarked for the project.

**Location Description:** The Republic of Mauritius is an island in the Indian Ocean and is located about 2,000 kilometers (1,200 mi) off the southeast coast of the African continent. The Republic of Mauritius also includes the islands of Rodrigues, Agalega and St. Brandon. The capital is Port Louis.

Mauritius is known for its beaches, lagoons and reefs. The mountainous interior includes Black River Gorges National Park, with rainforests, waterfalls, hiking trails and wildlife. Mauritius has 9 districts as follows:

**Moka – The Site Location:** The site is located in the Moka district. Moka is situated in the central plateau of the island. The district has an area of 234.4 km2 and the population estimate was at 83,672 as of 01 July 2019.

It is administered by the Moka District Council. The elevation is around 203 meters and can be up to 425 meters (approx.) in some places. Moka is directly on the other side of the Moka Mountain Range from Port Louis. The village is close to the mountain Le Pouce and the town of Beau-Bassin and Rose-Hill.

The people of Mauritius are multiethnic, multicultural and multilingual. Mauritius is highly ranked for democracy and for economic and political freedom. The Human Development Index of Mauritius is one of the highest in Africa. Mauritius is ranked as the most competitive and one of the most developed economies in the African region.

The main pillars of the Mauritian economy are manufacturing, financial services, tourism, and information and communications technology. Mauritius is a welfare state; the government provides free universal health care, free education up to tertiary level and free public transport for students, senior citizens, and the disabled.

#### **Project Vision and Objective:**

It is governed by the Police Act 1974 and responsible for policing on mainland Mauritius, Rodrigues and other outer islands. It is headed by the Commissioner of Police and operates under the aegis of the Home Affairs Division of the Prime Minister's Office. The MPF is presently composed of about 12,500 Police officers posted Divisions and Branches which comprise, among others, an Anti-Drug and Smuggling Unit (ADSU), Passport and Immigration Office (PIO), paramilitary units- Special Mobile Force (SMF) and Special Support Unit (SSU,) an air wing -Police Helicopter Squadron (PHS) and Maritime Air Squadron (MAS) and a naval wing-National Coast Guard (NCG).

For an effective and sound management and functioning of the MPF and for a better delivery of service proper training of the police is very important. On joining the Police Force, new recruits undergo a foundation course of two years' duration during which they are exposed to Police duties, law and procedures, map reading, navigation, public order policing and weapon handling, amongst others. The programme also includes intensive physical training.

At the end of the foundation course, they have to complete two top-up modules of 120 hours at the University of Mauritius, leading to the award of a 'Certificate in Police Duties'. The new recruits benefit from a total amount of 5,330 hours of training in all. Once these Officers are posted to different units, they undergo on-the-job training. They also benefit from refresher courses workshops and seminars by the Police Training School with a view to keeping abreast of new legislations, procedures and other administrative and operational matters.

Right now, there are many training institutions in Mauritius but they are segregated across island so there is a need of one single consolidated campus so that a world class training facility can be provided to the police force and can train them to provide a quality service with pride and care and meet the organizational vision.

#### Scope of Work:

The building shall be designed with flexibility to support adaptability and change. State land of a size of 30 acres at Cote D'or, Mauritius, has been made available to the Mauritius Police Force for the construction of Mauritius Disciplined Forces Academy at Cote D'or, Mauritius. The building shall have Academy Head Quarter (HQ), Police HQ, Dormitory, Fire Drill Tower, Workshop, Library & Dining, Central Criminal Investigation Division (CCID), Furniture, Landscape etc. including associated infrastructure work like Roads, Water Supply, Sewerage, Drains, and other public utilities with required MEP works, etc. for the building as per BOQ, Drawings, technical specification and others specified in the tender documents.

The scope of work covered in this tender shall be as per the Bill of Quantities, specifications, drawings, instructions, orders issued to the contractor from time to time during the pendency of work. The drawings for this work, which may be referred for tendering, provide general idea only about the work to be performed under the scope of this contract. These may not be the final drawings and may not indicate the full range of the work under the scope of this contract. The work will be executed according to the drawings to be released as "GOOD FOR CONSTRUCTION" from time to time by the Engineer-in-charge of NBCC (India) Limited and according to any additions/ modifications/ alterations/ deletions made from time to time, as required by any other drawings that would be issued to the contractor progressively during execution of work. It shall be the responsibility of the contractor to incorporate the changes that may be in this scope of work, envisaged at the time of tendering and as actually required to be executed.

The quantities of various items as entered in the "BILL OF QUANTITIES" are indicative only and may vary depending upon the actual requirement. The contractor shall be bound to carry out and complete the stipulated work irrespective of the variation in individual items specified in the bill of quantities. The variation of quantities will be governed as per relevant clause of contract.

#### Part II. Instructions to Applicants

#### A. General

#### 1. Background

1.1 The Export-Import Bank of India (hereinafter called "the Bank"), on behalf of the Government of India (GOI), extends from time-to-time, concessional credit facilities (hereinafter called "Lines of Credit") under the Indian Development and Economic Assistance Scheme (IDEAS) to overseas governments or their nominated agencies (hereinafter called "Borrower or Employer"), for financing projects to be executed by Indian entities. Payment by the Bank to the Indian exporters will be made only at the request of the Borrower and upon approval by the Bank, and will be subject, in all respects, to the terms and conditions of the credit (or financing) agreement.

#### 2. Scope of Prequalification

2.1 With reference to the Invitation for Prequalification (IFP) indicated in Part III, Data Sheet (**DS**), this Application Document ("Application Document") is being issued by the Bank to prospective applicants ("Applicants") interested in submitting applications ("Applications") for prequalification as per the scope described in Part I, Scope of the Construction Contract and subject to the provisions of this Application Document.

# 3. Ethics and Integrity

- 3.1 The Bank requires Applicants to participate in this prequalification process with the highest standards of ethics and integrity. It is strictly forbidden to the parties involved in the prequalification process, by themselves or by a third party, to offer, ask or accept for itself or for a third party, financial or non-financial advantage or even direct or indirect promise or any other acts<sup>1</sup>, as offsets for prequalification or bidding or contract award and execution as applicable, if susceptible of being qualified as criminal unlawful acts in accordance with national laws of any party involved.
- 3.2 In pursuance of ITA 3.1 above, Applicants shall permit the Bank to inspect all accounts, records and other documents relating to the submission of the Application, bid submission (in case prequalified), and contract performance (in the case of award), and to have them audited by auditors appointed by the Bank.
- 3.3 If, in accordance with the administrative procedures of the Bank, it is demonstrated that an Applicant in this prequalification process, or during the subsequent bidding for the contract(s) has violated the provisions stated in ITA 3.1 above, the Bank, inter alia.
  - a. shall reject any Application for prequalification or proposal to award a contract in connection with the subsequent procurement process, as applicable; and/or
  - may declare an Applicant, temporarily or permanently, ineligible to be awarded future contracts under Bank funding.

#### 4. Eligibility of

4.1 This prequalification exercise is open to only Indian Applicants in

- accordance with the provisions of ITA 4.4. Any form of association by the Applicant with ineligible entities either during this prequalification process or subsequent bidding process may be liable for rejection.
- 4.2 For the purpose of applying the eligibility criteria listed in this article 4, "Applicant" would include the single entity or in case of a joint venture ("JV"), each member of the JV, involved or intended to be involved with this prequalification process (as mentioned in Form A.1.2 Applicant's JV Member's Information Form), for any part of the prospective contract(s) including related services.
- 4.3 An Applicant may be a single entity or a combination of entities in the form of a JV either existing or with the intent to enter into a JV supported by a letter of intent or JV Agreement listing out the names of all the JV members. In the case of a JV, all members shall be jointly and severally liable for the execution of the subsequent contract(s) in accordance with the respective contract terms. The JV shall be represented by an authorized representative who shall have the authority from all members of the JV so as to conduct all business for and on behalf of the JV during the prequalification process. The limit on the number of members in a JV would be as specified in the **DS**.
- 4.4 This prequalification exercise is open to only Indian Applicants. An Applicant shall be deemed to be Indian if the Applicant is registered in India and/or incorporated/established under any law in force in India, as evidenced by its articles of incorporation and its registration documents, as the case may be.
- 4.5 An Applicant that has been blacklisted/ debarred/ sanctioned/ suspended by any multilateral development bank (MDB), such as World Bank, Asian Development Bank, or any authority of GOI or the Borrowing Government in accordance with extant rules and shall be ineligible to participate pregualification/ bidding process as applicable, during such period of time as the sanctioning authority shall have determined. In case the Applicant is blacklisted/ debarred/sanctioned post the pregualification process (i.e. including during bidding process and/or contract implementation phase), the Applicant shall immediately inform Bank of such Exim blacklisting/ debarment/sanction and reasons thereof. This may lead to cancellation of Applicant's pregualification / contract.
- 4.6 The list of debarred firms and individuals by certain leading MDBs is available as specified in the **DS**. This may not be an exhaustive list of debarred entities but those which are made available centrally on the respective MDB's website. Additionally, there could be lists of debarred entities issued by various government departments/ procuring entities/ corporations and maintained offline.
- 4.7 An Applicant shall be ineligible to be prequalified if (a) it is currently under default on any loan to any Bank/ Financial Institution (FI) and its account has been classified as Non-Performing Asset (NPA) as per Central Repository of Information on Large Credits (CRILC) database; and/or (b) its promoters/ directors appear in Negative

List, RBI Wilful Defaulter List (Suit filed as well as non-suit filed), Credit Information Bureau India Ltd. (CIBIL) Defaulter List and/or any other negative list of central and/or state government agencies, updated from time-to-time. On being included in any of the above lists post the prequalification process (i.e. including during bidding process and/or contract implementation phase), the Applicant shall immediately inform Exim Bank on the inclusion and reasons for inclusion thereof. This may lead to cancellation of Applicant's prequalification / contract.

4.8 An Applicant shall (i) be eligible with respect to the provisions of Public Procurement Orders Nos. 1 & 2 dated July 23, 2020 and Public Procurement Order No. 3 dated July 24, 2020 issued by the Public Procurement Division of the Department of Expenditure, Ministry of Finance, Government of India; and (ii) furnish such evidence of eligibility satisfactory to the Bank, as the Bank shall reasonably request.

#### B. Composition of the Application Document

- 5. Contents of this Document
- 5.1 This Application Document consists of the Parts indicated below, and which should be read in conjunction with any Corrigendum issued in accordance with ITA 7.

- 5.2 Unless obtained directly from the Bank, the Bank shall not be responsible for the completeness of the document, responses to requests for clarification, or Addenda to the Application Document in accordance with ITA 7. In case of any discrepancies, documents issued directly by the Bank shall prevail.
- 5.3 An Applicant is expected to study all instructions, and forms in the Application Document and to furnish with its Application all information or documentation as is required by the Application Document.
- 6. Clarifications
- 6.1 A prospective Applicant requiring any clarification of the Application Document shall contact the Bank in writing at the Bank's address indicated in the **DS**. The Bank will respond in writing to any request for clarification provided that such request is received no later than fourteen (14) days prior to the deadline, or any extension thereof, for submission of the applications. The Bank's response, at its discretion, may be uploaded on its website and shall include a description of the inquiry (without identifying its source) and corresponding clarification. As a result of a clarification the Bank may, if necessary, amend the Application Document in accordance with the provisions of ITA 7.
- 6.2 Any modification to the Application Document that may become necessary as a result of the clarifications to the queries shall be made by the Bank exclusively through the use of a Corrigendum pursuant to ITA 7.
- 7. Corrigendum of
- 7.1 At any time prior to the deadline for submission of Applications,

the Bank may amend the Application Document by issuing a Corrigendum.

- 7.2 Any Corrigendum or Addenda issued shall be deemed to be part of the Application Document and shall be published on the Bank's website.
- 7.3 Post Corrigendum, in order to allow sufficient time to the prospective Applicants in preparing their Applications, or for other good reason, the Bank may, at its discretion, extend the deadline for the submission of Applications in accordance with ITA 16.2.

#### C. Preparation, Submission and Opening of Applications

### 8. Cost towards Application

- 8.1 The Applicant shall bear all costs associated with the preparation and submission of its Application. The Bank will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the pregualification process.
- 9. Language
- 9.1 The Application documentation and printed literature that are part of the Application, if in another language, shall be accompanied by an accurate translation of the relevant passages in English language, which shall be the governing language.

# 10. Documents constituting the Application

- 10.1 The Application shall comprise the following:
  - (a) Application Submission Form, in accordance with ITA 11.1;
  - (b) documentary evidence establishing the Applicant's eligibility, in accordance with ITA 12.1;
  - (c) documentary evidence establishing the Applicant's qualifications, in accordance with ITA 13; and
  - (d) any other document required as specified in the **DS**.

Each Form included in Part V and the Questionnaire in Part VI shall be duly signed by the authorized representative of the Applicant. In case of JV, authorized representative of the respective member shall sign. Noncompliance with this clause may result in summary rejection of the Application.

- 13.2 If an Applicant does not manufacture or produce the goods it offers to supply, it shall submit documentation related to Manufacturer's Authorisation as specified in the **DS**.

#### D. Procedures for Evaluation of Applications

# 19. Evaluation to be Confidential

- 19.1 Information relating to the Applications, their evaluation and result shall be confidential and will not be disclosed to Applicants or any other person(s) not officially concerned with the prequalification process until the official notification of pregualification results is made in accordance with ITA 25.
- 19.2 From the deadline for submission of Applications to the time of notification of the results of the prequalification in accordance with ITA 25, any Applicant who wishes to contact the Bank on any matter related to the prequalification process (except as specified in ITA 20.1 below), may do so only in writing. Canvassing in any form will be grounds for disqualification.

# 20. Clarifications during Evaluation

- 20.1 During the evaluation of Applications, in case of ambiguity, the Bank may, at its discretion, ask an Applicant for a clarification of its Application, to be submitted within a stated reasonable period of time. Any request for clarification from the Bank and all clarifications from the Applicant shall be in writing. Any clarification submitted by an Applicant that is not in response to a request by the Bank may not be considered.
- 20.2 If an Applicant does not provide (within the time allowed) clarifications and/or documents requested as per the Bank's request for clarification, its Application shall be evaluated based on the information and documents available at the time of evaluation of the Application.

#### 21. Determination of Responsiveness of Applications

21.1 The Bank may reject any Application which is not responsive to the requirements of the Application Document and may not subsequently be made responsive by correction of the causes of non-responsiveness or by substitution or resubmission of the Application or part thereof.

# 22. Evaluation of Applications

- 22.2 The qualification and experience of sub-contractor(s), if any, proposed by the Applicant will not be considered for evaluation of the Application.
- 22.3 Only the qualifications of the Applicant, in the capacity as prime contractor/ member of JV to the project employer, or as Sub-Contractor shall be considered. In particular, the qualifications of parent or subsidiary or any other affiliated

- company of the Applicant, who is not member of the JVCA except as permitted by ITA 4.3, shall not be considered.
- 22.4 The qualification and experience of the Applicant² for execution of supplies/works/contracts in-house or for a parent/ promoter/ subsidiary/ group concerns or for Special Purpose Vehicles (SPVs), set up by the Applicant or its group companies, shall not be considered. However, the experience of the SPV can be considered in favour of the Applicant provided it is established through documentary evidence that the SPV was established by the Applicant pursuant to a concession granted/requirement stipulated by a Project Authority who is unrelated to both the Applicant and the SPV and the Letter of Acceptance of bid/ Letter of Award was issued by the Project Authority in favour of the Applicant or a JV comprising the Applicant. Further, the FAC issued by the Project Authority should indicate that the project was executed by the Applicant as a Construction Contractor.
- 23. Bank's Right to Accept or Reject Applications
- 23.1 The Bank reserves the right to accept or reject any Application, and to annul the prequalification process and reject all Applications at any time, without thereby incurring any liability to the Applicants.

26.1 The Bank shall forward the list of prequalified firms to the Borrower for subsequent invitation of bids.
