## INVITATION FOR PREQUALIFICATION OF EPC CONTRACTORS FOR GOVERNMENT OF INDIA LINE OF CREDIT (LOC) PROJECT

The Export-Import Bank of India [hereafter Exim Bank, or the Bank], on behalf of the Government of India (GOI), extends from time-to-time, concessional credit facilities under the Indian Development and Economic Assistance Scheme (IDEAS) to overseas governments / their nominated agencies in developing countries for financing projects involving procurement of goods, civil works, consultancy and non-consultancy services to be contracted to Indian entities.

These Lines of Credit (LOCs) are governed by the Guidelines issued by the GOI from time-to-time. As per the extant guidelines issued vide letter F.No. 5/7/2019-IDEAS dated March 31, 2022, the Bank is required to carry out a prequalification exercise and provide a list of prequalified bidders to the Borrower for invitation of bids for specific contract packages under the project(s) financed by the LOCs.

In pursuance to the above, the Bank invites Applications from eligible Indian entities for prequalification of an EPC Contractor for 51 MW Wind Farm at Rio Seco, Holguin Province, Cuba under a Line of Credit extended to the Banco Exterior de Cuba.

An upfront and non-refundable Processing Fee of INR 50,000 plus applicable GST (presently 18%) is payable through NEFT transfer as per details given below:

## **Part I: Scope of EPC**

The Export-Import Bank of India (hereafter Exim Bank or the Bank), on behalf of the Government of India (GOI) has approved financing a project out of a Line of Credit extended to the Banco Exterior de Cuba for 51 MW Wind Farm at Rio Seco, Holguin Province, Cuba. A part of the LOC shall be utilized for construction of the Wind Farm for which Exim Bank now seeks applications for prequalification from eligible Indian entities. Refer Part II ITA 4 for eligibility provisions

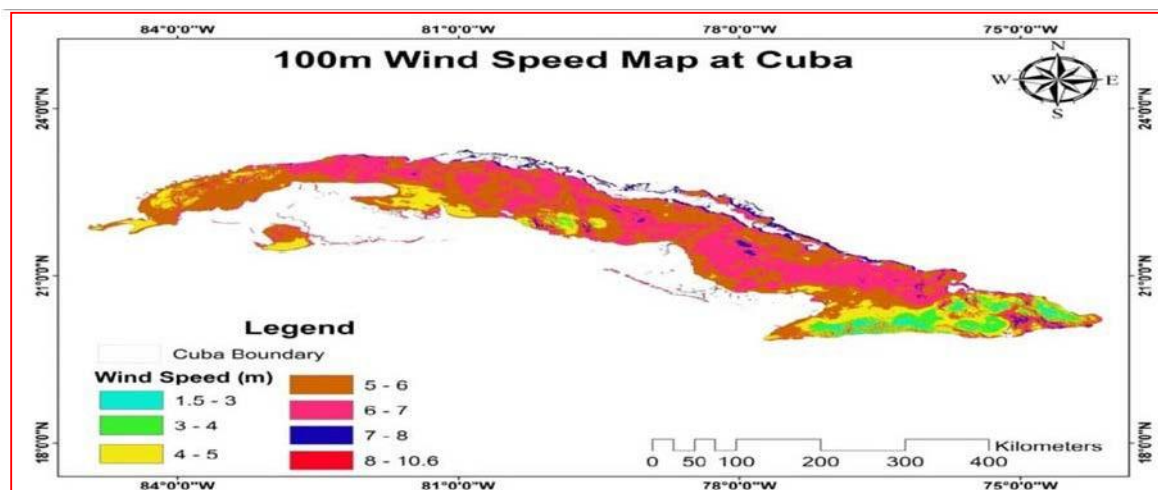
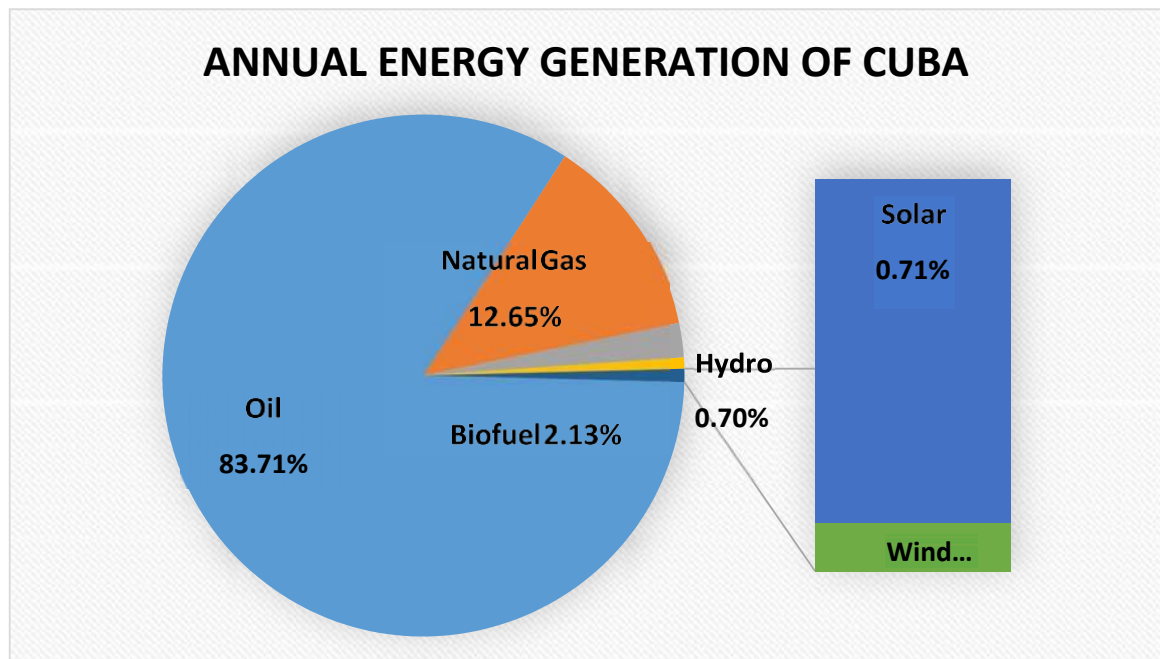
### **A] Background and Major Components of the Project**

The Republic of Cuba is a Caribbean Island between the Caribbean Sea and the North Atlantic Ocean. The total area of Cuba is around 110,860 sq. kms. The Cuban economy is dominated by the tourism industry and the exports of sugar, tobacco and coffee. The services sector contributes the maximum to Cuba's GDP. In 2017 estimates, it accounted for 73.4% of Cuba's GDP followed by industrial sector (22.6%), and agriculture (4%). Cuba's GDP stood at an estimated USD 103.5 bn in 2020, and GDP per capita at PPP amounted to an estimated USD 12,974. Cuba is a hot and a humid country with an average relative humidity of 78%. The annual average temperature in summer goes up to 25°C, and in winter it is 20°C. The geographical map of Cuba is shown as below:



The overall installed power capacity of Cuba was 6.7 GW at the end of 2018. The major source of electricity generation in Cuba is liquid fuel, which accounted for 83.71% in the energy mix. The rest of the energy came from Natural Gas (12.65%) and renewable (3.64%) including biofuel (bagasse), Hydro Power, Solar and Wind Power.

The energy mix of the country in 2018 is represented as below:



As per the Intended Nationally Determined Contribution (INDC) of Cuba, according to Paris agreement, it was proposed to install 2,144 MW of renewable energy electricity generation by 2030. This is to be made up of 755 MW of sugar and biomass plants, 738 MW of wind farms, 700 MW of solar photovoltaic and 45 MW of small hydroelectric plants.

To reach its envisaged goal of 738MW of wind generation capacity by 2030, Cuba plans to build 13 wind farms along the northern coast of the Country. To execute the project Union Electrica de Cuba (UNE), under the Ministry of Energy and Mines (MINES), Cuba, has identified the wind potential zones along the vast coastal plain located on the North and East in Holguin province as the ideal locations for development of the wind farm. In this regard, Rio Seco was selected as one of the 13 sites for developing a wind farm.

The Rio Seco site (proposed to be funded under Exim Bank's GOI-LOC to Banco Exterior de Cuba) considered for the development of 51 MW wind farm is located in Holguin Province, Cuba. The selected site area is located in the Northern coastal strip of the province of Holguin, in the Municipality of Banes, at about 7.8 km (aerial distance) to the east of Puerto Sama, 4.3 km

(aerial distance) to the west of Rio Seco Bay and about 4.5 km (aerial distance) to the northwest of the Los Angeles settlement. The proposed land area is homogenous with scattered bushes & shrubs. The site is approachable through state highway 421. The average elevation range of the site is 40m-50m Mean Sea Level (MSL).

The harnessing of wind energy in Cuba started in 1999 with a 0.45MW demonstration wind farm and from 2007, onwards small-sized wind farms were installed. Presently, the Country has 11.70 MW of wind farm capacity ranging from 225kW to 850kW wind turbines.

### **Scope :**

**Indicative Scope of EPC Contractor for the project is given below:**

- End-to-end sourcing/Manufacturing of Wind Turbine Generators (WTGs) of indicative capacity 2.2 MW to 3 MW each to meet the capacity requirements i.e. ~ 51 MW at any company owned manufacturing site in India.
- Transportation of WTG components (Nacelle, Hub, Blades, Towers) from India to the Project Site in Cuba.
- Assembly and Commissioning of all plant equipment (including the supply of the 110 kV evacuation line and the expansion of the Banes 110/34.5 Electrical Substation)
- To Build the foundation and underground networks for WTGs and 110/34.5 kV Electrical Substation at Rio Seco.
- Development of Site for installation of Wind Turbine Generators (WTGs)
- Installation of WTGs at the Rio Seco Site in Holguin Province
- Supply and installation of the equipment including civil construction of the Rio Seco 110/34.5 kV Electrical Substation for connection with the National Electrical System (SEN) including supplies on the Indian Side.
- Supply and installation for Construction of Power Evacuation Line of 110 kV line (approximately 24 Km) from the wind farm at Rio Seco to the Banes Substation for the evacuation of the energy produced.
- Supply and installation for Expansion of Electrical Substation at SE Banes 110/ 34.5 kV Electrical Substation(S/s).
- Erection and Commissioning of the Wind Farm
- Technical Assistance, Operation and Maintenance for a period of one year with the participation of Cuban personnel.

**The following works shall be undertaken by Government of Cuba through its own funding/EPC contractor, as below:**

- Construction of access road from the Guardalavaca-Banes highway (approx. 10 kms) from La Vega De Sama in Cuba to the Wind Farm.
- Construction of the Internal Roads of the Selected Area
- Development of the Site – Cuban Side will carry out the studies of the project.
- Modifications to the road at the critical points of the road from the Puerto de Vita to La Vega de Sama to allow the safe transit of loads of exceptional dimensions and weight.
- Prepare the port for the reception of technological equipment
- Construction of a logistical support base adjacent to the Wind Farm
- Provide technical assistance for Rio Seco 110/34.5 kV Electrical Substation.
- Provide technical advice and construction (Civil) services for Construction of
  - (a) 110 kV Power Evacuation Line from the wind farm at Rio Seco to the Banes Substation for the evacuation of the energy produced and
  - (b) Expansion of SE Banes 110/ 34.5 kV Electrical Substation
- Build the 34 kV power line for temporary installation
- Build the Control house of the Wind Farm



**B] Contract execution period**

The duration of the contract is expected to be 22 months from the Contract Effective Date.

**C] Other Information**

**D] GOI Guidelines**

As per the GOI guidelines, goods, works and services for minimum 75% value of the contracts covered under the Lines of Credit, must be sourced from India. ## Part II. Instructions to Applicants

### A. General

- 1. Background**
  - 1.1 The Export-Import Bank of India (hereinafter called “the Bank”), on behalf of the Government of India (GOI), extends from time-to-time, concessional credit facilities (hereinafter called “Lines of Credit”) under the Indian Development and Economic Assistance Scheme (IDEAS) to overseas governments or their nominated agencies (hereinafter called “Borrower or Employer or Project authority”), for financing projects to be executed by Indian entities. Payment by the Bank to the Indian exporters will be made only at the request of the Borrower and upon approval by the Bank, and will be subject, in all respects, to the terms and conditions of the credit (or financing) agreement.
- 2. Scope of Prequalification**
  - 2.1 With reference to the Invitation for Prequalification (IFP) indicated in Part III, Data Sheet (DS), this Application Document (“Application Document”) is being issued by the Bank to prospective applicants (“Applicants”) interested in submitting applications (“Applications”) for prequalification as per the scope described in Part I, Scope of EPC and subject to the provisions of this Application Document.
- 3. Ethics and Integrity**
  - 3.1 The Bank requires Applicants to participate in this prequalification process with the highest standards of ethics and integrity. It is strictly forbidden to the parties involved in the prequalification process, by themselves or by a third party, to offer, ask or accept for itself or for a third party, financial or non-financial advantage or even direct or indirect promise or any other acts<sup>1</sup>, as offsets for prequalification or bidding or contract award and execution as applicable, if susceptible of being qualified as criminal unlawful acts in accordance with national laws of any party involved.
  - 3.2 In pursuance of ITA 3.1 above, Applicants shall permit the Bank to inspect all accounts, records and other documents relating to the submission of the Application, bid submission (in case prequalified), and contract performance (in the case of award), and to have them audited by auditors appointed by the Bank.
  - 3.3 If, in accordance with the administrative procedures of the Bank, it is demonstrated that an Applicant in this prequalification process, or during the subsequent bidding for the contract(s) has violated the provisions stated in ITA 3.1 above, the Bank, inter alia,
    - a. shall reject any Application for prequalification or proposal to award a contract in connection with the subsequent procurement process, as applicable; and/or
    - b. may declare an Applicant, temporarily or permanently, ineligible to be awarded future contracts under Bank funding.

<sup>1</sup>These acts shall include, but not limited to, corrupt practice, fraudulent practice, collusive practice, coercive practice, obstructive practice, and conflict of interest.

**4. Eligibility of Applicants**

- 4.1 This prequalification exercise is open to only Indian Applicants in accordance with the provisions of ITA 4.4. Any form of association by the Applicant with ineligible entities either during this prequalification process or subsequent bidding process may be liable for rejection.
- 4.2 For the purpose of applying the eligibility criteria listed in this article 4, “Applicant” would include the single entity or in case of a joint venture (“JV”), each member of the JV, involved or intended to be involved with this prequalification process (as mentioned in Form A.1.2 Applicant’s JV Member’s Information Form), for any part of the prospective contract(s) including related services.
- 4.3 An Applicant may be a single entity or a combination of entities in the form of a JV either existing or with the intent to enter into a JV supported by a letter of intent or JV Agreement listing out the names of all the JV members. In the case of a JV, all members shall be jointly and severally liable for the execution of the subsequent contract(s) in accordance with the respective contract terms. The JV shall be represented by an authorized representative who shall have the authority from all members of the JV so as to conduct all business for and on behalf of the JV during the prequalification process. The limit on the number of members in a JV would be as specified in the **DS**.
- 4.4 This prequalification exercise is open to only Indian Applicants. An Applicant shall be deemed to be Indian if the Applicant is registered in India and/or incorporated/established under any law in force in India, as evidenced by its articles of incorporation and its registration documents, as the case may be.
- 4.5 An Applicant that has been blacklisted/ debarred/ sanctioned by any multilateral development bank (MDB), such as World Bank, Asian Development Bank, or any authority of GOI or the Borrowing Government in accordance with extant rules and procedures, shall be ineligible to participate in the prequalification/ bidding process as applicable, during such period of time as the sanctioning authority shall have determined. In case the Applicant is blacklisted/ debarred/sanctioned, post the prequalification process (i.e. including during bidding process and/or contract implementation phase), the Applicant shall immediately inform Exim Bank of such blacklisting/debarment/sanction and reasons thereof. This may lead to cancellation of Applicant’s prequalification / contract.
- 4.6 The list of debarred firms and individuals by certain leading MDBs is available as specified in the **DS**. This may not be an exhaustive list of debarred entities but those which are made available centrally on the respective MDB’s website. Additionally, there could be lists of debarred entities issued by various government departments/ procuring entities/ corporations and maintained offline.
- 4.7 An Applicant shall be ineligible to be prequalified if (a) it is currently under default on any loan to any Bank/ Financial Institution (FI) and its account has

been classified as Non-Performing Asset (NPA) as per Central Repository of Information on Large Credits (CRILC) database; and/or (b) its promoters/directors appear in Negative List, RBI Wilful Defaulter List (Suit filed as well as non-suit filed), Credit Information Bureau India Ltd. (CIBIL) Defaulter List and/or any other negative list of central and/or state government agencies, updated from time-to-time. On being included in any of the above lists post the prequalification process (i.e. including during bidding process and/or contract implementation phase), the Applicant shall immediately inform Exim Bank on the inclusion and reasons for inclusion thereof. This may lead to cancellation of Applicant's prequalification / contract.

4.8 An Applicant shall (i) be eligible with respect to the provisions of Public Procurement Orders Nos. 1 & 2 dated July 23, 2020 and Public Procurement Order No. 3 dated July 24, 2020 issued by the Public Procurement Division of the Department of Expenditure, Ministry of Finance, Government of India; and (ii) furnish such evidence of eligibility satisfactory to the Bank, as the Bank shall reasonably request.

## **B. Composition of the Application Document**

### **5. Contents of this Document**

5.1 This Application Document consists of the Parts indicated below, and which should be read in conjunction with any Corrigendum issued in accordance with ITA 7.

- Part III. Data Sheet (DS) to ITA
- Part IV. Prequalification Criteria and Requirements

5.2 Unless obtained directly from the Bank, the Bank shall not be responsible for the completeness of the document, responses to requests for clarification, or Addenda to the Application Document in accordance with ITA 7. In case of any discrepancies, documents issued directly by the Bank shall prevail.

5.3 An Applicant is expected to study all instructions, and forms in the Application Document and to furnish with its Application all information or documentation as is required by the Application Document.

### **6. Clarifications**

6.1 A prospective Applicant requiring any clarification of the Application Document shall contact the Bank in writing at the Bank's address indicated in the **DS**. The Bank will respond in writing to any request for clarification provided that such request is received no later than fourteen (14) days prior to the deadline, or any extension thereof, for submission of the applications. The Bank's response, at its discretion, may be uploaded on its website and shall include a description of the inquiry (without identifying its source) and corresponding clarification. As a result of a clarification the Bank may, if necessary, amend the Application Document in accordance

with the provisions of ITA 7.

- 6.2 Any modification to the Application Document that may become necessary as a result of the clarifications to the queries shall be made by the Bank exclusively through the use of a Corrigendum pursuant to ITA 7.

**7. Corrigendum of Application Document**

- 7.1 At any time prior to the deadline for submission of Applications, the Bank may amend the Application Document by issuing a Corrigendum.
- 7.2 Any Corrigendum or Addenda issued shall be deemed to be part of the Application Document and shall be published on the Bank's website.
- 7.3 Post Corrigendum, in order to allow sufficient time to the prospective Applicants in preparing their Applications, or for other good reason, the Bank may, at its discretion, extend the deadline for the submission of Applications in accordance with ITA 16.2.

**C. Preparation, Submission and Opening of Applications**

**8. Cost towards Application**

- 8.1 The Applicant shall bear all costs associated with the preparation and submission of its Application. The Bank will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the prequalification process.

**9. Language**

- 9.1 The Application documentation and printed literature that are part of the Application, if in another language, shall be accompanied by an accurate translation of the relevant passages in English language, which shall be the governing language.

**10. Documents constituting the Application**

- 10.1 The Application shall comprise the following:
- (a) Application Submission Form, in accordance with ITA 11.1;
  - (b) documentary evidence establishing the Applicant's eligibility, in accordance with ITA 12.1;
  - (c) documentary evidence establishing the Applicant's qualifications, in accordance with ITA 13; and
  - (d) any other document required as specified in the **DS**.

**11. Application Submission Form**

- 11.1 The Applicant shall complete an Application Submission Form as provided in Part V (Forms). This Form must be completed without any alteration to its format.

**12. Documents Evidencing the Applicant's Eligibility**

- 12.1 To establish its eligibility in accordance with ITA 4, the Applicant shall complete the eligibility declarations in the Application Submission Form and Forms A.1.1 and A.1.2, included in Part V (Forms).

**13. Documents Evidencing the**

- 13.1 To establish its qualifications in accordance with Part IV, Prequalification Criteria and Requirements, the Applicant shall provide the information

Applicant shall also complete the Questionnaire included in Part VI without any alteration to the questions. Each Form included in Part V and the Questionnaire in Part VI shall be duly signed by the authorized representative of the Applicant. In case of JV, authorized representative of the respective member shall sign. Non-compliance with this clause may result in summary rejection of the Application.</p> <p><b>13.2</b> If an Applicant does not manufacture or produce the goods it offers to supply, it shall submit documentation related to Manufacturer's Authorisation as specified in the <b>DS</b>.</p> <p><b>13.3</b> Wherever a monetary amount is to be stated, Applicant should indicate the USD equivalent using the rate of exchange determined as follows:</p> <ul style="list-style-type: none"><li>(a) Exchange rates shall be taken from the publicly available source identified in the <b>DS</b>. Equivalent amount in USD shall be arrived at using the exchange rate as on 31<sup>st</sup> March of respective financial year as specified in the <b>DS</b>;</li><li>(c) for data related to Liquidity, Annual Residual Contract Value and contracts signed in the current financial year, unless otherwise specified in the <b>DS</b>, the exchange rate prevalent as on the working day preceding the date of Invitation for Prequalification (IFP) shall be used to arrive at the USD equivalent as specified in the <b>DS</b>; and</li><li>(d) for contracts signed prior to the current financial year, the exchange rate as on 31<sup>st</sup> March of the respective financial year in which the contract was signed shall be used to arrive at the USD equivalent as specified in the <b>DS</b>.</li></ul>
<b>14. Authorized Signatory and Number of Copies</b>	<p><b>14.1</b> The Applicant shall prepare one original of the documents comprising the Application as described in ITA 10 and clearly mark it "ORIGINAL". The original of the Application shall be typed or written in indelible ink and shall be signed by a person duly authorized to sign on behalf of the Applicant. In case the Applicant is a JV, the Application shall be signed by all members of the JV.</p>
<b>15. Preparing the Application Envelope</b>	<p><b>15.1</b> The Applicant shall enclose the original Application in a sealed envelope that shall:</p> <ul style="list-style-type: none"><li>(a) be addressed to the Bank, as per ITA16.1;</li><li>(b) mention the name and address of the Applicant; and</li><li>(c) mention the specific identification of this prequalification process indicated in the <b>DS</b> ITA2.1.</li></ul> <p><b>15.2</b> The Bank will accept no responsibility for not processing any envelope that was not prepared as required in ITA 15.1 above.</p>
<b>16. Application Submission Deadline</b>	<p><b>16.1</b> Applicants must submit their Applications in dual mode (on-line as well as off-line). Applications shall be received by the Exim Bank at the address and no later than the deadline indicated in the <b>DS</b>.</p>

16.2 The Bank may, at its discretion, extend the deadline for the submission of Applications by amending the Application Document in accordance with ITA 7.

**17. Late Applications**

17.1 Applications received after the deadline for submission of applications shall not be admissible, and if received, shall be returned unopened to the Applicant.

**18. Opening of Applications**

18.1 The Bank shall open all Applications at the date, time and place specified in the **DS**. Applicants' representatives may be present during opening.

**D. Procedures for Evaluation of Applications**

**19. Evaluation to be Confidential**

19.1 Information relating to the Applications, their evaluation and result shall be confidential and will not be disclosed to Applicants or any other person(s) not officially concerned with the prequalification process until the official notification of prequalification results is made in accordance with ITA 25.

19.2 From the deadline for submission of Applications to the time of notification of the results of the prequalification in accordance with ITA 25, any Applicant who wishes to contact the Bank on any matter related to the prequalification process (except as specified in ITA 20.1 below), may do so only in writing. Canvassing in any form will be grounds for disqualification.

**20. Clarifications during Evaluation**

20.1 During the evaluation of Applications, in case of ambiguity, the Bank may, at its discretion, ask an Applicant for a clarification of its Application, to be submitted within a stated reasonable period of time. Any request for clarification from the Bank and all clarifications from the Applicant shall be in writing. Any clarification submitted by an Applicant that is not in response to a request by the Bank may not be considered.

20.2 If an Applicant does not provide (within the time allowed) clarifications and/or documents requested as per the Bank's request for clarification, its Application shall be evaluated based on the information and documents available at the time of evaluation of the Application.

**21. Determination of Responsiveness of Applications**

21.1 The Bank may reject any Application which is not responsive to the requirements of the Application Document and may not subsequently be made responsive by correction of the causes of non-responsiveness or by substitution or resubmission of the Application or part thereof.



## **E. Evaluation of Applications and Prequalification of Applicants**

### **22. Evaluation of Applications**

- 22.1 The Bank shall use the criteria and requirements defined in Part IV, Prequalification Criteria and Requirements, to evaluate the qualifications of the Applicants, and no other methods, criteria, or requirements shall be used. The Bank reserves the right to waive minor deviations from the prequalification criteria if they do not materially affect the technical capability and financial resources of an Applicant to perform the contract.
- 22.2 The qualification and experience of sub-contractor(s), if any, proposed by the Applicant will not be considered for evaluation of the Application.
- 22.3 Only the qualifications of the Applicant, in the capacity as prime contractor/ member of JV to the Project authority, shall be considered. In particular, the qualifications of parent or subsidiary or any other affiliated company of the Applicant, who is not member of the JVCA except as permitted by ITA 4.3, shall not be considered.
- 22.4 The qualification and experience of the Applicant for execution of supplies/ works/ contracts in-house or for a parent/ promoter/ subsidiary/group concerns or for Special Purpose Vehicles (SPVs), set up by the Applicant or its group companies, either singly or in JV/ consortium, shall not be considered, except in case of supplies/ works/ services/ contracts awarded or assigned by ministry or its department of Government of India. However, the experience of the SPV can be considered in favour of the Applicant provided it is established through documentary evidence that the SPV was established by the Applicant pursuant to a concession granted/ requirement stipulated by the Project Authority who is unrelated to the Applicant and the Letter of Acceptance of bid/ Letter of Award was issued by the Project Authority in favour of the Applicant or a JV/ consortium comprising the Applicant. Further, the FAC issued by the Project Authority should indicate that the project was completed by the said SPV. Certificate from the SPV or Project Authority indicating that the project was executed by the Applicant or JV/ consortium comprising the Applicant as the EPC contractor indicating inter alia, the detailed scope, period and value as per the requirements stated in the relevant section of this document should also be submitted by the Applicant.
