


Part I: Scope of EPC


The Export-Import Bank of India (hereafter Exim Bank or the Bank), on behalf of the Government of India (GOI) has approved financing a project out of a Line of Credit extended to Democratic Republic of Congo for revival and rehabilitation of the Katende Hydro Electric Project (HEP) in Democratic Republic of Congo (DR Congo). The LOC shall be utilized for construction of the Katende Hydro Electric Project (HEP) in Democratic Republic of Congo (DR Congo) for which Exim Bank now seeks applications for prequalification from eligible Indian entities. Refer Part II ITA 4 for eligibility provisions

A] Background and Major Components of the Project

Grand Katende Hydro Electric Project (64 MW) is a Run-of-River (ROR) scheme on Lulua river near Katende village about 80 km south of Kananga town in the Kasai Central province of Democratic Republic of Congo. The project envisages construction of a 426 m long (left + right) Weir across Lulua river to divert river water for power generation through a 317 m long Power Channel aligned on right bank of Lulua river to feed water to 4 generating units located in a sub surface Power House. Being a low head scheme, the generating units have been provided with Vertical Kaplan Turbines. Turbines would be operating at a net head of 15.1m each with a design discharge of 121.1 cumecs. The water will be discharged back into the Lulua River through 220 m long Tail Race Channel. The sub surface power house has 4 generating units of 16 MW capacity each.








Key Details of the earlier Contract:

- Client's Name: Ministry of Energy and Water Resources, Govt. of D R Congo
- Contractual Commencement Date: 23rd May 2012
- Current Status: Civil, Mechanical, Switchyard & Transmission Line work is to be completed.

The Katende Hydro Electric Project (4 X 16 MW) has been funded through Government of India (GOI) supported LOCs extended to the Government of DR Congo. The Engineering Procurement Construction (EPC) works was awarded to a consortium of one EPC Contractor company along with a Manufacturer company of Electrical Turbines and equipment etc. in August 2011. The works under the project was commenced during May 2012. The scheduled completion date of the project was in March 2016. The above project was managed and monitored by one Project Management Consultancy (PMC) company. Under earlier contract certain level of Civil, Hydro-Mechanical, Switchyard & Transmission Line construction are completed. The balance work under Civil, Hydro-Mechanical, Switchyard & Transmission Line are to be completed under the project. Accordingly, the Prequalification exercise is to include new EPC contractor to undertake the above mentioned balance work.

Scope:

The new EPC Contractor shall assess all the existing & the balance works of Civil, Hydromechanical, Switchyard, Transmission and other Miscellaneous works in complete manner & provide their technical & financial quotation accordingly. The brief description of pending works is as under, however EPC Contractor shall visit project site to check the condition of existing works on ground before taking up the project. The diagram of the project layout is given below.



Indicative Scope of EPC Contractor for the project is given below:

(A) Balance Civil Works to be Executed by New Civil Contractor

1. Infrastructure Works:

- a) Site clearance (removal of bushes from project area)
- b) Renovation & maintenance of Existing Infrastructure at site.
- c) Re-furnishing of Residential & non- residential buildings including AC, furniture, photocopy, printer, lab equipment & other peripherals etc.
- d) Repair & maintenance of water treatment plant and distribution system constructed by EPC Contractor to ensure adequate drinking water supply.
- e) To Construct permanent project area roads and & maintain for complete project duration.
- f) To provide and maintain electricity distribution system for adequate illumination to infrastructure facilities and work sites.
- g) To maintain telecommunication system (including telephone network, wireless network, internet facility etc).
- h) To maintain dispensary/ hospital with adequate medical & paramedical staff free of cost for all workers/staff posted at site from various organization for project works.
- i) To provide furnished office, guest house and residential accommodation to owner staff (5 Nos) and PMC staff (5 Nos.)
- j) After successful commissioning of project, contractor construction facilities/ areas like crushing

plant, batching plant, re-bar yard, shuttering yards etc shall be cleared and ground leveled.

- k) To repair and provide black topping/ carpeting of project road connecting all major components after commissioning of project.
- I) Watch and ward of the project area.
- m) Observe/Collect ad submit G&D and hydro- meteorological data.
- n) Maintain quality control for project works.
- o)cleaning of muck & slush in TRC & Power house area
- p)Investigation of existing work done in power channel, power house & TRC and Surface treatment & preparation for Cold joint treatment including application of epoxy, dowel, removal of week concrete & reinforcement in power channel, Power House & tailrace area (whereever required)
- q)Road from Tshimbulu/Kananga to Project site shall be maintained for smooth transportation of material to project site.

Points to be noted:

- It may be noted that project area lies in the high thundering zone, the sky lightening frequently damage the electronic control cards of equipments/ telecommunication equipments requiring replacement.
- All infrastructure facilities in working condition are required to be handed over to client after successful Commissioning of the project.

2. Diversion Weir:

(a) Construction works:

- (i) Entire Diversion Weir of 426 m (Concrete structure) is to be constructed across Lulua river to divert water.
- (ii) Repair & Restoration of Inlet/Weir Coffer DAM
- (iii) Bridge Construction for crossing river
- (iv) Possible construction of dikes to protect the reservoir to prevent river water from overflowing outside its bed
- (v) Protection of river banks by construction of dikes

(b) Design and drawings

No Drawing has been approved. However, Draft drawings for construction of weir and plan for river diversion are available.

Point(s) to be noted:

The Concrete weir Structure is around 426 m long un-gated concrete weir with a provision of fish ladder in two parts i.e. Left & Right wing and two coffer dams in two stages.

3. Inlet Structure:

The Structure is around 83.00 m long Inlet structure with 10 bays (6.5 m each) & 9 piers (2.0 m each) and 5.50 m wide bridge, u/s coffer dam, Hoisting arrangements for gates etc.

a) Construction works:

Balance Excavation and construction of Inlet Structure is to be taken up.

Maintenance and removal (after construction of Inlet structure) of coffer dam has to be taken up.

b) Design and drawings:

Coffer dam, Excavation drawings have been approved. Pre-approved construction drawings for Inlet structure are available.

4. Power channel:

Construction of lined power channel with gravity / counter fort walls on both banks and bed lining with drainage filters at bottom.

Service roads with parapet walls and railing. Service ramp and Dewatering system are also art of Power channel.

(a) Construction works:

Excavation works are complete except some under cuts in dewatering system.

Balance excavation, Civil works has to be taken up including lining, gravity/counter fort wall, Power channel bed lining work, Service roads with parapet walls, railing and Dewatering system etc.

Stone pitching has to be taken up for slope protection.

(b) Design and drawings:

Power Channel Excavation, concreting, Power Channel Ramp & Retaining Wall drawings have been approved.

Draft Power Channel Dewatering System drawings are available.

5. Power House and Intake structure:

It consists of construction of main building as battery rooms, Machine hall, control rooms etc., Service bay and Intake structure Including Concrete spiral casing.

(a) Construction works:

- Excavation Works are almost Complete for main PH building, Service bay and Power Intake.
- ❖ Concreting works for unit 1 & 2 were completed partially up to EL 621.00 & 620.00 m.
- Concreting work for 1/3rd Service bay raft is to be taken up.

In general entire civil works except above for power house & power intake has to be taken up.

(b) Design and drawings:

- ❖ Power Intake & Power House Excavation, Power House Service Bay Raft and Power House First Stage Concrete drawings have been approved.
- ❖ Power House General Arrangement Plan, power house frame, Power House Draft Tube Deck, Power House Second Stage Concrete Outline Details and Power House Roof Truss are under draft stage.

(C) Dewatering:

- ❖ In service bay back filling concreting work has been completed up to EL 651.70 m and RCC raft 21 m x 21 m have been done up to EL652.95 m.
- ❖ For UNIT-III reinforcement placement has been completed.
- New Contractor shall ensure dewatering and cleaning of the area before starting the concrete work.

6. Tail Race Channel (TRC):

Tail race channel consists of construction of bottom rafts, wall linings Gravity/CF walls, control weir, service roads & with parapet walls and railing, service platforms, protection works and coffer dam.

Construction works:

- **Excavation Works are almost Complete except in some parts.**
- ❖ Concreting works for all the structures of TRC are to be taken up for construction.
- Reconstruction & Maintenance of coffer dam has to be taken up till completion of power house, Control weir and TRC. After completion of these structures coffer dam should be removed.
- Stone pitching has to be taken up for slope protection.
- ❖ TRC outlet/ river junction works are yet to be planned and taken up.

Design and drawings:

Drawings of Tailrace Channel Excavation and Tailrace Channel Concreting have been approved.

Point(s) to be noted:

- Plain cement Concrete (PCC) leveling course for bottom raft in sloping portion has been completed.
- Coffer dam on down stream side of TRC has been completed.
- Part Slope protection on right bank with stone pitching has been completed.

7. Switchyard:

It includes construction of switch yard, Concrete foundations, Control room, Transformer yard, internal roads etc.

(a) Construction works:

Excavation Works as per excavation drawings are almost Complete. Civil works are yet to be taken up.

(b) Design and drawings:

Detail Design & Drawings related to civil works needs to be carried out.

(B) HYDRO-MECHANICAL:

1. General

Scope include design, manufacturing, supply, transportation, erection and commissioning of Hydro-Mechanical equipment.

2. Design Engineering and Manufacturing

Design, Engineering and manufacturing of almost all hydro mechanical equipment has already been carried out.

3. Erection and Commissioning

Erection for all Hydro Mechanical equipment is yet to be taken up.

4. Scope for New Contractor: The list of equipment with their scope for new contractor are given below:

5. Other issues:

- **a)** Though the Air Vent pipe have been designed, manufactured and already supplied to site However, the location of vent pipe required for the Intake emergency gate has to be changed and under review, as the same is passing through power house nearby the transformer.
- **b)** The draft tube gate sensor has to be supplied and the same should be reflected in the control room. The selection of type of sensor and its position are to be taken care of.
- c) Inlet gate storage room/storage area and method of storing has to be finalized.

After the joint inspection to be carried out by PMC and Project Authority Grand Katende and Kakobola (GCK)/Ministry of Energy, GO-DRC at site to check the availability of all concerned HM equipment and their loose items, PMC will recommend the missing, lost or defective loose items to be supplied by new EPC Contractor.

Also, it is proposed that the rubber seals (top seal, side seal and bottom seal) for all the gates shall be replaced with new one. However, the recommendation shall be finalized after the joint inspection carried out by PMC and Project Authority Grand Katende and Kakobola (GCK)/Ministry of Energy, GO-DRC.

(C) SWITCHYARD WORKS:

Complete design, manufacturing, supply, transportation, storage, preservation, erection and commissioning of Switchyard works shall be in the scope of works. Estimated BOQ is given below:

Part II. Instructions to Applicants

A. General

1. Background

1.1 The Export-Import Bank of India (hereinafter called "the Bank"), on behalf of the Government of India (GOI), extends from time-to-time, concessional credit facilities (hereinafter called "Lines of Credit") under the Indian Development and Economic Assistance Scheme (IDEAS) to overseas governments or their nominated agencies (hereinafter called "Borrower or Employer or Project authority"), for financing projects to be executed by Indian entities. Payment by the Bank to the Indian exporters will be made only at the request of the Borrower and upon approval by the Bank, and will be subject, in all respects, to the terms and conditions of the credit (or financing) agreement.

2. Scope of Prequalification

2.1 With reference to the Invitation for Prequalification (IFP) indicated in Part III, Data Sheet (DS), this Application Document ("Application Document") is being issued by the Bank to prospective applicants ("Applicants") interested in submitting applications ("Applications") for prequalification as per the scope described in Part I, Scope of EPC and subject to the provisions of this Application Document.

3. Ethics and Integrity

- 3.1 The Bank requires Applicants to participate in this prequalification process with the highest standards of ethics and integrity. It is strictly forbidden to the parties involved in the prequalification process, by themselves or by a third party, to offer, ask or accept for itself or for a third party, financial or non-financial advantage or even direct or indirect promise or any other acts¹, as offsets for prequalification or bidding or contract award and execution as applicable, if susceptible of being qualified as criminal unlawful acts in accordance with national laws of any party involved.
- 3.2 In pursuance of ITA 3.1 above, Applicants shall permit the Bank to inspect all accounts, records and other documents relating to the submission of the Application, bid submission (in case prequalified), and contract performance (in the case of award), and to have them audited by auditors appointed by the Bank.
- 3.3 If, in accordance with the administrative procedures of the Bank, it is demonstrated that an Applicant in this prequalification process, or during the subsequent bidding for the contract(s) has violated the provisions stated in ITA 3.1 above, the Bank, inter alia,
 - a. shall reject any Application for prequalification or proposal to award a contract in connection with the subsequent procurement process, as applicable; and/or
 - b. may declare an Applicant, temporarily or permanently, ineligible to be awarded future contracts under Bank funding.

¹These acts shall include, but not limited to, corrupt practice, fraudulent practice, collusive practice, coercive practice, obstructive practice, and conflict of interest.

4. Eligibility of Applicants

- 4.1 This prequalification exercise is open to only Indian Applicants in accordance with the provisions of ITA 4.4. Any form of association by the Applicant with ineligible entities either during this prequalification process or subsequent bidding process may be liable for rejection.
- 4.2 For the purpose of applying the eligibility criteria listed in this article 4, "Applicant" would include the single entity or in case of a joint venture ("JV"), each member of the JV, involved or intended to be involved with this prequalification process (as mentioned in Form A.1.2 Applicant's JV Member's Information Form), for any part of the prospective contract(s) including related services.
- 4.3 An Applicant may be a single entity or a combination of entities in the form of a JV either existing or with the intent to enter into a JV supported by a letter of intent or JV Agreement listing out the names of all the JV members. In the case of a JV, all members shall be jointly and severally liable for the execution of the subsequent contract(s) in accordance with the respective contract terms. The JV shall be represented by an authorized representative who shall have the authority from all members of the JV so as to conduct all business for and on behalf of the JV during the prequalification process. The limit on the number of members in a JV would be as specified in the **DS**.
- 4.4 This prequalification exercise is open to only Indian Applicants. An Applicant shall be deemed to be Indian if the Applicant is registered in India and/or incorporated/established under any law in force in India, as evidenced by its articles of incorporation and its registration documents, as the case may be.
- 4.5 An Applicant that has been blacklisted/ debarred/ sanctioned by any multilateral development bank (MDB), such as World Bank, Asian Development Bank, or any authority of GOI or the Borrowing Government in accordance with extant rules and procedures, shall be ineligible to participate in the prequalification/ bidding process as applicable, during such period of time as the sanctioning authority shall have determined. In case the Applicant is blacklisted/ debarred/sanctioned, post the prequalification process (i.e. including during bidding process and/or contract implementation phase), the Applicant shall immediately inform Exim Bank of such blacklisting/debarment/sanction and reasons thereof. This may lead to cancellation of Applicant's prequalification / contract.
- 4.6 The list of debarred firms and individuals by certain leading MDBs is available as specified in the **DS**. This may not be an exhaustive list of debarred entities but those which are made available centrally on the respective MDB's website. Additionally, there could be lists of debarred entities issued by various government departments/ procuring entities/ corporations and maintained offline.
- 4.7 An Applicant shall be ineligible to be prequalified if (a) it is currently under default on any loan to any Bank/ Financial Institution (FI) and its account has

been classified as Non-Performing Asset (NPA) as per Central Repository of Information on Large Credits (CRILC) database; and/or (b) its promoters/directors appear in Negative List, RBI Wilful Defaulter List (Suit filed as well as non-suit filed), Credit Information Bureau India Ltd. (CIBIL) Defaulter List and/or any other negative list of central and/or state government agencies, updated from time-to-time. On being included in any of the above lists post the prequalification process (i.e. including during bidding process and/or contract implementation phase), the Applicant shall immediately inform Exim Bank on the inclusion and reasons for inclusion thereof. This may lead to cancellation of Applicant's prequalification / contract.

4.8 An Applicant shall (i) be eligible with respect to the provisions of Public Procurement Orders Nos. 1 & 2 dated July 23, 2020, Public Procurement Order No. 3 dated July 24, 2020 and Public Procurement Order No. 4 dated February 23, 2023 issued by the Public Procurement Division of the Department of Expenditure, Ministry of Finance, Government of India; and (ii) furnish such evidence of eligibility satisfactory to the Bank, as the Bank shall reasonably request

B. Composition of the Application Document

5. Contents of this Document

5.1 This Application Document consists of the Parts indicated below, and which should be read in conjunction with any Corrigendum issued in accordance with ITA 7.

• Part I. Scope of EPC

• Part II. Instructions to Applicants (ITA)

• Part III. Data Sheet (DS) to ITA

• Part IV. Prequalification Criteria and Requirements

- 5.2 Unless obtained directly from the Bank, the Bank shall not be responsible for the completeness of the document, responses to requests for clarification, or Addenda to the Application Document in accordance with ITA 7. In case of any discrepancies, documents issued directly by the Bank shall prevail.
- 5.3 An Applicant is expected to study all instructions, and forms in the Application Document and to furnish with its Application all information or documentation as is required by the Application Document.

6. Clarifications

6.1 A prospective Applicant requiring any clarification of the Application Document shall contact the Bank in writing at the Bank's address indicated in the **DS**. The Bank will respond in writing to any request for clarification provided that such request is received no later than fourteen (14) days prior to the deadline, or any extension thereof, for submission of the applications. The Bank's response, at its discretion, may be uploaded on its website and shall include a description of the inquiry (without identifying its source) and corresponding clarification. As a result of a clarification the Bank may, if necessary, amend the Application Document in accordance

with the provisions of ITA 7.

- 6.2 Any modification to the Application Document that may become necessary as a result of the clarifications to the queries shall be made by the Bank exclusively through the use of a Corrigendum pursuant to ITA 7.
- 7. Corrigendum of Application Document
- 7.1 At any time prior to the deadline for submission of Applications, the Bank may amend the Application Document by issuing a Corrigendum.
- 7.2 Any Corrigendum or Addenda issued shall be deemed to be part of the Application Document and shall be published on the Bank's website.
- 7.3 Post Corrigendum, in order to allow sufficient time to the prospective Applicants in preparing their Applications, or for other good reason, the Bank may, at its discretion, extend the deadline for the submission of Applications in accordance with ITA 16.2.

C. Preparation, Submission and Opening of Applications

- 8. Cost towards

- 8.1 The Applicant shall bear all costs associated with the preparation and submission of its Application. The Bank will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the prequalification process.
- 9. Language
- 9.1 The Application documentation and printed literature that are part of the Application, if in another language, shall be accompanied by an accurate translation of the relevant passages in English language, which shall be the governing language.
- 10. Documents constituting the Application
- 10.1 The Application shall comprise the following:
 - (a) Application Submission Form, in accordance with ITA 11.1;
 - (b) documentary evidence establishing the Applicant's eligibility, in accordance with ITA 12.1;
 - (c) documentary evidence establishing the Applicant's qualifications, in accordance with ITA 13; and
 - (d) any other document required as specified in the **DS**.
- 11. Application Submission Form
- 11.1 The Applicant shall complete an Application Submission Form as provided in Part V (Forms). This Form must be completed without any alteration to its format.
- 12. Documents

- 12.1 To establish its eligibility in accordance with ITA 4, the Applicant shall complete the eligibility declarations in the Application Submission Form and Forms A.1.1 and A.1.2, included in Part V (Forms).
- 13. Documents

- 13.1 To establish its qualifications in accordance with Part IV, Prequalification
 Criteria and Requirements, the Applicant shall provide the information

requested in the corresponding Forms included in Part V without any alteration to the format. Applicant shall also complete the Questionnaire included in Part VI without any alteration to the questions. Each Form included in Part V and the Questionnaire in Part VI shall be duly signed by the authorized representative of the Applicant. In case of JV, authorized representative of the respective member shall sign. Non-compliance with this clause may result in summary rejection of the Application.

- **13.2** If an Applicant does not manufacture or produce the goods it offers to supply, it shall submit documentation related to Manufacturer's Authorisation as specified in the **DS**.
- 13.3 Wherever a monetary amount is to be stated, Applicant should indicate the USD equivalent using the rate of exchange determined as follows:
 - (a) Exchange rates shall be taken from the publicly available source identified in the **DS**. Any error in determining the exchange rates in the Application may be corrected by the Bank during evaluation;
 - (b) For data related to financial statements, the amounts shall be mentioned in Indian Rupees (INR). Equivalent amount in USD shall be arrived at using the exchange rate as on 31st March of respective financial year as specified in the **DS**;
 - (c) for data related to Liquidity, Annual Residual Contract Value and contracts signed in the current financial year, unless otherwise specified in the **DS**, the exchange rate prevalent as on the working day preceding the date of Invitation for Prequalification (IFP) shall be used to arrive at the USD equivalent as specified in the **DS**; and
 - (d) for contracts signed prior to the current financial year, the exchange rate as on 31st March of the respective financial year in which the contract was signed shall be used to arrive at the USD equivalent as specified in the **DS**.

14. Authorized Signatory and Number of Copies

14.1 The Applicant shall prepare one original of the documents comprising the Application as described in ITA 10 and clearly mark it "ORIGINAL". The original of the Application shall be typed or written in indelible ink and shall be signed by a person duly authorized to sign on behalf of the Applicant. In case the Applicant is a JV, the Application shall be signed by all members of the JV.

15. Preparing the Application Envelope

- 15.1 The Applicant shall enclose the original Application in a sealed envelope that shall:
 - (a) be addressed to the Bank, as per ITA16.1;
 - (b) mention the name and address of the Applicant; and
 - (c) mention the specific identification of this prequalification process indicated in the **DS** ITA2.1.
- 15.2 The Bank will accept no responsibility for not processing any envelope that was not prepared as required in ITA 15.1 above.

16. Application Submission Deadline

16.1 Applicants must submit their Applications in dual mode (on-line as well as off-line). Applications shall be received by the Exim Bank at the address and no later than the deadline indicated in the **DS.**

16.2 The Bank may, at its discretion, extend the deadline for the submission of Applications by amending the Application Document in accordance with ITA 7.

17. Late Applications

17.1 Applications received after the deadline for submission of applications shall not be admissible, and if received, shall be returned unopened to the Applicant.

18. Opening of Applications

18.1 The Bank shall open all Applications at the date, time and place specified in the **DS**. Applicants' representatives may be present during opening.

D. Procedures for Evaluation of Applications

19. Evaluation to be Confidential

- 19.1 Information relating to the Applications, their evaluation and result shall be confidential and will not be disclosed to Applicants or any other person(s) not officially concerned with the prequalification process until the official notification of prequalification results is made in accordance with ITA 25.
- 19.2 From the deadline for submission of Applications to the time of notification of the results of the prequalification in accordance with ITA 25, any Applicant who wishes to contact the Bank on any matter related to the prequalification process (except as specified in ITA 20.1 below), may do so only in writing. Canvassing in any form will be grounds for disqualification.

20. Clarifications during Evaluation

- 20.1 During the evaluation of Applications, in case of ambiguity, the Bank may, at its discretion, ask an Applicant for a clarification of its Application, to be submitted within a stated reasonable period of time. Any request for clarification from the Bank and all clarifications from the Applicant shall be in writing. Any clarification submitted by an Applicant that is not in response to a request by the Bank may not be considered.
- 20.2 If an Applicant does not provide (within the time allowed) clarifications and/or documents requested as per the Bank's request for clarification, its Application shall be evaluated based on the information and documents available at the time of evaluation of the Application.

21. Determination of Responsiveness of Applications

21.1 The Bank may reject any Application which is not responsive to the requirements of the Application Document and may not subsequently be made responsive by correction of the causes of non-responsiveness or by substitution or resubmission of the Application or part thereof.

E. Evaluation of Applications and Prequalification of Applicants

22. Evaluation of Applications

- 22.1 The Bank shall use the criteria and requirements defined in Part IV, Prequalification Criteria and Requirements, to evaluate the qualifications of the Applicants, and no other methods, criteria, or requirements shall be used. The Bank reserves the right to waive minor deviations from the prequalification criteria if they do not materially affect the technical capability and financial resources of an Applicant to perform the contract.
- The qualification and experience of sub-contractor(s), if any, proposed by the Applicant will not be considered for evaluation of the Application.
- 22.3 Only the qualifications of the Applicant, in the capacity as prime contractor/ member of JV to the Project authority, shall be considered. In particular, the qualifications of parent or subsidiary or any other affiliated company of the Applicant, who is not member of the JVCA except as permitted by ITA 4.3, shall not be considered.
- 22.4 The qualification and experience of the Applicant for execution of supplies/ works/ contracts in-house or for a parent/ promoter/ subsidiary/group concerns or for Special Purpose Vehicles (SPVs), set up by the Applicant or its group companies, either singly or in JV/ consortium, shall not be considered, except in case of supplies/ works/ services/ contracts awarded or assigned by ministry or its department of Government of India. However, the experience of the SPV can be considered in favour of the Applicant provided it is established through documentary evidence that the SPV was established by the Applicant pursuant to a concession granted/ requirement stipulated by the Project Authority who is unrelated to both the Applicant and the SPV and the Letter of Acceptance of bid/ Letter of Award was issued by the Project Authority in favour of the Applicant or a JV/ consortium comprising the Applicant. Further, the FAC issued by the Project Authority should indicate that the project was completed by the said SPV. Certificate from the SPV or Project Authority indicating that the project was executed by the Applicant or JV/ consortium comprising the Applicant as the EPC contractor indicating inter alia, the detailed scope, period and value as per the requirements stated in the relevant section of this document should also be submitted by the Applicant.

23. Bank's Right to Accept or Reject Applications

- 23.1 The Bank reserves the right to accept or reject any Application, and to annul the prequalification process and reject all Applications at any time, without thereby incurring any liability to the Applicants.
- 24. Prequalification of Applicants
- 24.1 All Applicants, whose Applications substantially meet or exceed the specified qualification requirements, will be prequalified by the Bank.

25. Notification of Prequalification

- 25.1 The Bank shall notify the result of the prequalification process through a letter to the prequalified Applicants and to the applicants not meeting the prequalification criteria.
- 25.2 Applicants that have not been prequalified may write to the Bank no later than 7 calendar days after the date of intimation by the Bank, of the result of prequalification, to request clarifications regarding the grounds on which they were not prequalified.

26. Subsequent Invitation for Bids

The lead partner of the JV shall be the one with the highest share in the JV which shall not be less than 26%. The maximum number of other members in the JV shall be such that each of the other members should have at least 20% share. In case there are two partners in the JV, the Lead Partner should have at least 51% share. The JV can be either an incorporated JV company or an unincorporated consortium/ association [JVCA or JV] based on a memorandum of understanding. In case of unincorporated JVCA, the share shall be determined based on the share in the proceeds of the contract [in terms of percentage] being bid for. In other words, if prequalified and invited to bid, the share of JV members in the contract in terms of value shall be in the proportion as stated above.

The Letter of Intent to enter into a JV or JV agreement should contain, inter alia, the following:

- Names of the Lead Partner and each of the other members
- Percentage share of each JV member
- Confirmation of Joint and Several Liability of all members of the JV

The JV is permissible at prequalification Stage only. The JV which is prequalified will be sustained for the entire bidding process. JV among prequalified EPC Contractors and non–prequalified EPC Contractors or any other entity is not allowed subsequent to prequalification stage. No change of JV members or change in percentage (%) of share in JV is allowed subsequent to prequalification. A member of JVCA shall not be permitted to participate either in individual capacity or as a member of another JVCA in the same contract package in a prequalification process.

In the event of award of final contract to any JVCA, all the payments to the JVCA shall be made to the bank account of the JVCA and not to the account of individual member(s).

The Joint Venture Agreement shall in all respect be governed by and interpreted in accordance with Indian Laws.
