

Addendum to the PQ Application Document for selection of Engineering Procurement Construction (EPC) Contractor for Stung Sva Hab Water Resources Development Project, Cambodia

2. Purpose

Based on the representations received by Exim Bank and discussions in the Pre-PQ meeting held on May 30, 2025, this addendum is issued to amend the following:

- a) 2.12 Specific Experience: Correction in referencing
- b) 2.9 Financial Status and Capacity: Replacement of EPC Revenue with Works Revenue.
- c) 1.2.5 Processing Fees: Waiver of PQ Fees for applicants who had previously submitted Application under PQ Ref. No. GOILOC-202(P-1)/Cambodia/EPC-99

3. Changes in the PQ

3 (a) Changes in Instructions to Applicants (ITA) Clause 2.12.2 pertaining to correction in referencing:

For meeting the requirements stipulated in clause 2.11.1 b., the Specific Experience of all the Members of JV on a cumulative basis would be considered.</p>	<p>2.12.2</p> <p>In addition to the above requirements stipulated in clause 2.12.1 a. above, in case of JV, each member of JV shall demonstrate experience of at least one completed contract of value not less than 50% of the value indicated under Option I in clause 2.12.1 a. above. For meeting the requirements stipulated in clause 2.12.1 b., the Specific Experience of all the Members of JV on a cumulative basis would be considered.</p>

3 (b) Replacement of EPC Revenue with Works Revenue:

All references to “EPC Turnover” or “EPC Revenue” are to be replaced and read as “Works Revenue”.

It is hereby clarified that Works Revenue shall include revenue generated from all kinds of Works irrespective of the mode of execution such as EPC, Item Rate, Lump Sum etc.

3 (c) Waiver of PQ Fees under Clause 1.2.5

Following to be inserted after end of Clause:

"The applicants who had submitted the applications under the previous PQ GOILOC-202(P-1)/Cambodia/EPC-99, and paid the processing fees for the same, are not required to pay the processing fees again while applying for the current PQ. The evidence of remittance of the Processing Fees for the previous PQ ID as stated above shall be submitted by the applicant as evidence of payment of the processing fees."

4. Instructions to Applicants

- a) This addendum is being issued in accordance with the provision of the PQ Application Document and forms an integral part of the PQ Application Document.
- b) Except for the changes specified under Para 3 above, all other terms and conditions of the PQ Application Document shall remain unchanged.
- c) It is clarified that the Applications shall only be accepted in online mode in accordance with clause no. 3.7 of the PQ document. Application through any other mode shall not be entertained and evaluate.
