

Invitation of Bids from Indian Companies

The Government of Guyana has received a Line of Credit from the *Export-Import Bank of India* towards the cost of *Fixed and Mobile High Capacity Drainage Pumps and Associated Structures/Equipment*, and it intends to apply part of the proceeds of this credit to payments under the contract for the *Design, Supply, Installation and Commissioning of Nine Fixed and Five Mobile High Capacity Drainage Pumps and Associated Structures/Equipment*.
