Q3. Cutoff marks for the final selection in final list. (only Law Stream)	Cut off marks for final selected candidate law stream is 68.6 #
Q4. Have you considered all those student which are not come in any reservation list in making your final list? (only Law Stream)	Performance of all the candidate is considered while making final list.
