The objectives of Exim Bank include “providing financial assistance to exporters and importers, and functioning as the principal financial institution for coordinating the working of institutions engaged in financing export and import of goods and services with a view to promoting the international trade”. In line with the above mandate, Exim Bank has been part financing the requirements of the exporters and importers based at Mysore from time to time. In its role as the principal financial institution coordinating the working of other institutions facilitating international trade, Exim Bank has been conducting programmes / workshops / seminars on the various financing avenues available to the corporates, including the MSMEs. Accordingly, Exim Bank has conducted 51 such programmes / workshops / seminars along with other stakeholders during the years 2009-2018 in the State of Karnataka.</p>
