

Annexure

KYC/AML- Export-Import Bank of India

Export-Import Bank of India (Exim Bank) was set up by an Act of Parliament (The Export-import Bank of India Act 1981, No. 28 of 1981) and is wholly owned by the Government of India.

Exim Bank is an All India term Lending Institution. The Bank's clients, who are extended funded/non-funded facilities, are predominantly corporate borrowers (or their overseas wholly owned subsidiaries / joint ventures). These borrowers are registered with the Registrar of Companies in terms of the Companies Act, and they provide copies of the Memorandum and Articles of Association (Constitutional documents), which are public documents. The Bank insists upon the said constituent documents as also copies of the resolutions passed by the Board of Directors of the corporate borrowers and other supporting documents including loan documents executed under the common seal of the company, or by the duly authorized Directors/Officers of the company for the purpose of availing facilities from the Bank. All payments to the borrowers for any amount are only effected by the Bank by electronic means (RTGS/NEFT/SWIFT) in favour of the corporate through their bankers. Also, Exim Bank is not a commercial bank and does not undertake any retail cash transactions including issuance of travellers cheques / money orders/ demand drafts etc.
