In terms of the Department of Commerce (DOC), Ministry of Commerce & Industry (MOCI), Government of India (GOI)'s Office Order No. A-12022/45/2014-E.IV (Pt. II) dated October 30, 2023 and Order File No. 6/6/2011-EMDA-PartFile dated November 14, 2023, ECGC Ltd. (ECGC), vide its letter dated November 16, 2023, nominated Shri.
