

1. EXECUTIVE SUMMARY

Introduction

The Latin America and the Caribbean (LAC) region occupies a significant portion in the global economy. The region has weathered through several crises including the Latin American debt crisis, Argentine economic crisis, and the Mexican peso crisis. In the course of these crises, most economies in the region have traversed through a series of economic changes, including decentralization of operations, reorganization of production, and reinforcement of scientific management and strategic planning. Today, most economies in this region exhibit strong macroprudentials and have the ability to conduct countercyclical policies.

Economic Environment of the LAC Region

According to the International Monetary Fund (IMF), economic activity in LAC continued to weaken in 2014, with a growth of 1.3 percent, mainly resulting from a slower Chinese economy, and shrinking investments. The weakness was concentrated in South America, where falling commodity prices reinforced a generalized sense of leaner times, weighing down on private demand. Domestic policy uncertainties further depressed confidence in some countries.

The majority of Latin American economies are large commodity producers. As a result, the sharp fall in most commodity prices since mid-2014 (aggravated by concerns about growth in China) has stoked market fears about the economic outlook in Latin America, which in many cases has deepened the sell-off of local

currencies. The collapse in oil prices has hit the region's main oil producers (Venezuela, Mexico, Colombia and Ecuador), but with global metal prices and agricultural prices also down sharply, metal producers such as Chile, Peru and Bolivia, and agricultural producers such as Brazil and Argentina, have been affected.

Many Latin American economies have been affected by currency volatility since mid-2014, when speculation about the beginning of a monetary tightening cycle in USA and a fall in global commodity prices prompted most local currencies to depreciate. The Colombian peso hit a record low of Ps 3,261: US\$ 1 in August, compared with around Ps 1,900: US\$ 1 a year earlier, making it among the world's worst-performing currencies (along with the Russian rouble and the Ukrainian hryvnia). The Brazilian real has also hit a record low against the US dollar in late August, when the currency was trading at R 3.67: US\$ 1. Meanwhile, the Mexican peso also fell to new depths, breaching Ps 17: US\$ 1 for the first time at the end of the month, while the Chilean peso broke through Ps 700: US\$ 1, a level last breached in 2003.

Inflation has increased across the region as rising import costs are passed on to consumers through higher retail prices. In fact, inflation is already above target levels in many countries, recording 9.6 percent in Brazil (compared to a targeted 4.5 percent), 4.6 percent in Chile (compared with a 2-4 percent target range) and 4.5 percent in Colombia (compared with a 2-4 percent target range). Mexico is the only major Latin American economy in which inflation has remained subdued.

Near-term prospects remain fairly dim for South America, with output contractions projected in three of the largest economies (Argentina, Brazil. and Venezuela) for 2015, while only Chile and Peru are expected to see a pick-up in growth. Weakness in commodity prices, perhaps related to a more pronounced deceleration of investment in China, is expected to heighten pressures on South America's net commodity exporters. Elsewhere in LAC, growth is projected to be steady (Central America and the Caribbean) or strengthen (Mexico), supported by lower oil bills for importers and push up in demand, as a result of robust economic recovery in USA. On balance, regional growth is expected to decline for a fifth consecutive year, bottoming out at just below 1 percent before staging a moderate recovery in 2016.

Recent Trends in LAC's Foreign Trade

The LAC region is characterized by large markets, host of trading blocs, and its close access to USA and European economies. The LAC region, which comprises 43 countries, accounts for about 11.6 percent of world trade in 2014.

Global trade of LAC has witnessed upward trend in recent years. In fact, during the last decade, LAC's total trade (exports + imports) has risen two-fold, from US\$ 1084.8 billion in 2005 to US\$ 2179.6 billion in 2014, underlined by buoyant exports and imports.

The region participated actively in multilateral trade negotiations, embarked on North-South trade agreements with developed countries and, more recently, witnessed a boom of South-South trade, fueled by the rise of China and other emerging economies and the related rising demand for commodities. As a result, LAC trade

expansion consistently exceeded GDP growth, and functioned as an effective engine of growth until the 2008-2009 global financial crisis had put a brake on rising trade. LAC's total trade revived in 2010, and were seen at levels higher than the pre-crisis period, stemming from South-South trade, which has emerged as the main driver of LAC trade performance. However, in 2014, slow down of growth in LAC's major emerging trading partners such as China, coupled with falling commodity prices, had moderated LAC's total trade, which was seen at US\$ 2179.6 million.

In the case of exports, LAC's total exports have risen from US\$ 570.9 billion in 2005 to US\$ 1068.6 billion in 2014. LAC's exports, after registering a decline in 2009 owing to the global crisis, rebounded thereafter to reach US\$ 1106 billion in 2012. However, weak external demand conditions particularly from USA and the European Union which are the main markets for exports, coupled with fall in commodity prices, affected LAC's global exports, resulting in moderating exports in 2014. During the same year, LAC's exports constituted 5.7 percent of global exports.

As regards imports, LAC's total imports have also witnessed a steady growth, increasing more than two-fold, from US\$ 513.9 billion in 2005 to US\$ 1111.1 billion in 2014. In 2014, LAC's imports constituted 5.9 percent of global imports, up from 4.8 percent in 2005. LAC generally maintains a trade surplus, barring a few years. The fall in exports relative to imports during 2014 resulted in an increased deficit of US\$ 42.5 billion during the year.

Mineral fuels, which mainly comprise petroleum crude are the largest export items from LAC, accounting for as much as 20.2 percent of

LAC's total exports in 2014. Other major items of exports from LAC include transport vehicles (9.9 percent of the total exports); electrical and electronic equipment (8.5 percent); machinery and instruments (7.2 percent); ores, slag and ash (6.4 percent); pearls and precious stones, etc (2.7 percent); and copper and articles (2.6 percent).

LAC's import basket is relatively diversified. Mineral fuels and petroleum products (14.4 percent of the total imports); electrical and electronic equipment (14.2 percent); machinery (14 percent); transport vehicles (8.8 percent); and plastics and articles thereof (4.6 percent) are among the largest import items in 2014.

India's Trade Relations with LAC

With the increasing diversification of India's global trade towards other developing countries, the LAC region has emerged as an important partner for India, both as export destination as also import source. This is reflected in the synergy in bilateral trade relations wherein India's total trade with LAC has risen more than nine-fold, from US\$ 5.2 billion in 2005 to touch US\$ 49.1 billion in 2014.

Underlying the robust trend in total trade has been the significant rise in both India's exports to as also India's imports from LAC, with the latter having risen faster than the former. While India's total exports to LAC have risen from US\$ 2.8 billion in 2005 to US\$ 15.5 billion in 2014, depicting more than a five-fold rise during the period, India's total imports from LAC have also risen significantly from US\$ 2.4 billion to US\$ 33.6 billion during the same period. As a result, India's trade balance with LAC, which stood at a surplus of US\$ 0.5 billion in 2005, has turned into a deficit in recent years, amounting to a trade deficit of US\$ 18.1 billion in 2014.

India's major export items to LAC include mineral products (28.7 percent of the total exports); vehicles (15.9 percent); organic chemicals (5.3 percent); pharmaceutical products (4.4 percent), and machinery (3.7 percent), with a combined share of 58 percent of India's total exports to LAC in 2014. Other important items of India's exports to LAC include iron and steel; aluminum and articles; miscellaneous chemical products; cotton; and manmade filaments, among others.

Brazil is India's largest export destination in LAC, accounting for around 46 percent of India's total exports to LAC in 2014, up from 34.3 percent in 2005. Other major export markets in LAC include Mexico (18.8 percent of the total exports), Colombia (7.3 percent), Peru (4.9 percent), and Chile (4 percent).

Reflecting the increased importance of the LAC region as source for India's crude oil imports, mineral fuels (HS-27) are the largest items in India's import basket from LAC, accounting for as much as 72 percent of India's total imports from LAC in 2014. Other important items of imports from LAC include ores, slag and ash; animal, vegetable fats and oils; pearls and precious stones; sugar and sugar confectionery; and iron and steel. Venezuela is the largest import source, followed by Brazil, Colombia, Mexico, and Chile.

Underlying the robust trend in bilateral trade between India and LAC, which has risen more than nine-fold, from US\$ 5.2 billion in 2005 to touch US\$ 49.1 billion in 2014, has been the rising trend in India's trade deficit with LAC. India's trade balance with LAC, which stood at a surplus of US\$ 457.9 million in 2005, flipped to a deficit of US\$ 1.2 billion in 2006. India's trade balance with the LAC region has been in deficit since then, and reached a high of US\$ 18.1 billion in 2014.

Amongst the major trade partners with which India maintains a trade deficit, the largest countries are Venezuela, Chile, Colombia and Argentina. In the case of Venezuela and Colombia, large and rising volume of crude imports have underlined India's rising trade deficit. In the case of Chile, large imports of ores and concentrates have resulted in a huge trade deficit. India's rising imports of vegetable fats and oil from Argentina has resulted in widening of trade deficit with Argentina.

Enhancing Bilateral Trade Relations with Select Countries in LAC

To further enhance India's trade with the LAC region, and at the same time to address the rising trade deficit, an important strategy would be to focus on India's export potential to the major importing countries in LAC. Such as strategy would require

- Identification of major items of imports of select focus markets, and share of India in each product line of imports, based on 2-digit HS commodity code
- Selection of potential items of India's exports
 to each of the focus markets, based on low
 share of India in target country's import basket
 of major commodities, keeping in view India's
 global export capability. This would entail
 identification of potential export items to each
 focus market, under each 2-digit HS code,
 upto 6-digit HS commodity code

Potential items of India's exports to Mexico would include Electrical and electronic equipment (HS-85); Machinery and instruments (HS-84); Vehicles other than railway, tramway (HS-87); Mineral fuels, oils, distillation products, etc (HS-27); Plastics and articles (HS-39); Organic chemicals (HS-29);

Iron and steel (HS-72); Articles of iron or steel (HS-73); Pharmaceutical products (HS-30); Meat and edible meat offal (HS-02); Cereals (HS-10).

Potential exports from India to Brazil identified at 2-digit HS code classification are Machinery and instruments (HS-84); Electrical and electronic equipment (HS-85); Vehicles other than railway, tramway (HS-87); Organic chemicals (HS-29); Pharmaceutical products (HS-30); Articles of iron or steel (HS-73); Iron and steel (HS-72); Cereals (HS-10).

Potential items of exports from India to Chile based on Chile's import demand and India's comparative advantage, have been identified using 2-digit HS code classification would include Mineral fuels, oils, distillation products, etc (HS-27); Machinery and instruments (HS-84); Vehicles other than railway, tramway (HS-87); Electrical and electronic equipment (HS-85); Plastics and articles (HS-39); Articles of apparel, accessories, not knit or crochet (HS-62); Iron and steel (HS-72); Pharmaceutical products (HS-30); Meat and edible meat offal (HS-02).

Potential items identified at 2-digit HS code classification for Argentina would include Vehicles other than railway, tramway (HS-87); Organic chemicals (HS-29); Machinery and instruments (HS-84); Electrical and electronic equipment (HS-85); Pharmaceutical products (HS-30); Plastics and articles (HS-39); Articles of iron or steel (HS-73); Cotton (HS-52).

In order to bridge India's trade deficit with Colombia, potential exports from India to Colombia have been identified at 2-digit HS code which include Iron and steel (HS-72); Organic chemicals (HS-29); Plastics and articles (HS-39); Machinery

and instruments (HS-84); Pharmaceutical products (HS-30); Electrical and electronic equipment (HS-85); Articles of apparel, accessories, not knit or crochet (HS-62).

Potential exports from India to Peru, identified at 2-digit HS code classification would include Machinery and instruments (HS-84); Mineral fuels, oils, distillation products, etc (HS-27); Electrical and electronic equipment (HS-85); Vehicles other than railway, tramway (HS-87); Cereals (HS-10); Articles of iron or steel (HS-73); Organic chemicals (HS-29).

In order to bridge India's deficit with Venezuela, strategy would involve increased exports from India, based on Venezuela's import demand, as well as India's global capability. Such products identified at 2-digit HS code classification would include Machinery and instruments (HS-84); Electrical and electronic equipment (HS-85); Vehicles other than railway, tramway (HS-87); Organic chemicals (HS-29); Miscellaneous chemical products (HS-38).

Potential exports from India to Guatemala identified at 2-digit HS code classification would include Machinery and instruments (HS-84); Electrical and electronic equipment (HS-85); Pharmaceutical products (HS-30); Iron and steel (HS-72); Organic chemicals (HS-29); Articles of iron or steel (HS-73).

India maintains a trade deficit with Ecuador. Therefore, in order to bridge the deficit by way of increasing India's exports to Ecuador, potential items of exports at 2-digit HS code classification have been identified as Mineral fuels, oils, distillation products, etc (HS-27); Machinery and

instruments (HS-84); Electrical and electronic equipment (HS-85); Vehicles other than railway, tramway (HS-87); Plastics and articles (HS-39); Pharmaceutical products (HS-30); Articles of iron or steel (HS-73); Organic chemicals (HS-29).

India's share in Dominican Republic's global imports was low at 0.8 percent in 2014. Potential exports from India to Dominican Republic identified at 2-digit HS code classification are Electrical and electronic equipment (HS-85); Plastics and articles (HS-39); Machinery and instruments (HS-84); Vehicles other than railway, tramway (HS-87); Cotton (HS-52); Articles of iron or steel (HS-73).

Potential exports from India to Costa Rica, identified at 2-digit HS code classification are Vehicles other than railway, tramway (HS-87); Pharmaceutical products (HS-30); Machinery and instruments (HS-84); Organic chemicals (HS-29); Electrical and electronic equipment (HS-85); Articles of apparel, accessories, knit or crochet (HS-61); Iron and steel (HS-72).

Potential exports to Panama, based on the import demand as well as India's comparative advantage at 2-digit HS Code have been identified as Machinery and instruments (HS-84); Vehicles other than railway, tramway (HS-87); Electrical and electronic equipment (HS-85); Articles of iron or steel (HS-73); Iron and steel (HS-72); Pharmaceutical products (HS-30); Cereals (HS-10).

Potential items of exports to Paraguay identified at 2-digit HS code classification would include Mineral fuels, oils, distillation products, etc (HS-27); Electrical and electronic equipment (HS-85) Machinery and instruments (HS-84); Vehicles

other than railway, tramway (HS-87); Iron and steel (HS-72); Pharmaceutical products (HS-30); Organic chemicals (HS-29); Articles of iron or steel (HS-73).

Potential exports from India to Uruguay identified at 2 digit HS code classification would include Mineral fuels, oils, distillation products, etc (HS-27); Electrical and electronic equipment (HS-85); Vehicles other than railway, tramway (HS-87); Plastics and articles (HS-39); Pharmaceutical products (HS-30); Organic chemicals (HS-29); Articles of iron or steel (HS-73); Iron and steel (HS-72).

Potential exports from India to El Salvador at 2-digit HS code classification have been identified as Electrical and electronic equipment (HS-85); Machinery and instruments (HS-84); Vehicles other than railway, tramway (HS-87); Cotton

(HS-52); Pharmaceutical products (HS-30); Iron and steel (HS-72); Articles of apparel, accessories, knit or crochet (HS-61); Cereals (HS-10); Articles of iron or steel (HS-73).

India's Initiatives to Enhance Bilateral Trade Relations with LAC

With a view to facilitate and further enhance bilateral trade and commercial relations with countries in the LAC region, India has put in place important policy measures as also institutional frameworks to create an enabling trade and business environment. Major policy initiatives and institutional frameworks include, among others, Focus LAC Programme, IBSA Initiative, India-LAC Partnership Conclaves, PTA with MERCOSUR and Chile, etc. India has recently also been granted 'Observer' status in the emerging grouping, the New Pacific Alliance.

1. REGIONAL ECONOMIC DEVELOPMENTS IN LATIN AMERICA AND THE CARIBBEAN REGION

The Latin America and the Caribbean (LAC) region occupies a significant portion in the global economy. The region has weathered through several crises including the Latin American debt crisis, Argentine economic crisis, and the Mexican peso crisis. In the course of these crises, most economies in the region have traversed through a series of economic changes, including decentralization of operations, reorganization of production, and reinforcement of scientific management and strategic planning. Today, most economies in this region exhibit strong macroprudentials and have the ability to conduct countercyclical policies.

Economic Environment of the LAC Region

According to the International Monetary Fund (IMF), economic activity in LAC continued to weaken in 2014, with a growth of 1.3 percent, mainly resulting from a slower Chinese economy, and shrinking investments (**Table 1.1**). The weakness was concentrated in South America, where falling commodity prices reinforced a generalized sense of leaner times, weighing down on private demand. Domestic policy uncertainties further depressed confidence in some countries.

The majority of Latin American economies are large commodity producers. As a result, the sharp fall in most commodity prices since mid-2014 (aggravated by concerns about growth in China) has stoked market fears about the economic outlook in Latin America, which in many cases has deepened the sell-off of local

currencies. The collapse in oil prices has hit the region's main oil producers (Venezuela, Mexico, Colombia and Ecuador), but with global metal prices and agricultural prices also down sharply, metal producers such as Chile, Peru and Bolivia, and agricultural producers such as Brazil and Argentina, have been affected.

Many Latin American economies have been affected by currency volatility since mid-2014, when speculation about the beginning of a monetary tightening cycle in USA and a fall in global commodity prices prompted most local currencies to depreciate. The Colombian peso hit a record low of Ps 3,261: US\$ 1 in August, compared with around Ps 1,900: US\$ 1 a year earlier, making it among the world's worst-performing currencies (along with the Russian rouble and the Ukrainian hryvnia). The Brazilian real has also hit a record low against the US dollar in late August, when the currency was trading at R 3.67: US\$ 1. Meanwhile, the Mexican peso also fell to new depths, breaching Ps 17: US\$ 1 for the first time at the end of the month, while the Chilean peso broke through Ps 700: US\$ 1, a level last breached in 2003.

Inflation has increased across the region as rising import costs are passed on to consumers through higher retail prices. In fact, inflation is already above target levels in many countries, recording 9.6 percent in Brazil (compared to a targeted 4.5 percent), 4.6 percent in Chile (compared with a 2-4 percent target range) and 4.5 percent in Colombia (compared with a 2-4 percent target

range). Mexico is the only major Latin American economy in which inflation has remained subdued.

Outlook

Near-term prospects remain fairly dim for South America, with output contractions projected in three of the largest economies (Argentina, Brazil, and Venezuela) for 2015, while only Chile and Peru are expected to see a pick-up in growth. Weakness in commodity prices, perhaps related

to a more pronounced deceleration of investment in China, is expected to heighten pressures on South America's net commodity exporters. Elsewhere in LAC, growth is projected to be steady (Central America and the Caribbean) or strengthen (Mexico), supported by lower oil bills for importers and push up in demand as a result of robust economic recovery in USA. On balance, regional growth is expected to decline for a fifth consecutive year, bottoming out at just below 1 percent before staging a moderate recovery in 2016.

2. RECENT TRENDS IN LAC'S FOREIGN TRADE

The LAC region is characterized by large markets, host of trading blocs, and its close access to USA and European economies. The LAC region, which comprises 43 countries, accounts for about 11.6 percent of world trade in 2014.

Global trade of LAC has witnessed upward trend in recent years. In fact, during the last decade,

LAC's total trade (exports +imports) has risen two-fold, from US\$ 1084.8 billion in 2005 to US\$ 2179.6 billion in 2014, underlined by buoyant exports and imports (**Table 2.1 and Chart 2.1**).


The region participated actively in multilateral trade negotiations, embarked on North-South trade agreements with developed countries

and, more recently, witnessed a boom of South-South trade, fueled by the rise of China and other emerging economies and the related rising demand for commodities. As a result, LAC trade expansion consistently exceeded GDP growth, and functioned as an effective engine of growth until the 2008-2009 global financial crisis had put a brake on rising trade. LAC's total trade revived in 2010, and were seen at levels higher than the pre-crisis period, stemming from South-South trade, which has emerged as the main driver of LAC trade performance. However, in 2014, slow down of growth in LAC's major emerging trading partners such as China, coupled with falling commodity prices, had moderated LAC's total trade, which was seen at US\$ 2179.6 million.

In the case of exports, LAC's total exports have risen from US\$ 570.9 billion in 2005 to US\$ 1068.6 billion in 2014. LAC's exports, after registering a decline in 2009 owing to the global crisis, rebounded thereafter to reach US\$ 1106 billion in 2012. However, weak external demand conditions particularly from USA and the European Union which are the main markets for exports, coupled with fall in commodity prices affected LAC's global exports, resulting in moderating exports in 2014. During the same year, LAC's exports constituted 5.7 percent of global exports.

As regards imports, LAC's total imports have also witnessed a steady growth, increasing more than two-fold, from US\$ 513.9 billion in 2005 to US\$ 1111.1 billion in 2014. In 2014, LAC's imports constituted 5.9 percent of global imports, up from 4.8 percent in 2005. LAC generally maintains a trade surplus, barring a few years. The fall in exports relative to imports during 2014 resulted in an increased deficit of US\$ 42.5 billion during the year.

LAC – Major Exporters & Importers

Amongst the countries in LAC, the largest exporters are Mexico, Brazil, Chile, Argentina, and Colombia, together accounting for as much as 78.5 percent of LAC's total exports in 2014 (**Table 2.2**). Other important exporters from LAC include Peru, Venezuela, Ecuador and Guatemala.

As regards imports, the leading importers in LAC are Mexico, Brazil, Chile, Argentina and Colombia, together accounting for 74.8 percent of LAC's total imports in 2014 (**Table 2.3**).

LAC - Major Export Items

Mineral fuels, which mainly comprise petroleum crude are the largest export items from LAC, accounting for as much as 20.2 percent of LAC's total exports in 2014 (**Table 2.4**). Other major items of exports from LAC include transport vehicles (9.9 percent of the total exports); electrical and electronic equipment (8.5 percent); machinery and instruments (7.2 percent); ores, slag and ash (6.4 percent); oil seed, oleagic fruits (3.1 percent); pearls and precious stones, etc (2.7 percent); and copper and articles (2.6 percent).

LAC's Crude Petroleum Exports - Countries in LAC such as Venezuela and Mexico are among the leading global exporters of crude oil. Venezuela ranks 10th among the global exporters of crude petroleum, accounting for 3.7 percent of the global crude petroleum exports in 2014, while Mexico ranks 13th with a share of 2.5 percent in the global exports of crude petroleum in 2014.

LAC - Major Import Items

LAC's import basket is relatively diversified. Mineral fuels and petroleum products (14.4 percent of the total imports); electrical and electronic equipment (14.2 percent); machinery (14 percent); transport vehicles (8.8 percent); and plastics and articles thereof (4.6 percent) are among the largest import items in 2014 (**Table 2.5**).

Impact of Lower International Oil Prices on LAC

Oil prices have been in freefall since mid 2014, declining from its peak of US\$ 108.4/barrel in June 2014, to US\$ 60.7/barrel in December 2014 and further dropping below US\$ 40/ barrel in August 2015. Owing to this fall and challenging external conditions, growth of the commodity driven LAC region moderated to 1.3 percent in 2014 compared to 2.9 percent recorded in the previous year.

LAC's output is forecast to moderate further to 0.9 percent in 2015. Growth in major LAC economies such as Brazil, Argentina and Venezuela (that account for nearly 60 percent of the region's GDP) would primarily affect LAC's overall growth performance. Brazil's economy is projected to contract by 1 percent in 2015 as tightening policies to lay the foundation for sustained economic growth is having a temporary adverse impact on economic activity and consumer price inflation. Further, private sector sentiment remains weak because of unaddressed competitiveness challenges. In Argentina and Venezuela stagflation is deepening. Argentina's GDP is projected to contract by 0.3 per cent in 2015. In Venezuela, economic activity is projected to contract sharply by 7 per cent in 2015, as the oil price decline has compounded an already difficult situation. While Chile, Colombia, Mexico, and Peru are forecast to outperform the rest of the region in 2015, benefiting from better balanced policy frameworks and greater export exposure to the strengthening USA economy.

The LAC economy is expected to recover from 2016 onwards as revival in oil prices will lead to higher export earnings, boost government consumption and thus investment.

While LAC is emerging as a major exporter of crude petroleum, as analysed in the preceding paragraphs, large imports of petroleum products by the major importers in LAC have resulted in mineral fuels and products being the largest import category of LAC. These products include large volumes of petroleum oils (not crude) (HS-2710) imported by Mexico, Brazil, Panama, Chile, Colombia, Argentina, and Venezuela; petroleum gases (HS-2711) imported by Mexico, Brazil, Argentina, Chile, and Ecuador; and coal, briquettes etc (HS-2701) imported by Brazil, Chile, Mexico, Argentina, and Dominican Republic.

LAC - Major Export Markets

While western developed countries such as USA, Canada, Germany, Spain, UK and Netherlands continue to be major markets for LAC's exports, developing countries such as China and India have emerged as major export destinations in recent years. Major destinations for LAC's exports in 2014 include USA (42.5 percent of LAC's exports), China (9.1 percent), India (2.7 percent), Netherlands (2.4 percent), and Canada (2.1 percent). While India, which did not feature among the top 20 markets for LAC in 2005, has now emerged as the 3rd largest market for LAC in 2014 accounting for 2.7 percent of LAC's total exports.

LAC - Major Import Markets

As in the case with LAC's export markets, developed countries such as USA, Japan, and Germany have continued to be the major sources for LAC's global imports. However, over the years, there has been a paradigm shift to emerging and developing countries for its imports as well. USA continues to be the key source of imports for the LAC, accounting for 31.9 percent of LAC's global imports. Other suppliers to the LAC region include China (16.2 percent), Japan (3.9 percent), Germany (3.1 percent), and South Korea (2.5 percent).

Trade Blocs in the LAC Region

Some of the major trading blocs in the LAC region are Andean Community (CAN), Central American Common Market (CACM), Caribbean Community (CARICOM), Latin American Integration Association (LAIA), South American Common Market (MERCOSUR), Free Trade Area of the Americas (FTAA), North American Free Trade Agreement (NAFTA), and Union of South American Nations (UNASUR). Of these, FTAA and NAFTA are inter-regional i.e. with North America, while the others are within the LAC region.

The Union of South American Nations (UNASUR) is the most recent inter-governmental union among all the South American Nations, except French Guiana. The UNASUR Constitutive Treaty, that was signed on May 23, 2008, entered into force on March 11, 2011.

3. INDIA'S TRADE RELATIONS WITH LAC

With the increasing diversification of India's global trade towards other developing countries, the LAC region has emerged as an important partner for India, both as export destination as also import source. This is reflected in the


synergy in bilateral trade relations wherein India's total trade with LAC has risen more than nine-fold, from US\$ 5.2 billion in 2005 to touch US\$ 49.1 billion in 2014 (Table 3.1 and Chart 3.1).

Underlying the robust trend in total trade has been the significant rise in both India's exports to as also India's imports from LAC, with the latter having risen faster than the former. While India's total exports to LAC have risen from US\$ 2.8 billion in 2005 to US\$ 15.5 billion in 2014, depicting more than a five-fold rise during the period, India's total imports from LAC have also risen significantly from US\$ 2.4 billion to US\$ 33.6 billion during the same period. As a result, India's trade balance with LAC, which stood at a surplus of US\$ 0.5 billion in 2005, has turned into a deficit in recent years, amounting to a trade deficit of US\$ 18.1 billion in 2014.

India has entered into Preferential Trading Agreement (PTA) with MERCOSUR and Chile, and is currently in the process of expanding its agreement with Chile. A Joint Commission between India and CARICOM has been established to determine the exact scope and nature of the projects being contemplated in the co-operation between the two sides. India has also established linkages with the Andean Community (CAN), and Community of Latin American and Caribbean States (CELAC).

India's Major Export Items to LAC

India's major export items to LAC include mineral products (28.7 percent of the total exports); vehicles (15.9 percent); organic chemicals (5.3 percent); pharmaceutical products (4.4 percent), and machinery (3.7 percent), with a combined share of 58 percent of India's total exports to LAC in 2014 (Table 3.2). Other important items of India's exports to LAC include iron and steel; aluminum and articles; miscellaneous chemical products; cotton; and manmade filaments, among others.

Exports of Petroleum Oils (not crude) [HS-2710]-LAC is increasingly emerging as an important destination for India's exports of petroleum oils (not crude) [HS-2710]. During the period 2005-2014, while India's global exports of petroleum oils rose over six-fold, from US\$10.1 billion to US\$60.8 billion, India's exports to LAC also rose over five-fold, from US\$758.1 million to US\$4.4 billion, with the major markets being Brazil, Ecuador, Bahamas, Argentina and Peru. LAC currently accounts for around 7.3 percent of India's global exports of petroleum oils (Table 3.3).

Exports of Vehicles – LAC is a major destination for India's exports of vehicles, accounting for a respectable 17 percent of India's exports of

vehicles in 2014. Mexico is a leading destination in the LAC region for India's exports followed by Colombia, Brazil, and Chile (**Table 3.4**).

Exports of Organic Chemicals – LAC is an important market for India's exports of organic chemicals. This can be assessed from the fact that India's exports to LAC have risen from US\$ 281 million in 2005 to touch US\$ 817.7 million in 2014, accounting for 6.8

percent of India's global exports. The largest destinations are Brazil, Mexico and Argentina (**Table 3.5**). In recent years, other countries such as Colombia, Peru, Chile, and Uruguay are also emerging as major destinations for India's exports to LAC.

Exports of Pharmaceutical Products – It is the fourth-largest item in India's export basket to LAC, accounting for 5.8 percent of India's total exports to LAC in 2014. Exports of these products to LAC have risen from US\$ 199.7 million in 2005 to reach

US\$ 686.8 million in 2014. Brazil, Venezuela, Chile, and Peru are the major destinations, accounting for the bulk (61.1 percent) of India's exports to LAC (**Table 3.6**).

Exports of Machinery – India's exports of machinery to LAC have risen significantly from US\$ 99.3 million in 2005 to touch US\$ 574.6 million in 2014, with a share of 5.8 percent of India's global exports of machinery (**Table 3.7**). While the

largest destinations are Brazil and Mexico, other countries such as Colombia, Honduras, Argentina, and Guatemala are also increasingly become important markets for machinery from India.

India's Major Export Destinations in LAC

Brazil is India's largest export destination in LAC, accounting for around 46 percent of India's total exports to LAC in 2014, up from 34.3 percent in

2005 **(Table 3.8)**. Other major export markets in LAC include Mexico (18.8 percent of the total exports), Colombia (7.3 percent), Peru (4.9 percent), and Chile (4 percent).

Brazil has been the leading destination in LAC for India's exports of petroleum oils, organic chemicals and machinery, and is also one of the major destinations for vehicles, plastics and articles, electrical and electronic equipment, cotton, and pharmaceutical products. All these items are among the major export items to LAC.

In the case of Mexico, the country is an important market for India's exports of vehicles, organic chemicals, aluminium, machinery, articles of apparel (not knit or crochet), and articles of iron and steel.

An analysis of the trend in India's exports to major destinations in LAC during the period 2005 to 2014 would reveal that, while the shares of major destinations such as Argentina, Chile, Colombia and Venezuela in India's total exports to LAC have declined, other countries such as Bahamas, Ecuador and Uruguay are increasingly emerging as important destinations, with rising share in India's exports to LAC.

India's Major Import Items from LAC

Table 3.9 presents the major items in India's import basket from LAC, as per 2-digit HS commodity codes. Reflecting the increased importance of the LAC region as source for India's crude oil imports, mineral fuels (HS-27) are the largest items in India's import basket from LAC, accounting for as much as 72 percent of India's total imports from LAC in 2014.

Other important items of imports from LAC include ores, slag and ash; animal, vegetable fats and oils; pearls and precious stones; sugar and sugar confectionery; and iron and steel.

Imports of Crude Petroleum (HS-2709) – India's imports of crude petroleum from LAC have risen from US\$ 18.8 million in 2005 to touch US\$ 24 billion in 2014, and accounted for as much as 13 percent of India's global imports. Venezuela is India's largest source of crude petroleum from the LAC region, accounting for as much as 54.6 percent of India's imports from LAC, followed by Colombia, Brazil and Mexico together accounting for 38.1 percent (**Table 3.10**).

Globally, Venezuela is the fourth-largest source of crude petroleum for India, with a share of 9.6 percent of India's global imports, after Saudi Arabia, Iraq, and Nigeria. Other LAC countries such as Colombia, Brazil and Mexico are also among the leading sources for India's import of crude petroleum.

Imports of Ores, Slag and Ash — Under this category, LAC accounts for around 47 percent of India's global imports. Chile is the largest source in LAC, accounting for as much as 77.4 percent of India's global imports of ores, slag and ash. Other suppliers under this category include Brazil, Peru and Argentina. Bulk of the items being imported by India from LAC under this category is copper ores and concentrates (HS-2603), lead ores and concentrates (HS-2607), and molybdenum ores and concentrates (HS-2613).

Imports of Animal, vegetable fats and oils – Under this category, LAC accounts for 18.8 percent of India's global imports. The main suppliers from LAC are Argentina, Brazil and Paraguay. The significance of Argentina is proven from the fact that Argentina alone accounts for 14.7 percent of India's global imports of animal, vegetable fats and oils.

India's Major Import Sources in LAC

Table 3.11 lists the major import partners for India in the LAC region. Venezuela is the largest import source, followed by Brazil, Colombia, Mexico, and Chile. In the case of Venezuela, Brazil and Mexico, these countries are important sources for India's global imports of crude petroleum. Venezuela is also a major source of iron and steel, inorganic chemicals, lead and articles and aluminium and

articles. Brazil is an important source of ores, slag and ash, iron and steel, animal, vegetable fats and oils, and machinery. Mexico is a leading source of electrical and electronic equipment, machinery, iron and steel, pearls and precious stones and plastics and articles. In the case of Chile, the country is a major supplier of copper ores and concentrates to India. Colombia is a major source of India's imports of crude oil, iron and steel and wood and articles of wood.

India's Trade Balance with LAC

Underlying the robust trend in bilateral trade between India and LAC, which has risen more than nine-fold, from US\$ 5.2 billion in 2005 to touch US\$ 49.1 billion in 2014, has been the rising trend in India's trade deficit with LAC. India's trade balance with LAC, which stood at a surplus of US\$ 457.9 million in 2005, flipped to a deficit of US\$ 1.2 billion in 2006. India's trade balance with the LAC region has been in deficit since then, and reached a high of US\$ 18.1 billion in 2014 (**Table 3.12**).

Amongst the major trade partners with which India maintains a trade deficit, the largest countries are Venezuela, Chile, Colombia and Argentina. In the case of Venezuela and Colombia, large and rising volume of crude imports have underlined India's rising trade deficit. In the case of Chile, large imports of ores and concentrates have resulted in a huge trade deficit. India's rising imports of vegetable fats and oil from Argentina has resulted in widening of trade deficit with Argentina.

4. ENHANCING BILATERAL TRADE RELATIONS WITH SELECT COUNTRIES IN LAC

As highlighted in the previous chapters, India's bilateral trade with the LAC region has increased more than nine-fold, from US\$ 5.2 billion in 2005 to touch US\$ 49.1 billion in 2014, supported by rising exports as well as imports. During the same period, India's exports to LAC have risen more than five-fold, while India's imports from LAC has increased more than fourteen-fold. As a result, India has a trade deficit with the LAC region, which was seen at US\$ 18.1 billion in 2014.

To further enhance India's trade with the LAC region, and at the same time to address the rising trade deficit, an important strategy would be to focus on India's export potential to the major importing countries in LAC. An analysis of **Table 4.1** would reveal the low share of India in LAC's imports as a whole, as well as major importing countries of the region.

Identification of potential items of India's exports to the focus markets viz. Mexico; Brazil; Chile; Argentina; Colombia; Peru; Venezuela; Ecuador; Guatemala; Dominican Republic; Costa Rica, Panama; Paraguay; Uruguay and El Salvador would be based on the following criterion:

- Identification of major items of imports of select focus markets, and share of India in each product line of imports, based on 2-digit HS commodity code
- Selection of potential items of India's exports
 to each of the focus markets, based on low
 share of India in target country's import basket
 of major commodities, keeping in view India's
 global export capability. This would entail
 identification of potential export items to each
 focus market, under each 2-digit HS code,
 upto 6-digit HS commodity code

Mexico- Potential Items of India's Exports

Mexico is the largest importer in LAC with a share of 36 percent of total LAC imports. USA (49 percent), China (16.6 percent), Japan (4.4 percent), South Korea and Germany (3.4 percent each), and Canada (2.5 percent) are the key sources of imports of Mexico in 2014. India is yet to become a sizeable share in the country's import basket.

As can be seen from **Table 4.2**, India's share in Mexico's global imports is low at 0.7 percent. India has achieved respectable share in only two categories, viz. aluminium and articles and copper and articles, out of the major import categories of Mexico. This would serve to highlight the potential to enhance these exports to Mexico, in light of the demand in the country, as also India's global export capability.

Based on the table above and India's export capability, potential items of India's exports to Mexico would include:

- Electrical and electronic equipment (HS-85)
- Machinery and instruments (HS-84)
- Vehicles other than railway, tramway (HS-87)
- Mineral fuels, oils, distillation products, etc (HS-27)
- Plastics and articles (HS-39)
- Organic chemicals (HS-29)
- Iron and steel (HS-72)
- Articles of iron or steel (HS-73)
- Pharmaceutical products (HS-30)
- Meat and edible meat offal (HS-02)
- Cereals (HS-10)

Based on the above analysis, potential items of export to Mexico, under select identified categories, upto 6-digit HS code classification have been presented in **Annexure 1**.

Brazil- Potential Items of India's Exports

As can be seen from **Table 4.3**, India's share in Brazil's global imports stood at 3.1 percent. India

had respectable share in only two commodities viz. mineral fuels, oils and distillation products and miscellaneous chemical products among Brazil's major import categories.

Potential exports from India to Brazil identified at 2-digit HS code classification are:

- Machinery and instruments (HS-84)
- Electrical and electronic equipment (HS-85)
- Vehicles other than railway, tramway (HS-87)
- Organic chemicals (HS-29)
- Pharmaceutical products (HS-30)
- Articles of iron or steel (HS-73)
- Iron and steel (HS-72)
- Cereals (HS-10)

Based on the above analysis, potential items of exports to Brazil, under select identified categories, upto 6-digit HS code classification have been presented in **Annexure 2**.

Chile- Potential Items of India's Exports

Chile is the third largest importer in the LAC region, with a share of 6.5 percent of total LAC imports. The main sources of imports for Chile in 2014 were China (20.9 percent of Chile's global imports); USA (19.8 percent); Brazil (7.8 percent); Argentina (4 percent); and Germany (3.6 percent).

India's share in Chile's global imports was low at 0.9 percent (**Table 4.4**). In 2014, India's imports from Chile outpaced its exports to Chile resulting in a trade deficit with Chile.

In an attempt to bridge India's trade deficit with Chile, potential items of exports from India to Chile based on Chile's import demand and India's comparative advantage, have been identified using 2-digit HS code classification which are presented as follows:

- Mineral fuels, oils, distillation products, etc (HS-27)
- Machinery and instruments (HS-84)
- Vehicles other than railway, tramway (HS-87)
- Electrical and electronic equipment (HS-85)
- Plastics and articles (HS-39)
- Articles of apparel, accessories, not knit or crochet (HS-62)
- Iron and steel (HS-72)
- Pharmaceutical products (HS-30)
- Meat and edible meat offal (HS-02)

Based on the above analysis, potential items of exports to Chile, under select identified categories, upto 6-digit HS code classification have been presented in **Annexure 3**.

Argentina- Potential Items of India's Exports

In 2014, Brazil was the main source of imports for Argentina (21.8 percent of Argentina's global imports); followed by China (16.4 percent); USA (13.5 percent); Germany (5.4 percent); and Bolivia (4.2 percent). During the same year India's share was seen at 0.8 percent (**Table 4.5**).

In 2014, India had a trade deficit of US\$ 1.5 billion, which has risen more than three-fold from US\$ 389.1 million in 2005. Strategy to reduce the trade deficit would entail identification of potential items of exports to Argentina, in line with India's capability and Argentina's import demand. Based on this criterion, potential items identified at 2-digit HS code classification are as follows:

- Vehicles other than railway, tramway (HS-87)
- Organic chemicals (HS-29)
- Machinery and instruments (HS-84)
- Electrical and electronic equipment (HS-85)
- Pharmaceutical products (HS-30)
- Plastics and articles (HS-39)
- Articles of iron or steel (HS-73)
- Cotton (HS-52)

Based on the above analysis, potential items of exports to Argentina, under select identified categories, upto 6-digit HS code classification have been presented in **Annexure 4**.

Colombia- Potential Items of India's Exports

The main sources of imports for Colombia in 2014 were USA (28.5 percent of global exports); China (18.4 percent); Mexico (8.2 percent); Germany (4 percent); Brazil (3.9 percent). India's share in Colombia's imports stands at 1.8 percent (**Table 4.6**).

Peru - Potential Items of India's Exports

In 2014, China was the primary source of imports for Peru, accounting for 21.2 percent of Peru's global imports, followed by USA (20.9 percent); Brazil (4.7 percent); Mexico (4.6 percent); and Ecuador (4.2 percent).

Table 4.7 depicts India's share in Peru's global imports, which was seen at 1.8 percent in 2014. Potential exports from India to Peru, identified at 2-digit HS code classification are presented as follows:

- Machinery and instruments (HS-84)
- Mineral fuels, oils, distillation products, etc (HS-27)
- Electrical and electronic equipment (HS-85)
- Vehicles other than railway, tramway (HS-87)
- Cereals (HS-10)
- Articles of iron or steel (HS-73)
- Organic chemicals (HS-29)

Venezuela- Potential Items of India's Exports

USA (28.7 percent of Venezuela's global imports); China (14.6 percent); Brazil (11.9 percent); Colombia and Argentina (5.1 percent each); and Mexico (4 percent) were the primary import sources of Venezuela in 2014.

India's share in Venezuela's global imports was 0.6 percent in 2014 (**Table 4.8**). India had a respectable share in Venezuela's imports only in the case of pharmaceuticals. At the same time, India has a trade deficit with Venezuela owing to imports of crude oil. In order to bridge India's deficit with Venezuela, strategy would involve increased exports from India, based on Venezuela's import demand, as well as India's global capability. Such products identified at 2-digit HS code classification would include:

- Machinery and instruments (HS-84)
- Electrical and electronic equipment (HS-85)
- Vehicles other than railway, tramway (HS-87)
- Organic chemicals (HS-29)
- Miscellaneous chemical products (HS-38)

Based on the above analysis, potential items of exports to Venezuela, under select identified categories, upto 6-digit HS code classification have been presented in **Annexure 7**.

Guatemala- Potential Items of India's Exports

In 2014, Guatemala accounted for 1.6 percent of total imports of the LAC region. During the same year, the main sources of imports for Guatemala included USA (40.3 percent of global imports of Guatemala), Mexico (10.7 percent), China (9.8

percent), El Salvador (4.5 percent), and Panama (3.7 percent).

India's share in Guatemala's global imports amounted to US\$ 221.7 million, accounting for 1.2 percent of Guatemala's global imports (**Table 4.9**). India had a respectable share in only two commodities of Guatemala's global imports viz. vehicles other than railway, tramway and cotton. Potential exports from India to Guatemala identified at 2-digit HS code classification would include:

- Machinery and instruments (HS-84)
- Electrical and electronic equipment (HS-85)
- Pharmaceutical products (HS-30)
- Iron and steel (HS-72)
- Organic chemicals (HS-29)
- Articles of iron or steel (HS-73)

Annexure 8 presents an analysis of the potential items upto 6-digit HS code classifiction.

Ecuador- Potential Items of India's Exports

In 2014, Ecuador's main import sources were USA (28 percent of Ecuador's global imports), China (16.7 percent), Colombia (7.5 percent), Mexico (4.1 percent), and Panama (3.5 percent). India had a low share of 1.1 percent (**Table 4.10**).

India maintains a trade deficit with Ecuador. Therefore, in order to bridge the deficit by way of increasing India's exports to Ecuador, potential items of exports at 2-digit HS code classification have been identified as:

- Mineral fuels, oils, distillation products, etc (HS-27)
- Machinery and instruments (HS-84)
- Electrical and electronic equipment (HS-85)
- Vehicles other than railway, tramway (HS-87)
- Plastics and articles (HS-39)
- Pharmaceutical products (HS-30)

Dominican Republic- Potential Items of India's Exports

In 2014, USA, China, Mexico, Venezuela, and Trinidad and Tobago were the main import sources

for Dominican Republic, together accounting for 68.4 percent of Dominican Republic's global imports.

As can be observed from **Table 4.11**, India's share in Dominican Republic's global imports was low at 0.8 percent. Potential exports from India to Dominican Republic, identified at 2-digit HS code classification are:

- Electrical and electronic equipment (HS-85)
- Plastics and articles (HS-39)
- Machinery and instruments (HS-84)
- Vehicles other than railway, tramway (HS-87)
- Cotton (HS-52)
- Articles of iron or steel (HS-73)

Costa Rica- Potential Items of India's Exports

In 2014, USA, China, Mexico, Japan and Guatemala together accounted for 66.3 percent of Costa Rica's global imports. However, India's share has been observed to be low at 0.5 percent (**Table 4.12**).

During 2014, India's share in Panama's global imports was seen at 2 percent (**Table 4.13**). To enhance bilateral trade further, one strategy could be to increase India's exports to Panama. Potential exports to Panama, based on the import demand as well as India's comparative advantage at 2-digit HS Code have been identified as follows:

- Machinery and instruments (HS-84)
- Vehicles other than railway, tramway (HS-87)

- Electrical and electronic equipment (HS-85)
- Articles of iron or steel (HS-73)
- Iron and steel (HS-72)
- Pharmaceutical products (HS-30)
- Cereals (HS-10)

Paraguay- Potential Items of India's Exports

In 2014, Brazil, China, Argentina, USA, and Germany together constituted 77.9 percent of Paraguay's global imports.

India had a respectable share only in Paraguay's global imports of tobacco and manufactured tobacco substitutes. India's share in Paraguay's global imports of other commodities is low. 5. INDIA'S INITIATIVES TO ENHANCE BILATERAL TRADE RELATIONS WITH LAC

With a view to facilitate and further enhance bilateral trade and commercial relations with countries in the LAC region, India has put in place important policy measures as also institutional frameworks to create an enabling trade and business environment. Major policy initiatives and institutional frameworks include, among others, Focus LAC Programme, IBSA Initiative, India-LAC Partnership Conclaves, PTA with MERCOSUR and Chile, etc. India has recently also been granted 'Observer' status in the emerging grouping, the New Pacific Alliance. Briefs of such major initiatives are highlighted below:

"Focus LAC" Programme

Considering the potential of the market in the Latin American region, an integrated programme, viz. "Focus LAC" was launched in November 1997 by the Ministry of Commerce and Industry, Government of India (GOI), which aims to encourage the Indian private sector, as well as state entities, to develop stronger trade and investment linkages with Latin America and the Caribbean, and at the same time focus on enhancing India's exports of textiles, engineering products, computer software, chemicals and pharmaceuticals to the region. The Programme has been reviewed from time to time and extended up to March 2019. This programme aims at:

 Sensitizing the organizations viz. Export Promotion Councils, Chambers of Commerce and Industry, Exim Bank, ECGC etc. involved in trade promotion efforts

- Granting various incentives to Indian exporters and launching of export promotion measures
- Focussing on the Latin American region, with added emphasis on major trading partners of the region
- Focussing on the following major product groups for enhancing India's exports to the Latin American region:
 - Textiles including ready-made garments, carpets and handicrafts
 - Engineering products and computer software
 - Chemical products including drugs/ pharmaceuticals

Components of "Focus LAC" Programme - The Focus LAC programme can be broadly categorized as under:

- Institutional mechanism
- Improved market access
- Economic infrastructure facilities

Joint Commissions/Committees

The following Joint Commissions/Committees exist with countries of the Latin American region:

- Indo-Argentine Joint Commission
- Indo-Argentine Joint Trade Committee
- Indo-Mexican Joint Commission
- Indo-Brazilian Commercial Council
- Indo-Cuban Joint Commission
- Indo-Cuban Trade Revival Committee
- Indo-Suriname Joint Commission
- Indo-Guyana Joint Commission
- Indo-Venezuela Joint Commission
- Indo- Trinidad Joint Commission
- India- Brazil Trade Monitoring Mechanism

In order to have increased frequency of interaction with important trading partners in the LAC region, the meetings of the Joint Commissions are held on a regular basis. Further, efforts have been made to set up consultative machineries with the other major countries in the region with a view to enhancing two-way trade.

IBSA Initiative

The first meeting of the India – Brazil – South Africa (IBSA) Trilateral Commission of the foreign ministers of India, Brazil and South Africa took place in March 2004 in New Delhi. The trilateral commission was an outcome of the IBSA Dialogue Forum, which was formed amongst the three countries during the visit of the Indian Foreign Minister to Brazil during June 2003.

IBSA co-operates on three fronts, as a forum seeking reforms in global institutions of political and economic governance; trilateral collaboration through Working Groups and People-to-People Forums for the common benefit of the three countries; and assisting other developing countries by taking up projects through the IBSA Fund.

An important outcome of the Trilateral Commission meeting was the decision to hold regular meetings of the foreign ministers of the three countries. Another important outcome was the formation of a Trilateral Joint Commission, which, is co-chaired by the foreign ministers. The three foreign ministers signed the "New Delhi Agenda for Co-operation and Plan of Action", which aims to boost bilateral trade and promote South-South co-operation. The Plan of Action envisages, among others, co-operation in fields like health, Information Technology (IT), civil aviation, defence, and the three countries have agreed to reinforce the economic strength of each other by synergising their complementarities in areas of industry, services, business and technologies. As per the Plan of Action, a trilateral co-operation agreement on air services would be considered and finalized, particularly in the areas of identification of routes for increased frequency of air links and possibilities for commercial agreements between airline companies.

Three Agreements and 17 Memorandum of Understanding) (MoU) have been signed for pursuing sectoral co-operation among IBSA countries. The 6th IBSA Summit was held in New Delhi during June 2013, which commemorated the 10th anniversary of establishment of IBSA.

Preferential Trade Agreement (PTA) with MERCOSUR

AFramework Agreement was signed between India and MERCOSUR (a trading block of Argentina, Brazil, Paraguay, Venezuela and Uruguay) on June 17, 2003 at Asunción, Paraguay. The aim of this Framework Agreement is to create conditions and mechanisms for negotiations by granting

reciprocal tariff preferences in the first stage and to negotiate a free trade area between the two parties in conformity with the rules of the World Trade Organisation in the second stage.

As a follow up to the Framework Agreement, PTA was signed in New Delhi on January 25, 2004. The aim of this PTA is to expand and strengthen the existing relations between MERCOSUR and India and promote the expansion of trade by granting reciprocal fixed tariff preferences with the ultimate objective of creating a free trade area between the parties. The PTA came into effect on June 01, 2009. Implementation of the India-MERCOSUR Agreement was notified by WTO on February 24, 2010. Efforts are underway to broaden and deepen the PTA and to link it, under IBSA to SACU as well.

Preferential Trade Agreement (PTA) with Chile

A Framework Agreement to promote economic co-operation between India and Chile was signed on January 20, 2005. The Framework Agreement envisaged a Preferential Trade Agreement (PTA) between the two countries as a first step. The Framework Agreement also provides for a Joint Study Group to go into the issues relating to a Free Trade Agreement between the two sides.

The PTA has two Annexes relating to the list of products on which the two sides have agreed to give fixed tariff preferences to each other and three Annexes relating to the Rules of Origin, Preferential Safeguard Measures and Dispute Settlement Procedures. While India has offered to provide fixed tariff preferences ranging from 10 percent to 50 percent on 178 tariff lines at the 8-digit level to Chile, the latter has offered India a similar range of tariff preferences on 296 tariff lines at the 8-digit level. India- Chile PTA came into

force on August 2007 in Chile and on September 2007 in India. Chile is the only country in the LAC region that has a PTA with India.

In January 2010, both countries agreed to deepen the PTA with a view to a much broader agreement. A second meeting to deepen the agreement took place in New Delhi during August 2010. The third meeting was held in Santiago in July 2011. The fourth meeting took place in February 2012, in New Delhi. Negotiations for the deepening of the PTA concluded in October 2014, in New Delhi.

Measures by ITPO

A cell in the India Trade Promotion Organisation (ITPO) has been created to act as a Centre for Trade Development with the Latin American region. The role of the cell in the ITPO is to-

- Deal exclusively with export promotion and development matters pertaining to the LAC region;
- Organize fairs/exhibitions as a tool of market development,
- Organize Buyer-Seller Meets (BSMs).

India-LAC Partnership Conclaves

FICCI/ASSOCHAM have increased interaction with their counterparts in the LAC region, and hold meetings of the Joint Business Councils (JBCs) at regular intervals. CII also has regular interaction with their counterparts in the LAC region with whom they have signed MoUs. Simultaneously, seminars and conferences are being organized within India to create awareness about business opportunities in the LAC region.

Foreign Trade Policy 2015-2020

Latin America has been identified as one of the Emerging and Focus Market regions in the Foreign Trade Policy (FTP) 2015-2020. Under the FTP, plans for greater engagement with the region envisage:

- Efforts to diversify India's exports to the region in the future
- Expansion of India-MERCOSUR PTA
- Strengthening trade and investment linkages with the Pacific Alliance
- Conclusion of the expansion of the India-Chile PTA
- Initiation of a Joint Study on a proposed India-Peru FTA

- Exploring the potential for large-scale farming by Indian companies/individuals with a view to augmenting India's food security programme as well as playing a greater role in global agriculture trade
- Encouraging project exports in the LAC region through easy access to credit facilities
- Intensifying trade promotion programme to encourage and support Indian exporters to export to Latin American countries
- Extending help in setting up warehousing facilities in Latin America to make Indian exports more competitive by overcoming distance and time constraints
- Continuing to explore possibilities for new regional trading arrangements in Central America and Caribbean Region
