Query 07:

Under the Scope of Work Sr. No. 1, request to remove the clause to share the Product source code to Exim Bank.

Exim Bank Reply:

Agreed. Vendor has to submit the declaration of support for quality assurance and continuous support on company letterhead.

Query 08:

Commercial Proposal mentions the required number of user license to be 50 units. Some Bidders want to quote for Enterprise license.

Exim Bank Reply:

Agreed. Bank is looking for enterprises unlimited user licenses. At the same time Bank will provide option to quote for 50 user license as well as enterprise license for cost analysis based on which the Bank may opt for user based license or enterprise based license.
