### Minutes of Pre-PQ Meeting

Project: Agricultural Component of the Agro-industrial Pole Project in the North (2PAI-NORD), in the Republic of Cote D'ivoire.

Exim Bank has invited applications for Prequalification for preparation of DPR vide reference. no. GOILOC-284 (P13)/ EBID (Cote d'Ivoire)/CS-67 dated September 04, 2025, for "Agricultural Component of the Agro-industrial Pole Project in the North (2PAI-NORD), in the Republic of Cote D'ivoire". In accordance with the conditions outlined in the PQ document, Exim Bank conducted a Pre-PQ meeting for the project on September 17, 2025, at 15:00 hours.

#### **Project Brief:**

The project aims to develop an agro-industrial zone in the northern region (2PAI-NORD) of Cote d'Ivoire, with the primary objectives of enhancing agricultural productivity and improving rural infrastructure. As part of GO-CIV's broader strategy to modernize its agricultural sector, promote industrialization, and achieve sustainable economic development, the 2PAI-NORD project is being implemented with financial and technical support from the African Development Bank (AfDB). The project seeks to increase the productivity of agro-pastoral commodity chains by upgrading hydro-agricultural facilities, improving access to agricultural inputs and services, and strengthening community resilience. It also aims to facilitate market access for agro-pastoral farmers through the development of rural infrastructure, structuring of commodity chains, and targeted capacity-building initiatives.

The major components of the project are as under:

- a) Rehabilitation of Rural Roads
- b) Rehabilitation and Construction of Hydro-Agricultural Dams to support irrigation and water resource management.
- c) Rehabilitation and Extension of Irrigated Areas approx 5,000 hectares.
