Minutes of Pre-PQ Meeting

Project: Construction of Drinking Water and Sanitation Infrastructure in Upper Guinea and Forest Guinea in the Republic of Guinea Date: December 17, 2025

Exim Bank has invited applications for Prequalification of Consultants for preparation of Detailed Project Report (DPR) and / or for Project Management Consultant (PMC) vide reference. no. GOILOC-284/EBID(Guinea)/CS-68 dated November 21, 2025, for "Construction of Drinking Water and Sanitation Infrastructure in Upper Guinea and Forest Guinea, in the Republic of Guinea". In accordance with the conditions outlined in the PQ document, Exim Bank conducted a Pre-PQ meeting for the project on December 17, 2025, at 15:00 hours.

Project Brief:

The project aims for construction of Drinking Water and Sanitation Infrastructure in Upper Guinea and Forest Guinea regions of the Republic of Guinea (the "**Project**), The total cost of the project is USD 36.91 mn. The project comprises the following key components:

- Construction of Boreholes: Development of 150 boreholes equipped with manual pumps, in alignment with Guinea's policy on the maintenance and standardization of manual pump systems.
- Installation of Drinking Water Supply Systems: Implementation of 100 solar-powered or hybrid (solar-diesel) drinking water supply systems. Each system will serve predefined connection points and include 10 standpipes, each fitted with two taps, to ensure widespread community access.
- Sanitation Infrastructure: Construction of 250 public lavatories in beneficiary communities, adopting the Community-Led Total Sanitation (CLTS) approach to promote improved hygiene and sanitation practices.
