

Pre-Bid Meeting

**Project: Qualification of EPC Contractor for Construction / Rehabilitation of potable water supply facilities in four communities in Sierra Leone**

**Date: January 19, 2026**

Exim Bank has invited applications for Qualification of the EPC Contractors vide reference. no. GOILOC-210(P1)/Sierra Leone/EPC-104, dated January 09, 2026, for **“Construction / Rehabilitation of Potable Water Supply Facilities in Four Communities in Sierra Leone”**. In accordance with the conditions outlined in the RFQ document, Exim Bank conducted a Pre-Bid meeting for the project on January 19, 2026, at 15:00 hours.

**Project Brief:**

The project aims to provide improved access to adequate, safe, and reliable water supply services for following 4 Towns in Sierra Leone and their environs, and to enhance the institutional, operational and management capabilities of the SALWACO (the Project Authority) through the Construction / Rehabilitation of Potable Water Supply Facilities:

1. Mattru Jong (along with neighboring towns namely Luawa, Semabu, Bauya and Tihun) [Southern Province]
2. Njala Mokonde [Southern Province]
3. Daru [Eastern Province]
4. Mongo [Northern Province]

Geographical Location of the 4 Towns is as represented below:



The water supply scheme across all the 4 Towns, primarily consists of construction of water supply system involving intake from water source, transmission mains, Ground Service Reservoirs, Water Treatment [for 2 identified Town], Elevated Service Reservoir distribution network and staff quarters. Each water supply scheme is designed to run on both DG sets / Solar PV system basis availability of weather.

The Sierra Leone Water Company (SALWACO) under the Ministry of Water Resources, is the agency on behalf of the Government of Sierra Leone undertaking the execution of this project.

**Queries from prospective Applicants:**

The queries received by Exim Bank along with the response to the queries is at Annexure-I. It is clarified that these minutes of the meeting should not be construed as any amendment to the RFQ Document. Any changes in the RFQ shall be made solely by way of issuance of Addendum by Exim Bank on its website.
