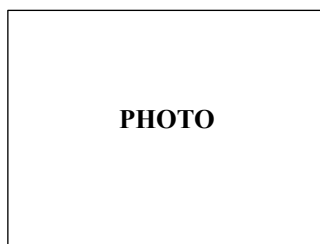

Candidates will be shortlisted for interviews in the ratio of 1:10. A list will be drawn from among the candidates who meet all the prescribed eligibility criteria. In the event more than 10 candidates are found eligible, a shortlist will be drawn based on the percentage score at postgraduation examination. The Bank may, at its discretion, relax the eligibility criteria relating to experience, age, and essential qualifications in the event of a limited response to the advertisement or an insufficient number of candidates being found eligible.
