ORDER

- I. The Appellant had filed an online RTI application dated June 17, 2022 (hereinafter called "the Application") under the Right to Information Act, 2005 ("RTI ACT"). The respondent vide letter dated July 12, 2022 replied to the Appellant (hereinafter called "the CPIO Response"). The Appellant has filed an online Appeal dated July 18, 2022 against the said CPIO Response.
- II. A brief summary of the facts is as under:

- III. I shall now, move on to decide the online Appeal and rule thereon, based on the facts. The online RTI Application, CPIOs response have accordingly called for clarification, papers, documents from CPIO, which have been placed before me.
- IV. Having considered the material placed before me, I find that the CPIO has rightly responded to your queries at question Nos. 1, 3 and 4 of your online RTI application. Further, information to your question No. 2, could not have been provide then since the final selection of the candidates was still under process. I therefore uphold the CPIO's responses.
- V. Now, since the process of final selection of the candidates has been completed, I am instructing the CPIO to provide you the final cut-off marks (written examination + interview) of selected candidates, category wise, as requested by you.
- VI. The Appeal is accordingly disposed off for the reasons stated above.
