#### **ORDER**

- 1. The Appellant had filed an online RTI application dated August 3, 2022 (hereinafter called "the Application") under the Right to Information Act, 2005 ("RTI ACT"). The respondent vide letter dated September 1, 2022 replied to the Appellant (hereinafter called "the CPIO Response"). The Appellant has filed an online Appeal dated September 2, 2022 against the said CPIO Response.
- II. A brief summary of the facts is as under:

I am of the opinion that your ground for appeal 'Refused access to Information Requested' is baseless and I therefore uphold the CPIO's responses.
- V. The Appeal is accordingly disposed off for the reasons stated above.
